MEDAL FOR JERSEY

Charles Bamford, Jersey breeder of the Hillside community, has just received a Gold and Silver Medal won by Nancy's St. Mawes Pride, on a record of 9975 pounds milk, 703.35 lbs. butter fat, average test 7.05 per cent for year.

The following is a letter to Mr. Bamford from O. H. Baker, Chief of the Register of Merit Department of the American Jersey Cattle Club:

"There are in this country, it is estimated, over two hundred thousand living registered Jersey cows. The cream of these cows are owned by men conducting official testing. Out of every four hundred records we record for the Register of Merit, but one cow meets the requirements for a medal. This should give you an idea as to how exceptional an animal you are fortunate in having."

It is indeed upon these medal cows in particular that the future position of the Jersey cow will be based.

The Jersey breed as a whole is indebted to you for bringing to light the production qualities of this animal and it is a pleasure, indeed, to add her name for all times to our roll of honor."
