County Protected in Tire Purchase

Rumor About Misdealing Corrected by Statement to the Press by Commissioners

In order to correct a rumor which is going around that the board of county commissioners purchased tires to the amount of \$5000 and at a cost of 10 to 15 per cent more than they could be purchased for now a statement has been made to the press.

Solid tires were purchased from the Peterson Bros. to the amount of \$1103.80 and from the Cady Motor Co. to the extent of \$1107.65, making a total of \$2211.45, according to the commissioners. This is a years supply. Furthermore they bring out the fact that although these tires were purchased in January the county is protected in as much as they get the benefit of any drop before May 10 and if there is an increase the price remains the same. The tires purchased are solid tires and the price includes pressing on.

TAX COLLECTIONS UNUSUALLY SLOW

Amount of Taxes Collected So Far Is Less

EXPECT LAST MINUTE RUSH

Taxpayers Urged to Get Statements Now Even If They Do Not Pay Until Later

Total tax collections by the sheriff at time of going to press amounted to \$25,750. This is \$15,500 less than for this time last year and all indications point toward a heavy rush of business at the tax department of the sheriff's office at the end of the month.

Unless more people get their statements of taxes shortly and at a greater rate than has been expected since the books opened in February, the late ones will be compelled to stand several hours waiting their turn according to those in charge. If statements are secured now, either by written request or by going directly to the sheriff's office, the business may be disposed of in a short time.

The demand for tax statements has been unusually light and the prospects are that the clerks at the sheriff's office will be swamped with work the first of April. The sheriff suggests that people get their statements now, even if they do not intend to pay until later in the year. Such procedure will speed up the tax collection, minimize errors that are bound to occur when the clerks are rushed and save the taxpayer precious time.

Victim Was Son of Mr. and Mrs. Michael Welter

WAS FAVORABLY KNOWN

Youth Dies Before Doctors Arrive; Services Held Tuesday

Mathew Welter, 27, of Kinton, son of Mr. and Mrs. Michael Welter of Beaverton, was killed in an accidental dynamite explosion on the Daniels' place south of Kinton school on the Scholls road, late Thursday afternoon. Doctors were called but nothing could be done.

The victim, who was doing some blasting, is thought to have gone back to investigate a charge when the explosion occurred. The accident victim is well and favorably known.

He is survived by the widow, Mrs. Ruby Welter, his parents, Mr. and Mrs. Michael Welter of Beaverton, and the following sisters and brothers: Mrs. Mary Overrober of Beaverton, Anna Holbraak of Heppner, Mrs. Catherine Penzer of Portland, and John and Mike at home.

Requiem mass was celebrated at the St. Cecilia Catholic church at Beaverton at 9:30 Tuesday. Interment was in the Mountside cemetery at Scholls.

Petitions for Paving West Oak Presented

TO PUT LANDS ON MARKET

Foreclosure Proceedings Will Soon Start on Delinquent Accounts

Drainage occupied much of the attention of the city council at the regular monthly session Tuesday night. A petition was presented asking for any kind of drainage that would afford some relief, while a remonstrance was presented against a title drain extending down Eighth street by abutting property owners. No definite action was taken and it will come up again next Tuesday night.

Curb Asked For

Petitions for paving Oak street from First to Moran street and then north to Baseline were presented. The petitions call for a 22 foot paving with curbs.

A committee of three councilmen and three real estate dealers will be appointed by Mayor Cady to appraise lands owned by the city. This land will then be placed on the market.

Foreclosure proceedings on property where assessments for improvements have not been paid will be started within a very short time. Two old horse carts that have passed their day of usefulness will be sold.

Enforce Dog Ordinance

The new city dog pound has been completed and the old city ordinance prohibiting dogs from running at large is being enforced. If a dog is not bailed out it is asphyxiated within five days.

The city collected \$5,039.52 during February. This included amounts for licenses, permits, miscellaneous, old improvement fund, 1924 improvement fund, delinquent bond liens, bonded liens, 1924 liens, bonded indebtedness and park fund.

DISABLED VETERAN FACES BOOZE CHARGE

Fear of Debt Leads to Try At Bootlegging

WAS GASSED IN TRENCHES

Ivan Yates Was Under Care of Veterans Bureau Until Two Years Ago

Worry over debt and the inability to work at physical labor for more than two days at a time because of gas received during the war is thought to have caused Ivan Ray Yates, son of an old pioneer family near Manning, to resort to moonshining in the hopes of paying off his farm mortgage. He and Charles H. Muloch were arrested Saturday charged with having booze, still and mash.

Cleverly Hidden

Four stills and 100 gallons of finished product were found in a room under the barn by Sheriff Reeves and Deputies Weckert and Redmond. Heavy padlocked doors led into the room where the stills were found and four vents ran into the silo eliminating all possibilities of the odor being noticed. The main floor of the barn had a double flooring and a trap door ran down into this room. The trap could not be seen from above.

Yates enlisted in Co. G of the old Third Oregon infantry and was later transferred to the 42nd division in France. He served with Battery C, 142 field artillery and was gassed and struck in the right hip by shrapnel according to the records of the veterans bureau in Portland. He was under the care of the veterans bureau for some time and until October 26, 1920, drew temporary total disability payment. April 5, 1921, he was given a partial disability rating. He was last examined by the government in November, 1923.

Dropped by Government

He was dropped by the government at a time when, he says, that he was unable to work any length of time at all. Debts piled up and he had a mortgage on his place. If he worked three days the gas would come out on him. He is believed to have been led on by Muloch and his fear of being in debt prompted him to take what he thought was the easiest road.

Minnie Brakebush was placed in jail Sunday to serve out a fine. E. L. Andrews is serving 10 days in the county jail on a charge of speeding. Andrews is declared to have been a flagrant violator. H. A. Wahner was arrested Thursday of last week on a charge of being drunk. Julius Coupe was arrested Friday on a liquor charge. Henry Haberman was arrested Friday charged with uttering a forged instrument. He is out on \$3,000 bail.
