## School Bells To Ring Here Monday Morn

Summer Vacation Coming to End in Few Days

## Bus Schedule Is Given

D'Hondt Building Will Be Used to House Overflow From Grade Schools

When the school bell rings Monday morning it will spell the ending of those glorious days of summer vacation for the boys and girls that will attend the Hillsboro grade school as well as the older students of the union high school.

The first day will be taken up with registration, the arranging of schedules, room assignments, and the purchase of books. Superintendent C. H. Nosler issued a special appeal to parents to bring their children to school the first Monday, and beginners will not be received during the first semester after the third Monday of school, September 24.

**Increase Expected**  
The usual steady increase in registration is expected in the grade schools and the union high. The D'Hondt building at Ninth and Oak streets has been secured to handle the overflow from the grade schools until the union high students are moved into the new structure during the Christmas vacation.

The high school bus schedule has been announced by Superintendent B. W. Barnes of the union school as follows for the first week:

The Laurel bus will leave the Midway garage at 7:30, going direct to Laurel, thence to the school house in district 80, thence to Hillsboro via Simpson's corner and the Grabel school. This bus, after reaching Hillsboro will pick up the students at the school house in district 89.

The Scholls bus will leave the Mountside school at 7:30 going to Hillsboro, turning west at Grover's corner and picking up students at Jacktown and Witch Hazel school houses.

Mr. Peters will take students from the Boge and Farmington school houses and connect with the Laurel stage at the Davis corner on the Hillsboro-Laurel road.

The Orengo bus will leave Hillsboro for Orengo at 7:15, following the same route that it did last year, arrive at Orengo at 8 a. m., thence to Hillsboro via Baseline road.

The Orengo bus will go to the Gregg school house, leaving there about 8:40. This bus will accommodate both grade and high school students.

Students not on the bus lines should meet the bus at the most convenient place. This schedule is subject to change.

## Brakeman Caught Between Logging Cars and Killed

William C. Edmondson, 40, brakeman, was killed Monday at Cochran when caught between two logging cars. Coroner Glenn F. Bell, who investigated, said that a train was being coupled up and that as the train started the coupling pulled apart. Edmondson signalled the engineer to back and jumped in between before the train came to a stop and his back was crushed.

Funeral services were held from the Glenn F. Bell mortuary Wednesday afternoon and interment was in the Hillsboro cemetery.

Edmondson was employed as a brakeman by the Blue Lake Logging company and had only been in Cochran a month. He is survived by the widow and two brothers.

## Serious Hurts Labor Day Toll

Labor Day week-end, with its ever increasing automobile traffic, took its toll of Washington county residents with one death, two seriously injured, and a few minor accidents.

Miss Helen Kuhne, 10, daughter of Mr. and Mrs. Walter Kuhne of this city, is in a critical condition in the Dr. Via hospital at Forest Grove with a fractured skull, compound fracture of the leg and possible internal injuries as the result of being struck by an automobile on Third street near Lincoln Monday evening.

The girl walked behind one car directly into the path of the second driven by Robert A. Hill of Aloha. Dr. J. B. Dinsmore was called and the girl taken to the Jones hospital, and from there to Forest Grove. She has not regained consciousness since the accident. Attendees at the Via hospital this morning said that she was now conscious at times and would likely recover. She is a niece of Dr. Via.

Mrs. A. A. Van Pouche of near the Jacktown school suffered a skull fracture, broken collar bone, and body bruises when struck by a car driven by E. P. Bunker of North Plains at Cornelius. Mrs. Van Pouche with her son was returning from Netarts and had stopped to go across the street to a store. She stepped from behind the parked car in front of the Bunker car.

John O'Dell of Tigard suffered serious burns in an accident on the Columbia highway near Vista House Monday night. He was leaving Vista House on his return when his lights went out. His car went into the ditch, overturned and burst into flames. His foot caught in the door, preventing his escape until passing motorists came to his rescue. He was taken to the St. Vincents hospital, where his condition is said to be serious.

## Prizes in Cash For Horseshoe Tournery Large

Elimination Contests the First Two Days of Fair

## Championship Is Goal

Thousand Horseshoe Pitchers Expected to Enter; Interest in Game Increases

Twenty-two cash prizes amounting to \$300 will be given by the county fair board in the state horseshoe pitchers' tournament here September 20, 21 and 22. This event is a special feature secured for the county fair this year by the fair board.

**First Prize \$85**  
First prize and the championship receives \$85, second prize is \$60, third is \$35, and on down to \$2.50. The 12 highest in percentage will play the finals. Each player will be required to throw 100 shoes to determine qualification rating. Elimination contests will be held the first two days of the fair. A fee of \$1 is charged for entrance. Exhibition games will be played each afternoon.

Approximately 1000 persons from all parts of the state are expected to try to qualify and fight for the large prizes and the championship. W. H. Hayden, present state champion, will probably have a hard time defending his title this year as the game has increased rapidly and hundreds more have become scientific players. It has become one of the greatest year-around sports and courts are found not only in the back yards but are in the finest parks and playgrounds of the cities.

The Oregon State Horseshoe Pitchers' association, a member of the national association, is boosting and working hard to show all players and their families a great time at this tournament.

Most of the remaining county schools will open September 17, among them being the Forest Grove schools.

The county boundary board in session here Tuesday night granted boundary changes on two petitions and denied one. A change was granted between Helvetia and Rock Creek and also between Cedar Mills and Union. The board denied the petition for a change between Progress and Raleigh on the understanding that Progress would build a modern two-room school in the near future.

## N. Bangs Dies In Automobile Wreck Sunday

Former Timber Postmaster Is Instantly Killed

## Thrown from Machine

Funeral Services for Prominent Resident Held Here This Afternoon

Nicholas Bangs, 75, former postmaster at Timber, was instantly killed in an automobile accident on the road between Vernonia and Timber Sunday.

Mr. Bangs drove to Vernonia with William J. Kelly of Vancouver, Wash., and on the return trip had turned into the Beaver road to see a friend. Kelly lost control of the car and Mr. Bangs was thrown out of the car, apparently striking his head on a log.

**Called Timber Mayor**  
He was born at Black Wolf, Wis., December 27, 1853, and in 1873 was married to Miss Christina Thorp, who died about 30 years ago. Eighteen years ago he moved to Timber, where he has been prominently identified with the affairs of the community. He was often called the mayor of Timber.

Mr. Bangs is survived by two daughters, Mrs. Edna K. Brosse of Scholls, Mrs. Florence Peterson of Tulsa, Okla., Nicholas Bangs, Jr., of Miles City, Mont., and Walter G. Bangs.

Mr. Bangs was well known in Hillsboro, where he spent considerable time. He was a member of the Hillsboro chamber of commerce.

Mr. Bangs was a member of the Portland lodge of Elks, and a life member of the Masonic lodge at Antigo, Wisconsin.

Funeral services were conducted this afternoon at 2:30 at the Limber chapel, under the auspices of the Hillsboro Masonic lodge. Commitment will be in the Portland crematorium.
