Many Pass in Inspection of Spuds Locally

Work of College Department Completed in County

More Certified Acres

Certified Grade Allows Only Five Per Cent Disease; Standard Grade Less

Forty-two Washington county farmers passed the field inspections for certified potatoes conducted this year by the farm crops department of the Oregon State Agricultural college, according to a report made by County Agent O. T. McWhorter. Eleven passed the standard grade test. The field inspections have just been completed.

In case of the certified grade of seed potatoes, fields must show not to exceed 5 per cent of total of Mosaic, Wilt, Rhizoctonia, Blackleg, Leaf Roll, and other potato diseases. Standard grade allows a slightly larger percentage and includes those potatoes which will not quite make the certified grade. The standard seed potato is used for commercial planting. The total acreage of certified seed potatoes in this county this year is larger than for 1927.

McWhorter will be held Friday and Saturday of this week in the old Star garage quarters in Long building next door to Long's Bazaar. The show will be open during the evenings.

Advance indications are that the corn exhibits for the show will far surpass that of last year in quality. Many of the entries after being exhibited here will be taken to Portland for the Pacific International.

Malcolm Tennant, head window decorator for the Meier & Frank company in Portland, will judge the windows Friday afternoon. The general idea to be carried out was advertising for the corn and potato show. The skill shown by a number of local business houses has resulted in many attractive windows.

Early Settler Laid to Rest

Funeral services for William Hamelman, 68, of Cornelius, who died October 17, were held from the Cornelius Lutheran church Saturday afternoon with the Rev. H. Timmeck officiating. Interment was in the Cornelius Lutheran cemetery.

Mr. Hamelman, a resident of Washington county for 40 years, was born in Germany on November 7, 1859. He emigrated to California in 1895 and then came to Washington county, settling near Forest Grove, in 1898. Mr. Hamelman was married to Miss Marie Hacke at Cornelius in 1890. After a few years near Forest Grove and at Dilley they moved to a farm south of Cornelius. He retired about nine years ago.

Oral Health Is Vital Factor

Oral health is a factor in business efficiency. It gives greater comfort and more resistance to disease in the opinion of Dr. Henry Cline Fixott, who addressed the members of the chamber of commerce at the luncheon Monday noon. Dr. J. R. Marshall acted as chairman.

Dr. Fixott cited the progress that had been made in the fight against disease during the past decade.

Factors that make lower efficiency, he said, were as follows: Improper heating and ventilation, lack of exercise, lack of attention to personal hygiene and neglect of oral hygiene. He declared that 60 per cent of the ills were traceable to oral or mouth infection.

Melquist to Act as Purchasing Agent

L. C. Melquist, foreman of the county shop, was authorized by the county court Wednesday to act as purchasing agent in the purchase of tools, supplies, materials and equipment for road construction and maintenance. The foreman of the various road districts are instructed to apply to Mr. Melquist for needed articles. The court said that in some instances road foremen have, without authority from the court, made purchases and frequently at a loss, because of the inability to obtain the best prices.

Hillsboro Shows Power

Goodman's Boys to Play the Powerful McMinnville Team Friday

Hilhi bucked and passed its way to a 20 to 0 victory over a highly-touted Newberg high team on the local gridiron Friday afternoon in the first conference game of the season. The boys from Quaker town never threatened to cross the Hillsboro goal line, while Coach B. M. Goodman's gridsters provided the visitors with a number of dangerous thrusts.

Blocks Two Punts

John Hare, Hilhi left end, who was outstanding on defense and of fence, and blocked two punts, paved the way for the first touchdown when he blocked a Newberg punt and it was recovered by Pasley in the shadows of the Newberg goal posts. Charles Blazer dropped back and threw a pass for Hare for the first counter. Hare converted.

The second touchdown came by the aerial route when Blazer tossed a short pass to Hare, who twisted and sidestepped and sprinted 40 yards to the touchdown. Try for point failed. The third score came on a line buck by little Blazer, who by the way can sure pick his holes in the opposing line. Hare converted the point and brought the score to 20 points.

Leonard Rea, although in a crippled condition as the result of the Hood River game, went into the fray after the game was only a few minutes old and brought the crowd to its feet with a 40-yard run, which placed Hilhi in a position to score. The Quakers held at this point, however.

The team showed power in every department of the game and gave indications that they would make the other conference teams sit up and take notice before the season ends. The line opened holes that helped the backs to add to their yardage totals. Jack Rushlow showed power in line plays after going in early in the second half.

Case Goes to Jurors Thursday Evening

Klink Case Is Halted

Liquors and Paraphernalia Taken in Enforcement Is Ordered Destroyed

A verdict of not guilty was returned by a jury in circuit court Friday morning after being out all night on the case of William Treglow, local man, charged with larceny by embezzlement while working for the county. The case took two days in court last week with R. Frank Peters representing the defense and E. B. Tongue and Paul Patterson handling the prosecution.

W. A. Root to Head Pomona For the Year

Officers Named at Meeting With Leedy Grange

Oppose Dunne Bills

Income Tax Urged in Talk; Stand for Temperance Taken in Resolution

W. A. Root of Tigard was elected master of Pomona grange at the meeting with Leedy Grange at Cedar Mills yesterday. Mr. Root succeeds C. W. Craft of Forest Grove, who has been at the head of the grange in the county for a number of years.
