Three Measures in Next Election

SALEM-Only three measures will nfront the voters of Oregon when they go to the polls next November. One of these - the Grange Power bill enacted by the 1933 legislature—will be in the ballot by reason of the referendum invoked by the Security Owners' association. The other two are in-itiated measures. Of these latter the proposed tax limitation amend-ment is sponsored by the Tax Limitation league of Oregon and the proposed healing arts amendment is sponsored by the Progressive Constitutional Amendment commit-

The Grange Power bill provides for state development of water power and hydro-electric energy either separately or in conjunction with the federal government or some other state or states, and the transmission, distribution and sale of power at cost. The measure also provides for the creation of a state power commission of three members. Bonds to finance operation of the commission and development of a state power program by the voters.


