Government Aids

Home Remodeling

United States government now making home repairs and remodeling loans, according to Charles K. Fulton, supervisor of Portland. These loans are in addition to the loans made home owners for refinancing their mortgages.

Three distinct operations have been earmarked by the government. Repair and maintenance is first, including all work designated to restore a house to its condition when new, such as painting, pointing of masonry, calking of doors and window frames, roofing, replacement of gutters, downspouts, house plumbing, etc.

Remodeling is next in order, involving structural changes, such as enlargement, addition of a bathroom, a porch, window, rearrangement of rooms, or any other alteration in the design.

Modernizing, the third operation, involves installation of new equipment, such as insulation, heating, electric system or running water.

Those who wish to repair or make their homes more livable and attractive, should make immediate application to their district Home Owners' Loan corporation office.
