Doctrine of Judicial Review for Country Gained Through Struggle

Editor's Note—One of a series of discussions on constitutional questions presented by members of the U. of O. faculty for newspaper use through co-operation of the college of social sciences and school of journalism.

The doctrine of judicial review in the United States has not been gained without a struggle. Walker in his book "Law Making in the United States" points out that a "somewhat similar power was exercised by the privy council in declaring void the charters of the colonies which seemed to be in conflict with the provisions of the royal charters."

As is pointed out by Corwin in his excellent book, "The Twilight of the Supreme Court," Lord Coke's views were adopted by the privy council in declaring void the charters of the colonies which seemed to be in conflict with the provisions of the royal charters.

However, it was for Marshall in 1803, in the case of Marbury vs. Madison, to apply for the first time in the name of the supreme court the principle that the federal judiciary has the power to pass upon acts of congress.

It is a proposition too plain to be contested, that the constitution controls any legislative act repugnant to it; or that the legislature may alter the constitution by an ordinary act.

Between these alternatives there is no middle ground. The constitution is not a mere parchment. Its precepts are operative and will be enforced by ordinary means, or it is on a level with ordinary legislative acts, and like other acts, is alterable when the legislature shall please to alter it.

It has appeared as a political issue which has agitated the country at intervals ever since it was definitely applied by Marshall. Through the Dred Scott decision it must take part of the blame for the Civil war.
