I regret that my opponent has seen fit to inject into the campaign a personal attack of my record. Such attack appeared in last week's issue of the various county newspapers. Some of the statements are misleading to such extent that I do not seem to have any alternative, except to publicly correct them.

DEPUTY: I have never employed a deputy at any time to assist me in conducting the office. Prior to my term, the county paid no less than \$225.00 per month for a DEPUTY and a SECRETARY to assist the District Attorney. My secretary is paid \$100.00 per month, a direct saving of \$125.00 per month. I have personally handled every case of the District Attorney's office, of which there has been almost 1000 thus far during my term.

FINES: It is well known that the decrease in income from fines has been occasioned entirely because of the repeal of the prohibition law.

TAX SUIT: The statements made by my opponent with reference to the tax suit are especially vicious and misleading. The suit has not been declared void. Only highly technical legal points pertaining to the sale of property thereunder are questioned. The same identical points are questioned in the suit in which Mr. Patterson participated when Deputy District Attorney. On the contrary, the County has already realized more than \$70,000.00 from old delinquent taxes as a direct result of such suit.

CONVICTIONS: My opponent continues to make a percentage comparison between my record of convictions and the record of convictions of my predecessor, Mr. Tongue, who was District Attorney for over 20 years. Such a comparison is not only incorrectly stated, but is wholly unfair. If any fair comparison is to be made, it should be upon Mr. Patterson's record as against my record. Here is such record: Of the many cases tried in Circuit Court during my term, Mr. Patterson has opposed me in four of them. In such four trials have resulted in three convictions and one acquittal.

I continue to stand upon my record. I have faced every responsibility of the office to the very best of my ability. Throughout my term, I have maintained my office at the Court House, where if property belongs to the convenience of the public. During my term more than 95% of all arrests have resulted in pleas of guilty or conviction in the Courts. I have succeeded in reducing the average amount of cost of maintaining the office from \$2791.00 during the preceding term to an average of \$1432.00 during my term—a saving of almost 50%.

If re-elected, I will continue to conduct all civil and criminal business of the county honestly, efficiently and economically. (Paid Adv.)

Health Association Votes for Changes

(Continued from page 1) Claude Mr. George A. Bauman of Forest Grove membership. Mr. Zola Morgan of Hillsboro, seal sale, and Mrs. Edward C. Comale of Hillsboro, nurse and supplies.

Final meeting of the executive board of the association was announced for Monday night at 7:30 o'clock in the office of the county nurse.

Introduction of Dr. Douglas was made by Dr. J. O. Robb following the church auditorium.

Dr. Douglas opened his address by declaring that a health department was the cheapest way to cut the cost of illness and pointed out that the best method of attack and the most reasonable in the way of cost, was by prevention rather than waiting for the disease to appear.

He suggested that the first step toward a health unit in this county was to appraise the work needed, covering the entire field of health needs and working forward to the new department from that start.

From this point he outlined what he believed would be an efficient health unit for this county which would include three nurses, a health officer, county physician, sanitary inspector, and an office clerk.

The sanitary inspector, he said, would deal with milk and water supplies and other investigations relative to public health matters. The work would include laboratory tests and inspections. Nurses and doctors would carry on the program at the present office that full time would be devoted to the work.

In the matter of funds, Dr. Douglas declared that the money should all come from one source if the unit was to function at full value. In Marion county, he said, the money came from several different places with resultant discord as to who should get the most service.

Counties can organize, he said, and then a committee of seven is appointed and given the power to employ the officials of the unit. There would be slight difference, he declared, in the amount of money expended, as it would amount to the shifting of expenditure from care of the sick to prevention of sickness.

The small unit would amount to \$6720, according to figures prepared by Mrs. Hugh McGilvray of Forest Grove. This total, \$6620 would be furnished by the county and \$2700 by the federal government under the social security law. Present expenses are such that addition of approximately \$1500 would be sufficient to establish the unit and it is believed that this amount can be raised by towns and cities and by the health association.

Mrs. Sadie-Orr Dunbar of Portland spoke briefly on the work of the health association in connection with tuberculosis eradication and the results of a survey of tuberculosis over the United States.

The tuberculosis slogan of the association has been changed, Mrs. Dunbar said, to "Eradication." The greatest single cause of death, Washington county was urged to concentrate on the Christmas seal sale this year and attempt to double the amount of the sales.

The entertainment part of the program included accordion solos by Earl Drorbaugh of Beaverton; reading by Delosa Anderson of Hillsboro, and violin music by Miss Ruth Boyles of Forest Grove.
