### Knox Pleasant Gentleman to Converse With

Colonel Frank Knox, Chicago, vice-presidential candidate of the republican party, is an easy man to interview, newspapermen found at a press conference in Corvallis Thursday night. Stocky, pleasant, smiling, hair and an open smile he seemed to make a hit.

Clad in a gray-green business suit, the colonel passed down the line of editors and reporters, shaking hands and giving a pleasant "good to meet you" to each, after which he dropped into an easy chair, puffed a cloud of smoke from a much used pipe and invited the "boys" to "shoot."

Despite long working days in which he makes numerous speeches, Colonel Knox appeared fresh and alert, his nimble mind meeting each question and throwing back his answer with machine gun regularity.

The first question on the firing line was one concerning the popularity in which he was declared life insurance has been placed by government spending. The question came from the representative of a democratic newspaper, who explained that he was desirous of getting the "record straight."

Further information, however, was desired by the other news hawks present. To this he replied that the nation used more bank checks than currency, and consequently currency was not in demand.

"We find the government borrowing from the banks and the banks loaning money on government securities," he said. "Ninety per cent of the government bonds are being absorbed by the banks."

"Credit inflation therefore is underway. In relation to the value of insurance policies the question is how much will the dollar be worth when the policy or savings account is paid."

"Another interesting fact is that the amount of business is exceedingly low in comparison to the amount of credit available."

The next question followed along the same line and asked how the republicans proposed to stop the move toward inflation.

"By stopping the excessive out-ging," Knox shot back, "or by the levy of taxes sufficient to balance the budget. Either course would react to strengthen the credit."

"If the government and present campaign issues were concerned."

"Not as long as there was a person in danger of going hungry or was out of work," he replied.

"However, we would move to stop the waste in relief."

"At this point one of the newsmen asked a question which had no bearing on the present campaign with the result that the remaining few minutes of the conference was just as far as statements of present campaign issues were concerned."

### Automatic Water Hearing Rate Cut

Reduced rates for gas automatic water heating and gas refrigeration have been put into effect by Portland Gas & Coke company, according to Tom Bailey, district manager.

Substantial savings to customers now eligible for services under the new schedule ad large additional savings to others who may qualify will result from the rate change, according to Bailey.

Two types of service are covered by the new rates. Bailey stated. One schedule makes lower rates available to customers using gas for automatic water heating or refrigeration, or both, on a year-around basis where no other major gas service is used.

Gas cooking customers are offered a new combination rate with automatic water heating or refrigeration, supplementary to the company's present low combination rate for all-gas household service.

"The new schedule makes gas in every way the most economical fuel for automatic water heating," said Bailey. "Calculations under the new rates show that a customer now using only a gas automatic water heater can use and free up 40 per cent more gas for the same money he has been paying."
