great war is over, but for those who were wounded, passed, or left struggling with disease, it is not over, and it is not over for the widows and the orphans of those men who have paid the supreme price, or for the gold star mothers. We want no more wars, but if we are attacked we shall resist to the last man."

He spoke about the foreign ideas and forces which are at work in the nation attempting to undermine and change the form of government, and pointed out that while we speak of peace the war clouds are thickening over Europe.

"If those countries wish to fight among themselves, let them," Snell declared, "America must stay out of their quarrels. We are opposed to them dumping their troubles in our back yard."

One great step toward peace, he remarked, would be to take the profit out of war. The last war
