WASHINGTON LETTER

WASHINGTON—Problems of administering the Black-Connelly bill, if it is passed, will be somewhat simplified because the federal government can draw on the experience of eight states which already have working minimum wage laws of their own.

The federal wage and hour bill is similar to the New York law, and was in fact written by Ben Cohen, self-effacing New Deal brain trust, who drafted the New York law. To the New York law applies only to women and minors but the federal bill embraces both men and women.

A limited number of wage earners will be affected by the Black-Connelly bill, if it becomes law. It is estimated there are about 3,000,000 persons in the industries to be covered who are earning less than 40 cents an hour, and there are about 6,000,000 persons who are working more than 40 hours a week.

There will be no minimum wage regulation to protect the man whose income is more than \$200 a year, and local service industries and small businesses will be left to the states to regulate.

Mrs. Elinore M. Herrick, New York regional director of the National Labor Relations Board, thinks the yardstick for wages which will be used by the federal board will be those wages which a majority in any specified industry would and could support voluntarily.

Labor laws such as that proposed by Black and Connelly are designed to control a sub-standard minority, and eliminate sub-standard practices.

This enables those employers who voluntarily subscribe to decent wage standards to maintain and improve those standards. Mrs. Herrick explained that it has been the experience of the New York board that it cannot set a wage higher than the wage in effect in the upper quarter of a given industry.

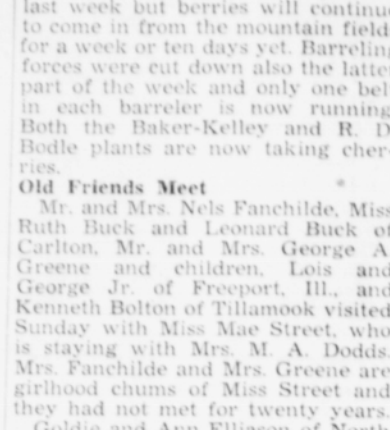

which to take membership in the union, which in this case, is the Dairy and Ice Cream Drivers' and Helpers' Local No. 305 of Portland, an affiliate of the Teamsters' Union.

Must Affiliate Soon Present employees have 40 days in which to affiliate with the union, or until August 8. Dues are \$2.50 a month, with an initiation fee, probably fixed at \$10.

The contract guarantees no sympathetic strikes, plant strikes, or lockouts during the life of the agreement. Conciliation of all differences will be in the hands of a committee, which includes two employees from the plant and two appointed by the executives of the plant.

In both cases the representatives of the union and the company must have been continuously employed in that particular plant for at least a year.

Under the contract, two men may be employed in the plant to learn the business as executive apprentices, but may not be employed to work before taking union membership, the plant will be virtually a closed shop.

According to C. T. Richardson, plant superintendent in Hillsboro, the local condenser already is on the union wage scale with two or three exceptions, the men all receiving 50 cents an hour or more. Hours also conform.

Only One in State The Hillsboro plant is the only one in Oregon, and one of several on the Pacific coast. It was established in 1906, and the Forest Grove plant combined with it in 1929.

During the 34 years of operation, the company has paid out in wages and for milk in this county, \$37,000,000, while from 80 to 85 per cent of the product is exported outside of the state, Richardson said.

Efforts to unionize the B. E. Maling cannery, still continue with two meetings held during the past week. Officials of the plant Wednesday were requested to attend a meeting of union officials in Portland this night (Thursday) with officials of other packing plants in this part of the state.

L. A. Davis, employe of the Maling plant, and local chairman of the Cannery Workers' union chartered in May, declared that 50 per cent of the state's employees had joined the group. Wage schedule minimum of 50 and 60 cents is to be asked, it is said.
