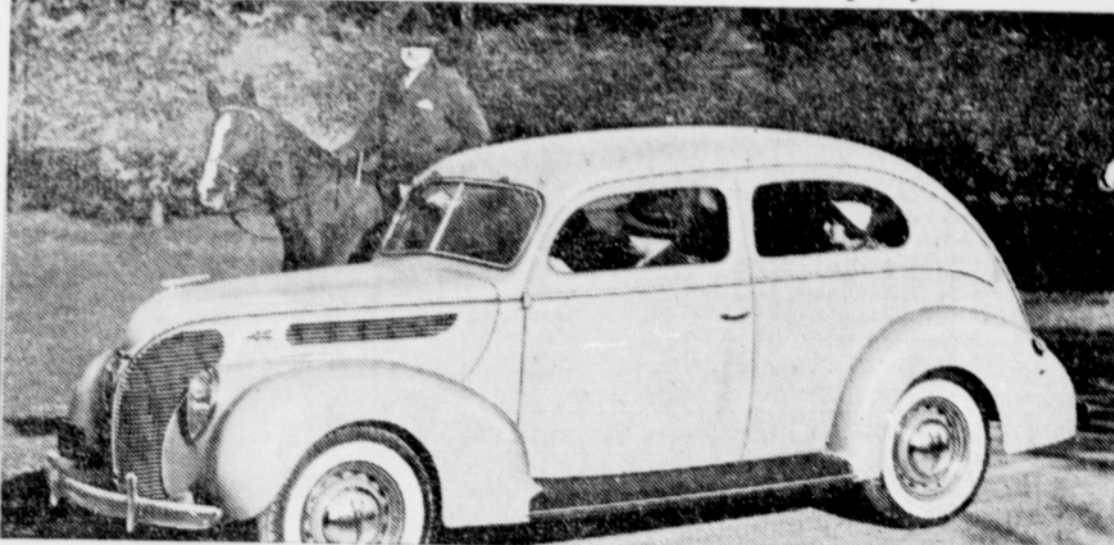
Rites Held Friday for Mrs. Schmidt

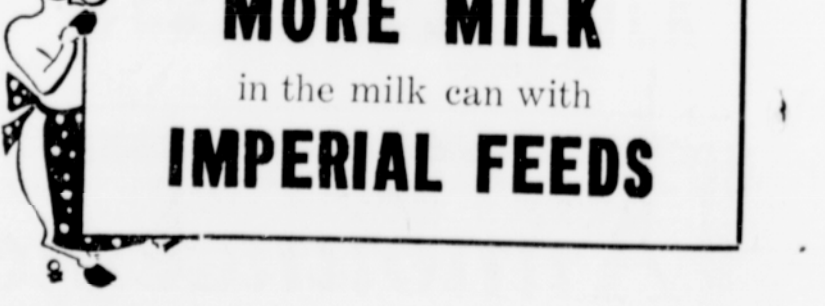
