

Forest Grove Trio's Trial Under Way

Trial of Ray Gillespie, Ed Greeley and Wallace Webster, Forest Grove union members, on charges of assault and battery growing out of altercations at Al's Oasis on October 30, 1937, began in circuit court late Tuesday afternoon with selection of the jury.

Trial proceedings got under way Wednesday, with William A. Lord defending the trio. An attempt was made some time ago to secure a change of venue for the trial, which was refused by the court.

less to understand why the county court would appoint persons to the election boards whom they know are now precinct committeemen, and would be likely to file again, and they notify them that they are not eligible to hold both positions.

Judge Templeton cited the election laws, from section 36-202 of the Oregon Code of 1930, which states that members of election or counting boards shall "not be a candidate for an elective office to be voted for at the ensuing election." In addition, he said, an oral opinion from District Attorney G. Russell Morgan was to the effect that precinct committeemen candidates cannot serve.

Scott, however, stated "in order to get the highest possible interpretation of the law, I have today consulted the office of the attorney general at Salem, and I find that on April 14, 1932, he rendered an opinion to the district attorney of Benton county to the effect that a judge or clerk of election is not disqualified as such by reason of his name appearing on a primary nominating election ballot as candidate for the office of central committeeman.

Told to Stick
"In accordance with this opinion," Scott informed, "I am advising the democrats who have been appointed on the election boards that they having filed for precinct committeeman does not disqualify them from serving on the election boards. This being the opinion of the attorney general, I recommend the democratic party in the county and the state will uphold our members in their rights."

In response to Scott's assertion that the county clerk's office has sent him the check that no person can serve on the election board whose name appears as committeeman candidate, Templeton said "No democrats have been notified but the check that no person can serve on the election board is a 'tempest in a teapot' and declared that in all probability the county court will not take any action on the subject this year."

Henry L. Hess of LaGrande, democratic candidate for governor, and Howard Costigan, executive secretary of the Washington Commonwealth federation, and others will speak at the Forest Grove union high school auditorium at 8 p. m. Friday, April 29.
