



This Is No Time to Upset The Nation's Appellate

The chiefs of three of the railroad unions, who cancelled strike authorizations only after government seizure of the nation's vast and vital railroad system, have accused the administration of delay and mis-handling of the wage dispute.

It seems to us, that the American public and the men and women in the armed services will point their collective fingers at any group or groups that strike or threaten strikes, and say that this is no time to upset the appellate. When American men and women are fighting and dying, doing it all without thought of hours and wages and conditions, it is most certainly no time for those enjoying the comforts of the home front to throw any monkey wrenches in the wheels of the war effort.

A personage high in the councils of the United States and United Nations last week termed the threats of railway and steel strikes a "great tragedy," asserting they provided fuel for the axis propaganda mill and thus may have delayed revolts in Germany and occupied lands this winter—revolts which could spell swift collapse for the nazis. It stands to reason that anything that smacks of difficulties on the United Nations home front would be comforting to our enemies as well as disruption to our war effort.

We have our orders from the government and should willingly and gladly carry on in the field in which we can do the best without complaint or demands for increased economic security while our boys are not only fighting Japs and Germans, but the worst of elements and conditions. Any group or groups that by its actions prolongs this war should answer to the fighting men and their families.

Patriotic Service

National recognition was fittingly accorded war price and rationing boards throughout the country on Wednesday, January 5, their second anniversary, for the faithful service rendered to the nation in time of crisis. The work has been exacting and far from glamorous, demanding hours of unselfish devotion and service. Besides the regular members of the boards, there are others serving on various panels that have given unselfishly of their time in connection with the various programs. Also there have been many other volunteer workers that have put in many long hours of patriotic endeavor so that the programs might go forward as smoothly as possible. They have all done a difficult job exceptionally well at the call of their country and truly merit the appreciation of the community.

One of the few remaining links between the historic pioneer past of Washington county and the modern day was severed last week with the burial of Charles M. Johnson, who was born on his father's donation land claim near Farmington in 1854. He was nearing five years of age when Oregon was admitted to the union in 1859. His was a full life that had seen his native land transformed from a virgin wilderness to the modern development of today, which in itself is almost a fairy story. The changes wrought during the brief span of human life are almost beyond the imagination.

I haven't seen Ray since the first day, but he is okay. I was talking to some of the fellows who were on the same ship back as he was.

I didn't get to see Bud on the island but he walked within a couple of feet of me one night. I was in my fox hole when he passed and I didn't know it was his outfit until after they passed.

But I'll probably get to see them both when we get settled over here.

Say, I haven't heard from any of you people in quite awhile but I guess they haven't passed out all the mail over here yet.

I got a letter from Star telephon Well I got a few pieces of Jap money this time to send home to you when I can and a few pieces of a Jap Zero plane, and a Jap Imperial marine's belt buckle. I had a rifle, too, but I gave it to another kid as I didn't want to carry it around.
