

Local Girls Tell of Plane Trip to Nome, Kotzebue

Editor's Note—The following interesting account of a plane trip to Nome and Kotzebue was given in a letter by Kitty and Julia Soder to their parents here:

Port Richardson, Alaska
June 26, 1946

Dear Folks:

We've decided to devote this entire letter to giving an account of our week-end trip to Nome, and Kotzebue, Alaska. Ethel Spiering, as well as twenty other girls from Port Richardson, also made this trip.

A few of us dreamed up the idea a couple of weeks ago, and then succeeded in chartering a plane to make that dream come true. The twenty-three of us made a maximum load for the plane, a C-47, now owned by an Anchorage airline.

Inasmuch as weather is a major item in Alaskan flying, we "hatched" the weather department on the spot for days in advance of the report to receive discouraging reports each time. Finally the "weather man" sent the report over in writing as follows:

A FINE ABOUT NOME
So off to Nome you also go.
If I were you, I'd use my dough—
There's really not so much to see.
A mountain, a stream, perhaps a tree.
Then those things are not so very rare.

You find them nearly everywhere. The week-end parties it is no friend. It has a habit of playing tricks. I know you're an ordinary girl, but you know the weather knows you're not. I've tried to tell it all in vain. It still insists it's going to rain. So hold my warning each and hold folks. Be sure and take that old umbrella.

Now that you've said your hard earned backs. And found the weather not fit for ducks. Please don't let it fill you with terror. There's always the chance that I've made an error.

So let me wish you the Voyage Remember
If you see the sun, it's just a mirage.

Contrary to the above prediction the weather was excellent Saturday afternoon as we took off from the airport in Anchorage, Alaska. Enroute to Nome we had a fine view of Mt. McKinley (29,300 ft.) and also of Mt. Foraker (a mere 17,000 ft.). We made very good time and three and a half hours after departing Anchorage, the plane was circling Nome to give all aboard a wonderful view of the little town on the Bering Sea, before landing.

Landing for the night was somewhat of a problem, for although advance reservations were supposed

edly made, the one main hotel just isn't equipped to handle a crowd the size of ours. However, some of the travelers were taken into a spot to "hang their hat."

Nome is rebound from October until June, so June 12th marked a very important day as the first ship of the season arrived, bringing supplies. Its recent arrival was evident in the offerings of the grocery stores and restaurants. Excellent meals were served at the Nome Grill at prices far more reasonable than those in Anchorage. Even a steak dinner didn't cost more than \$1.50. Servings of half a cantaloupe were only 35c, which is certainly reasonable considering the great transportation distance.

Most of us enjoyed shopping for carved ivory, and sight-seeing throughout the town, all of which contained less than an hour. Afterwards we lunched at the beach and occasionally got our feet wet when an unexpectedly large wave rolled in. Walking along the beach brought us to the gold rush days, and we wondered how any of those "fools" could have been so stupid as to waste their money on a worthless metal. The Eskimos were friendly and very helpful, in fact we were taken to their tents. Our arrival was a real event to them, for it is doubtful if they have seen any other visitors at one time. The only visible means of transportation in the village other than the dog sleds were not available at this time of year, was a caterpillar tractor with a trailer, which made trips to and from the airport. There were no narrow winding roadways between the huts. The Artic shore, which is slightly elevated, serves as the main thoroughfare.

We were pleased that we had an opportunity to meet Archie Ferguson, "the mad bush pilot," who has been featured in numerous magazine articles. Surprisingly, he manages to survive in spite of breaking most of the laws of nature and man in regard to flying.

We all regretted that we were unable to spend a couple of days in this interesting little village, for it was so very different from anything we had ever seen before.

On our return trip from Kotzebue to Anchorage, we enjoyed an unclouded view of the Yukon River valley. The small village of Nulato, Alaska, was our only stop enroute home, so while still a couple hundred miles away we were unable to spend a couple of days in this interesting little village, for it was so very different from anything we had ever seen before.

As we neared McGrath we were amazed to note the snake-like twisting of the Kuskokwin River. It apparently travels more than a thousand miles to cover a direct distance that would be less than a hundred miles. The little town has a beautiful setting. The greenness of the trees was a striking contrast to the barren country up north around Nome and Kotzebue. Alaska must have gotten its mosquito reputation from this section of the country, so we spent most of our time indoors, where we enjoyed the excellent supper which was ordered a couple of hours earlier.

After supper we visited a parka and mukluk factory. The owner showed us many pieces of beautiful native handwork, directed our attention to the tiny bits of fur of different colors carefully mixed and stitched into products intricate and beautiful designs. These are used for borders on parkas and trim for mukluks.

Continuing on our way, the flight over the Alaskan Range was really a sight to behold. It was clear and beautiful, with the sun striking many points. We were all thrilled by the many snow covered peaks and the immense stretches of snow. Here again we found the radio had served us well, for five cabs were waiting to take us to our barracks on the Post.

We were fortunate in having excellent pilots, and a wonderful hostess, who was surprised to learn that none of the three had ever before been to Nome or Kotzebue.
