PACIFIC COAST NEWS.

Dr. Watts is to give sixteen lectures to the Yamhill people on Revelations.

The Jacksonville Times threatens to fight against official thieves, with renewed vigor. The Statesman suggests that it begin on the San Francisco Harbor Commissioners.

Portland has three professional beggars.

The East Portland and Silverton plank road is undergoing repairs.

The Portland authorities are prosecuting saloon keepers for keeping their places of business open on Sunday.

The law students of Portland have formed a Law Association, with a Judge, which his name is O. P. Mason.

The liquor dealers of Portland are about to organize an association for mutual aid, protection, and mental, moral and religious culture.

An Oregon City girl exclaimed when she saw a Thomas fellow elevate his back: "Oh! wouldn't he make a lovely bustle?"

There is a young lady in Los Angeles county, Cal., who owns six thousand acres of land, and four thousand head of cattle, she has no incumbrance in the shape of a husband.

There was a heavy storm in San Francisco on the 29th ult., accompanied with thunder and lightning.

During June and July 95,000 seals were taken on the Alaska seal Islands. A big boat at Olympia weighs 44 pounds.

A Vancouver firm has contracted to furnish a San Francisco firm 1,500,000 hoop poles during the winter.

Reports from Walla Walla to Nov. 18th, represent that sleigh bells are jingling constantly, \$5 an hour at that.

The next Washington Territory Legislature will have a Democratic majority of 17 on joint ballot. So reported.

Scarlet fever is prevailing at Portland.

Wheat buyers were paying sixty cents per bushel at Tugent Station last week.

A reward of \$2,000 is offered for the apprehension and conviction of the incendiary who set the Oregon City Woolen Mills on fire.

At Yreka, on Thanksgiving day, Dr. O. P. S. Plummer, Superintendent of this Division of the W. U. Telegraph, was presented with a beautiful watch and chain, the gift of the forty-four operators of his District. J. W. Thompson delivered the presentation speech, and the Doctor responded appropriately. The names of the donors are engraved on the watch.

The next term of the Willamette University will begin December 16th.

Horse racing is a favorite amusement with young men on Sunday at Olympia.

Washington Territory, at the recent election, voted strongly against calling a Convention to form a State Constitution.

A colored man named Peter Kelley, and a forest marten named Betsy, were joined in marriage by Rev. Mr. Dickey at Olympia a few days ago.

Wood at Walla Walla in the winter won't sell less than \$3 per cord. It was recently attempted by sellers to put it up to \$15, but failed.

The County Commissioners of Walla Walla have authorized the Auditor to receive bids for furnishing 450,000 brick to be used in building a new Court House and jail.

No snow, and pleasant weather, is the report from north of Snake River.

W. F. Babcock, Albert Gansel and Louis Sloss have been appointed a committee in San Francisco to inquire into the diamond frauds, with full power to use all means necessary to bring the guilty parties to justice.

The Bulletin tells of the drowning, last Friday, in the Willamette river from the Stark street ferry boat, of the two horses of Mr. Lovett; left standing, they walked in to get a drink, and got it.

It is said that startling developments will soon be made of the abuse of the elective franchise in Utah.

Washlieke, the great Shoshone Chief and friend of the white settlers in Utah, was killed in a drunken row with one of his men recently.

A correspondent of the Statesman writing from Ellensburg, says: "Consult the surveys, ask the opinion of our coast Captains, and you will learn that Port Orford is the best summer harbor on the coast; it is situated half way between the mouths of our two principal rivers; half way between our two commercial cities, San Francisco and Portland; has the proper depth of water, with abundant material, so convenient that skillful engineers have estimated that one million dollars will build all that is required for the next half century."

The State Brick Yard at Salem has been doing a huge business lately, getting out clay for next season. Twenty-one teams and one hundred and twenty-three men have been employed.

A letter from the diamond fields to San Francisco, states that at least one thousand men are on the grounds prospecting.

Mr. Rogers, of Hillsboro, had his toes amputated one day last week.

"Epizoot," is causing the people in Washington county to cough, sneeze, blow, and so on. Bad "colds" is the matter.

The musical Chinaman in the Penitentiary heretofore noticed, has quit singing and gone to stealing. The Statesman says: "He works with the other hands with pick or shovel and works well except when he has a chance to steal something. Let another man lay down a shovel, our Heathen Chinese goes for it and swaps. If a smoker lays down his pipe, he gobbles it. If nobody is watching, he snatches another man's coat or jacket and whips it on over his own. The other day he arrayed himself gorgeously in three prisoner's jackets; and he wouldn't give them up until one of the guards stripped him."

Considerable lumber is being received at Roseburg from other parts of the State, and many improvements are being made.

Sheriff Scott, of Marion county, and his deputies, collected \$5,000 taxes during the month of November.

John Byron, an old resident of Oregon died at Salem on last Saturday at the age of 48 years.

That flag was presented to the firemen of Corvallis on Wednesday of last week with a grand flourish.

A wagon containing a woman and two children turned over twice in about a second and a half, near Myrtle Creek last week, but fortunately and almost miraculously, no one was much injured.

The citizens of Yaquina Bay have projected a scheme which, if successfully carried out, will prove of incalculable benefit, not only to themselves, but to the entire county. It is proposed that the Pioneer and Newport Wagon Road shall be completed through to the beach, thus obviating the necessity of traveling between these points by water. Mr. Alfred Cloake, one of the most energetic, thorough going citizens of that section, now offers to open the road through to Newport, by the first of next April, for the sum of \$200.

B. L. Arnold, President of the State Agricultural College at Corvallis, notifies the young men of Oregon that that institution is now fully organized with a full corps of teachers. Each State Senator is authorized to appoint two students, who receive their instruction free. Any young man, sixteen years of age, and of good moral character, can get an appointment by applying to the Senator of his district, or addressing the President.

The Eugene Guard has the following: On Monday of last week Messrs. Lynch and Strange, and two hunters from Yamhill county, went up the McKenzie river on a hunting excursion. They returned on Monday, having killed 41 deer, a panther and a lynx.

The meeting of the Washington County Farmers' Club at Hillsboro last Saturday was well attended, and much general interest was manifested. A correspondent suggests "that the rule of limiting the speakers to a certain length of time at the meeting of the club be adopted, so that each one can tell what he knows, and let his neighbor have a chance to jaw back."

The Good Templars of La Grande are making preparations to build a temperance billiard room.

A man about forty years of age, who registered his name at the Occidental Hotel, Seattle, about a month ago as "Richard Fay, Philadelphia," and has been a guest of the house ever since, was found dead in his bed on Sunday morning, the 25 inst.

The British Colonel of the 23 has the following account of the evacuation of San Juan Island by the British garrison, and its surrender to the American troops: "H. M. S. Scout and Petrel arrived at Esquimalt from San Juan Island yesterday, having on board Captain Delacombe and family, Lieutenant Stuart and family, and the men comprising the British garrison at San Juan Island, and all the guns, ammunition and stores connected with that establishment. The barracks and commandant's residence were handed over to the American force at 2 o'clock P. M. Lieutenant Epstein, U. S. A., taking possession in the name of the United States Government. The flag, staff, from which the British ensign had floated for thirteen years, was cut down, a portion divided among the men, and a long piece brought around to the dock yard as a souvenir. The evacuation was conducted in a most orderly manner."

A fellow in Salem challenges all the fiddlers in Oregon and Washington Territory to a trial of skill for the championship of the North-west coast. He proposes to claim that he is champion unless some one "out squares" him in sixty days.

There are four school districts in Union county named respectively Dixie, Shanghai, Froty and Harlequinable.
