Notes From Brownsville.

ED. REGISTER:—Seeing that there appears to be a general inquiry in regard to the resources and advantages of the different localities in the Willamette Valley, not only from the East and new comers, but by the public generally, and believing that this part of "Old Linn" possesses many inducements both for the emigrant and capitalist, I propose through your valuable paper to note a few items which I hope will prove of general interest to all.

BROWNSVILLE
Is located on the Calapoosia river, twenty-two miles southeast of Albany, and six miles east of Halsey on the O. & C. Railroad, from which point to Brownsville there is a daily mail carried during the greater portion of the year, by a four-horse coach, over, I must say, a most detestably bad road during the rainy season. If there is any one thing that we need more than another it is a *passable* road to Halsey.

Brownsville, like most other things and places, has two sides to it; and as South Brownsville has not yet been able to convince North Brownsville, and vice versa, that one side is better than the other, of course my opinion would not be of much value in the premises. If South Brownsville says it is warmer here in Winter, North Brownsville says it is cooler there in Summer; and if North Brownsville says we can walk upon our pretty hills to view the fair surroundings and inhale the health-giving breezes, South Brownsville rejoins we have the level ground for a race-track, or for base ball practice; so taken together, you see, we can suit the taste of the most fastidious.

But as South Brownsville is Brownsville proper, it must first claim our attention. It is, I believe, one of the oldest settlements in Linn county, being located partly on the original donation claim of Alexander Kirk and James Binkley. Mr. Kirk sold his entire farm a few years ago, and now resides at Weston, Umatilla county, Oregon. Mr. Binkley still resides on his fine farm near town. The town contains three general stores, one of which has done a good, continuous business for twelve years past, while the other two are doing very well; we can judge by the amount of stock they carry—and I have not heard of a merchant ever becoming a bankrupt here. We have a fine district school-house, which cost about \$2,000, with a prosperous school in charge of Rev. W. R. Bishop. There are also four neat churches,—belonging respectively to the M. E. Church, Presbyterian, United Presbyterian and Christian denominations, each having a resident pastor. The M. E. Church, during the last season, erected a neat parsonage. The M. E. Church South also has an organized church here, with Rev. J. E. Bradley as pastor. The Cumberland Presbyterians too have quite a large membership, with Rev. W. R. Bishop as pastor. For some years past the M. E. Church has maintained a flourishing Sunday School, under the superintendency of A. E. Ellis, Esq., where it is a real pleasure to sit and listen to the various exercises, singing, etc., on Sabbath. In the way of industries, there are three blacksmith shops, one of which I hear is about to be a Granger sign; a cabinet shop, shoemaker shop, a butcher shop, millinery shop, and a comfortable hotel, and a livery and feed stable, the latter two being under the proprietorship of Mr. W. C. Baird. The town contains about four hundred inhabitants, and is without any saloon or doggerly whatever.

In my next I shall likely say a few words about North Brownsville.

NOTES BY THE WAY.

Passing along the foot-hills in the direction of Brownsville, the country presents a cheerful aspect, showing rapid growth and improvement in all the branches pertaining to agriculture. Brownsville, too, gives evidence of growth and advancement, and improvements of various kinds are to be seen in almost every part of the city. New buildings are being erected, sidewalks put down, and other marks of thrift, showing an abiding faith in the future of the city, and all adding to its size, beauty and convenience. An act passed by the last Legislature of our State, incorporating North Brownsville, has already been productive of good results, and N. B. is rapidly assuming the proportions and putting on the airs of a city. An excellent school, under the direction of Prof. Gilbert, one of the best educators and most finished scholars in the State, with an average attendance of eighty pupils, we believe, is one of the attractions of the city. The high moral and literary attainments of the citizens of Brownsville are due in no small degree to the efficient labors of Prof. Gilbert.

A series of protracted meetings have lately been held by the Baptists, resulting in great good and many accessions to the church. The other denominations formed a union, and held meetings also, which were attended with

fine good results, not only in adding to the membership, but in creating a better feeling of brotherhood and fellowship among the different churches represented. The Christian denomination at present are conducting a series of meetings, which are well attended, and it is to be hoped, will result in the accomplishment of untold good.

The holidays passed off very pleasantly here. The different Christmas trees, parties and social gatherings were well attended and heartily enjoyed. Among the most interesting of these gatherings, was the birthday party in honor of the eighteenth birthday of Miss Mary Leach, at the residence of Henry Kays, Esq., near the Ferry, on New Year's eve. A goodly number of the young and handsome daughters of Brownsville, and vicinity were there, and a merry and enjoyable evening was spent in "stripping the light, fantastic to the music's voluptuous swell."

EAGLE WOOLEN MILLS.
At this place, are doing a fine business, running on regular time and turning out slathers of all kinds of woollen fabrics of the best quality, which find ready sale in all the markets of the State—in fact, on the entire coast the goods from this factory stand A. 1, and command the highest price. The Company running the mills deserve the highest praise for their perseverance and industry, and their determination to put none but the best quality of goods on the market. By this course they have established a reputation for their goods, equalled by few other establishments and inferior are meeting their due reward.

Quite a number of citizens on the north side are making extensive preparations for planting hops during the coming season. This location has been pretty well tested in former years, and found to be excellent for hop raising. They mature without injury from blight or early frosts. A large crop of superior hops is confidently anticipated in this vicinity the coming season, and as the article is in demand and readily brings the cash, we hope their anticipations may be fully realized.

A SOUTH BROWNSVILLE
is on the west side of the Calapoosia, and is quite a lively place. Several dry-goods stores are located here, all of whom seem to be doing a good business and running large stocks of goods. A fine school is taught here by Rev. W. R. Bishop, which is in a flourishing condition, with an attendance of sixty or seventy scholars, and the promise of a steady increase. The residents generally seem to be prosperous and happy. The general health of the town and vicinity is very good, while other portions of the county are less favored in this respect.

Passing from this point to HARRISBURG.

A distance of sixteen miles plus x—(which means that the distance is altogether owing to the season of the year or the condition of the roads—at this season of the year the distance would seem much greater,)—on the east side of the road indications of wealth and prosperity abundantly abound. Everywhere farmers were busy improving their farms and making preparations for the coming seed-time, when an increased acreage will be seeded. On my arrival in Harrisburg I found business not overly brisk. One cause of the quiet in business circles was the absence of the steamboats which usually make regular trips up the Willamette, during the winter season, to this place. The *Olio* made one trip during my stay (the first of the season), carrying away about sixty tons of freight. There is, a large amount of grain, wheat, oats, etc., stored at this point, in the river warehouses, awaiting boats to carry it to market. Wheat is very low at present in this market commanding but 50 and 55 cents per bushel, and dull sale at that. The wheat rings here and at Portland have it all their own way, consequently business of all kinds is dull.

Here is another flourishing school, with about one hundred scholars in regular attendance. The following gentlemen were installed as officers: G. L. Malloy, W.C.T.; Lewis Fuller, W. S. M. If South Brownsville says it is warmer here in Winter, North Brownsville says it is cooler there in Summer; and if North Brownsville says we can walk upon our pretty hills to view the fair surroundings and inhale the health-giving breezes, South Brownsville rejoins we have the level ground for a race-track, or for base ball practice; so taken together, you see, we can suit the taste of the most fastidious.

But as South Brownsville is Brownsville proper, it must first claim our attention. It is, I believe, one of the oldest settlements in Linn county, being located partly on the original donation claim of Alexander Kirk and James Binkley. Mr. Kirk sold his entire farm a few years ago, and now resides at Weston, Umatilla county, Oregon. Mr. Binkley still resides on his fine farm near town. The town contains three general stores, one of which has done a good, continuous business for twelve years past, while the other two are doing very well; we can judge by the amount of stock they carry—and I have not heard of a merchant ever becoming a bankrupt here. We have a fine district school-house, which cost about \$2,000, with a prosperous school in charge of Rev. W. R. Bishop. There are also four neat churches,—belonging respectively to the M. E. Church, Presbyterian, United Presbyterian and Christian denominations, each having a resident pastor. The M. E. Church, during the last season, erected a neat parsonage. The M. E. Church South also has an organized church here, with Rev. J. E. Bradley as pastor. The Cumberland Presbyterians too have quite a large membership, with Rev. W. R. Bishop as pastor. For some years past the M. E. Church has maintained a flourishing Sunday School, under the superintendency of A. E. Ellis, Esq., where it is a real pleasure to sit and listen to the various exercises, singing, etc., on Sabbath. In the way of industries, there are three blacksmith shops, one of which I hear is about to be a Granger sign; a cabinet shop, shoemaker shop, a butcher shop, millinery shop, and a comfortable hotel, and a livery and feed stable, the latter two being under the proprietorship of Mr. W. C. Baird. The town contains about four hundred inhabitants, and is without any saloon or doggerly whatever.

In my next I shall likely say a few words about North Brownsville.
