

THE NEW TREATY WITH CHINA

The President has issued a proclamation announcing the ratification of the additional treaty with China, and commencing its provisions.

Article first provides that in making commissions to citizens or subjects of foreign powers of privileges of residing on certain tracts of land, or of resorting to certain waters of the empire of China, the Emperor by no means relinquishes his right of eminent domain.

Article second, provides that any privilege or immunity with respect to trade or navigation within the Chinese dominions of the United States, or their property, within its said lands, it is also agreed that the United States shall abstain from attacking offensively citizens or subjects of any foreign power with whom they may be at war, and the right of the Chinese Government over persons and property is retained, except so far as that right may have been expressly relinquished by treaty.

Article third, authorizes the Emperor of China to appoint Consuls at United States ports, who shall enjoy the immunities and privileges of the Consul of Great Britain and Russia.

Article fourth, guarantees to the citizens of the United States visiting or residing in China the same privileges, immunities and exemptions in respect to travel or residence as are there enjoyed by citizens or subjects of the most favored nations, and reciprocal privileges to the citizens of China in the United States. But the stipulation is not to be construed as conferring naturalization on either.

Article seventh provides for the reciprocal enjoyment by the citizens of the two countries of public educational institutions under the control of either, which are enjoyed in the respective countries by the citizens and subjects of the most favored nations, and gives the privilege of establishing and maintaining schools within the empire of China, at those places where foreigners are by treaty permitted to reside. The Chinese citizens are to enjoy the same privileges and immunities in the United States.

Article eighth says, the United States, always disclaiming and disavowing all practices of unnecessary dictation and intervention of one nation in the affairs of domestic administration of another, do hereby disclaim and disavow any intention or right to interfere in the domestic administration of China in regard to their construction of railroads, telegraphs, or other national internal improvements; and on the other hand his majesty, the Emperor of China reserves to himself the right to decide the time, manner and circumstances of introducing such improvements within his dominions, with this mutual understanding, that it is agreed by the contracting parties that if at any time hereafter his imperial majesty shall determine to construct, or cause to be constructed, works of the character mentioned within the Empire, and shall make application to the United States, or to any other Western Power, for facilities to carry out that policy, the United States, in that case, designate and authorize suitable engineers to be employed by the Chinese Government, and will recommend to other nations an equal compliance with such applications—the Chinese Government in that case protecting such engineers in their persons and property, and to pay them their reasonable compensation for their service.
