Biographical.

Templeton during the present year, and is now with her husband in Philadelphia, and Mrs. Thompson and her son expect to start back east to join them next week.

SNOWED IN.

A Perilous Trip in the Cascade Mountains.

S. W. Hinman, of Camp Polk, Wasco county, dropped in on us unexpectedly last Wednesday, and gave us an account of an experience he has just had in the Cascade Mountains which is the most perilous we have heard of for a long time. Mr. D. Shaffer, of Shedd's Station, started over the Lebanon road across the Cascades on the 7th inst., with a four-horse team and light wagon, and when he arrived at the Mountain House broke one of his axles. Knowing that Mr. Hinman was something of a wagon maker he went over to his place (about 50 miles) and got him to come back and help him out of his difficulty. They came back, and getting the wagon fixed, started up Seven-Mile Hill early on the morning of the 12th. At Snow Creek they got into deep snow, and at Hackleman's Pass found it about 3 feet deep. From there to the Lakes their axles dragged in the snow, and they didn't get in until away after dark, and the distance was only ten or twelve miles. Next morning as soon as it was light they started up Sand Mountain in a snow and rain storm. The horses labored very heavily in the snow and when they had made about six miles it became very plain that it was only a waste of valuable time to try to take the wagon further. They thought if they could make it to the open country around Big Lake about four miles distant, they would find less snow and could go on to Camp Polk easily, so they unhitched the horses and cast mounting one started on the snow. The snow was then so deep that it struck the large horse half way up the side, and the farther they went the deeper it became. The horses floundered so that they soon tired and the men had to change horses every few hundred yards. Not more than a mile and a half from the wagon had been made until the snow became so deep that further progress was impossible. Mr. Hinman's horse fell with him and when he got off on his feet the snow struck him high on his breast, which would indicate that it must have been between 4 and 5 feet deep. They then took the back track, and twenty yards away found their trail entirely obliterated by the falling snow. If it had not been that Mr. Hinman was a mountaineer of long experience and perfectly familiar with the country, there is no doubt but that they would have perished there, but after a severe struggle of several hours they arrived at the wagon. It was then almost covered with snow, but not wishing to lose it they hitched on their four horses and tried to turn it, but in doing this they could not move it. Mr. H. then dug in under the rear end of it, and fastened a chain to the hind axle, and hitching the horses to it and clearing the snow away from the wheels and pulling down hill they started it. By this means they got the wagon turned around, and getting the horses hitched up in good shape started down the mountain to the Lakes. Although they were now going down hill their labor was diminished very little as it had snowed heavily and caused timber to fall across their path. Fourteen logs were cut out of the way and they did not get down to the Lakes until several hours after dark. There they took charge of the deserted Fish Lake House and building a fire thawed out their almost frozen limbs. They were so much exhausted after their perilous tramp that their eyes were not closed during the night. Another thing that did not add materially to their peace of mind was that they still had one pass to get through before they could strike the Santiam and two days before when they passed through it the snow was 3 feet deep. The next morning they left the wagon and started on horseback, and arriving at the pass they were rejoiced to see that it had been raining there instead of snowing. Arriving at the foot of the mountain they had to go into camp one day to let the Santiam run down as it was too high to attempt to cross. On Sunday they got out of the snow and arrived at Mealey's, having been fighting their way through the mountains for seven days, with nothing to eat but potatoes. We have not heard of such a severe struggle for life for a long time, and are very much rejoiced that our two friends got out of their difficulty in such good shape. Mr. Shaffer returned to his home at Shedd's and Mr. H. came down here, four hundred miles from home with only a dollar or two in his pocket and a suit of clothing that would not bring much even in a second hand store. He has many friends here and they soon fitted him out.

Fire Notes.

As the late warehouse fire was the largest Albany has ever had, and has been the principal subject of conversation on our streets since, we will give a few items growing out of it. The size of the warehouse was 100x200. Farmers who had grain stored in the warehouse went to work after the fire and took out several thousand bushels. It was not worth much for anything but hog or chicken feed, and that kind of grain is cheap in Linn county this season. One man worked all day and sacked up a large amount of what which he expected to haul away next day. That night some one stole every grain of it. Allen McDonald, who owned the cultivator, we understand has sold them to Mr. Putnam. From the way in which that engine screeched the night of the fire we think it would pay our boys to sell their fire bells and buy a locomotive. A great deal of cheap talk has been going around in relation to the warehouse being insured too high, so we will give you the correct figures on it. Warehouse, \$5,200; machinery, elevators, etc, \$2,000; engine, \$650; engine house, \$150—amounting in all to \$8,000. The policy was carried in the Liverpool, London and Globe. Phil C. Schuyler, the adjuster for that company, came up this week and the loss was adjusted Wednesday evening. Gaston and Furry claimed \$7,800 and will get \$7,761. They will be paid in full on the warehouse, \$1861 on the machinery, \$600 on the engine, and \$100 on the engine house. The money has not been paid yet, but will be inside of the next two weeks. The stench produced by the burning oats in the fire has been fearful, and the wind carrying it into the lower part of town, all the people down there had to go visiting. On Saturday the engine was taken out to drown out the fire, but just as the hose was laid the wind changed to the north, so our boys and A. Ward says of the fire company which came to his house when his twins were born under the impression that his house was on fire, "kindly refrained from squirting." Ad Edgar's stock of ale and porter was saved from the Centstock fire last Fourth of July and stored in the warehouse. The hose boys saved it this time, but in some way it was lost soon after.
