INDEMNITY AND ENLAWMENT.

A Chinaman Put in a Hog Pen by his Countrymen and Left to Die. Last Sunday morning a Chinaman came to Marshal Hill and informed him that another Chinaman, living in the back part of the old Chinese barracks in the rear of Sanders and Stenberg's store. Mr. Hill went down and found that it was so. There the poor heathen laid, in a part of the building which had been used as a hog pen, without any bed, or in fact anything over or under him but his own scanty clothing. Aid arrived too late, and the poor unfortunate fellow miserably perished from disease and exposure a few moments after he was discovered by the Marshal. It was soon ascertained that he had been lying ill at "Little Jim's" window for some time, and not getting better that Chinese dignitary and one of his men carried him down to this pig pen in the rear of another Chinese den, the evening before, and left him there to die. Coroner Davis suspended a jury, consisting of the following persons: Geo. Humphrey, E. R. Skipworth, R. A. Stratford, I. G. Deany, B. W. C. and J. L. Hill, after examining the body testified that the death of the deceased was caused by dropsy of the heart, which had been hurried to the fatal termination by exposure, and the jury rendered a verdict in accordance with this testimony. The body was buried on Sabbath afternoon, by order of the Coroner, but not a single Chinaman attended.

THE LITTLE JIM.

It is reported that a Chinaman testified to the circumstances stated above, and Dr. J. L. Hill, after examining the body testified that the death of the deceased was caused by dropsy of the heart, which had been hurried to the fatal termination by exposure, and the jury rendered a verdict in accordance with this testimony. Death of H. G. Olliver.

Many of the citizens of Oregon and Washington territory will remember Mr. H. G. Olliver, who came to Oregon some time ago as organizing officer and deputy grand master of the Ancient Order of United Workmen. From a Portland paper we learn that after doing the work of the order he returned to his home in California, and was attacked by malarial fever. He was taken to Brooklyn where the best medical aid attended him, but in vain. He died about one month ago, and his children's widow has the heartfelt sympathy of thousands of brothers in her sad bereavement.

A Fatal Accident.

The Hartsburg News says that Wm. Farver, an old man about 65 years of age living on the island below Hartsburg, on the old Ingram place, was instantly killed on Tuesday, the 16th inst., while digging potatoes in the field near his house. The wind was blowing strong and broke off the top of a balsam tree, near where he was at work. In trying to avoid the tree it struck him on the head, making in the skull and breaking his neck. He was a sober, industrious citizen, and leaves a wife and six children to mourn his sad and untimely end.
