TEACHERS INSTITUTE.
THURSDAY AFTERNOON.
Prof. Bell opened the subject of Proportion, on which a long discussion ensued, arising from a misunderstanding of the term "answer".
Geo. M. Paul delivered a short and pointed address on Denominational Numbers.
An essay on Temperance prepared by Miss Elizabeth Miller was read by Nellie Powell. Miss C. being unable to be present.
Miss Irene Cranfill read an excellent essay on "Inducements to study," which showed considerable thought.
Mr. C. C. Hogue presented the subject of History in the absence of Mr. Wertsbaugh, to whom it had been assigned. He taught topically and used charts to aid memory of pupils. He illustrated this by hearing a class of his own.
Prof. McElroy, of the Corvallis Agricultural College read a splendid paper on "School Government." Prof. Emery spoke on the same subject in a humorous vein. He is in favor of spilling the red ink and not sparing the child.
THE ENTERTAINMENT.
The entertainment held at the Y. P. C. A. Hall Thursday night for the purpose of defraying the expenses of the Institute was a fine affair. The Hall was completely crowded, with a very intelligent class of people who seemed to sympathize with the different participants in their ambition to excel, for as they were supposed to be the best from Salem, Corvallis, Scio and Albany, there was considerable feeling in the matter.
The exercises opened with music by the Magic Spell Orchestra, after which Miss Nellie Powell recited "Parrhasius and the Slave" in a careful, masterly manner, only marred by evidences of a severe cold. It was one of the best efforts of the evening. She was followed by Miss L. Johnson, of Scio, who recited "Asleep at the Switch." She has a dainty, nervous style, and lacks the deliberation which makes a recitation effective; but nevertheless has a way that is quite interesting.
Miss Annie Powell, of this city, sang "Sing Sweet Bird," very sweetly. In answer to an encore she sang "No, Sir, No." in splendid style, and better if anything than the first. Miss Bertha Neugass, of Corvallis, appeared with the aesthetic sunflower in her belt and recited "Absalom." She has probably the best voice of any of the speakers, but lacks that control of it which makes the eloquent.
Miss Jessie Taylor, of Corvallis, sang "Whispering Willows" and in answer to an encore she sang "The Goodbye Song." She has a fair voice, but a very bad habit of keeping time with it with her body. Miss Hattie Miller, of this city, recited "O'Connor's Child," and sustained the splendid reputation she has obtained. Her reading would be even more effective than it is did her voice have more volume. After music by the orchestra, Miss Ida Burnett, of Corvallis recited "Mr. Arp on the Rack," which shows her to be a complete master of comedy. Miss Olive Chamberlain, of Salem, sang "Tender and True," and of course was much enjoyed. She answered with "Twickenham Ferry," and probably carried off the musical honors of the evening.
Miss Jessie Taylor's rendition of the "Ballad of Shandy," was very good, and would have been better if it hadn't kept motion with the bells. Miss Belle Lawrence, of Salem, was expected to do something more than ordinary, and indeed she did. Her rendition of "Red Jacket," was fine, and entitled her to the praise she received. Miss Lawrence's gestures are perfect; but she lacks expression to the face and roundness of voice.
The entertainment closed with music by the Orchestra, which has obtained a good reputation by its fine playing during the whole Institute.

After prayer by Rev. Dillon, Miss Gilbert recited some good music. Mental Arithmetic was taken up by Sept. Gilbert, as teacher and the Institute as pupils.
The name of Mrs. S. B. Train was placed on the committee on resolutions.
Supt. Powell insisting on his right to run the financial part of the Institute, the Finance Committee, consisting of Messrs. Hogue, Marks and Archibald, resigned, or asked that their names be stricken off.
Rev. J. W. Harris presented the subject of Moral Culture in an able manner, presenting methods, etc. Prof. Miller, of Corvallis, presented the subject of Public Schools in a manner understood by all.
Normal Institutes was discussed, and the following persons consented to attend if one were organized: C. C. Hogue, J. L. Gilbert, T. C. Bell, D. V. Reid, Miss R. Alexander, Miss N. Green, Miss V. M. Kane, S. J. Paul.

General expenses, about \$40 (perhaps a little less) Magic Spell Orchestra, \$20; leaving a balance of about \$32.50 in the hands of the new finance committee.

Was it Sailed?
The stage from Corvallis last Thursday brought among other passengers a man about thirty years of age, about 5 feet 6 inches in height, with light hair and mustache, and dressed as a laborer.
About eight o'clock in the evening he was arrested for drunkenness and locked up in the calaboose. The next morning it was ascertained that he was in a dying condition from the effects of a dose of laudanum which he had probably taken the night before, as he is known to have purchased some at one of the drug stores at about 9 o'clock in the evening. He died at about 9 o'clock Friday morning. Dr. J. A. Davis, Corvallis, called a jury, which after a proper examination rendered the following verdict:
We, the jury believe the deceased to have been killed by the name of Frank Wilson, and that he came to his death at Albany, Or., on March 31, 1932, from the effects of opium poison administered by himself.

In the man's pocket were \$2.29 and a pocket book, in which was the name of Frank Wilson, which is "posed" to have been his name, and some who saw his corpse thought they recognized him as one who once lived here by that name. There was also a picture of a young lady reading in the pocket, which may serve to identify him. The body was buried Saturday at 2 o'clock.
Mrs. Powell's spring opening will occur next Wednesday, when she will expect to see everybody present, as it will be one of her best.
