The crop reports from France, Holland, Germany and Southern Russia continue to be favorable.

We hope our Legislators will attend to the matter of providing for the building of a fish-way at the Willamette falls at the next session.

AGENTS of the Northern Pacific Railroad are in Sweden organizing a colony of 6000 people to settle on lands along the line of the road.

The announcement is made by the President of the Baltimore and Ohio Railroad Co., that still another Atlantic cable will be laid to Europe to connect with the Baltimore and Ohio Railroad telegraph system.

CONGRESS has postponed action in relation to the proposition to abrogate the Hawaiian Treaty until December, and the people of the Pacific coast must remain at the mercy of a monopoly in San Francisco for another term.

With the changes made to date, and counting the gain of one Senator in this State, and one in Illinois, the next Senate will stand 38 Republicans to 56 Democrats, with 2 Readjusters. Republican ascendancy is thus assumed in the Senate until 1885.

BY THE new criminal code for the State of New York, which goes into effect the 1st of next December, swearing is punished by a fine of \$100 for each offense, and the utterer of a profane oath within hearing of a magistrate may be sent to jail for ten days.

SERGEANT MASON, who tried to shoot Guitau, writes from the Albany Penitentiary to a Cleveland sympathizer: "I am in good health, thank the Lord, and am trimming shoes the best I can. I am treated very well by the officers of this prison, yet I would like my liberty, and I will shoot no more only in defense of my country."

THE North Carolina Republicans, in their State Convention last month, endorsed the nominations made by the Liberal party, and took strong ground against all measures of liquor prohibition. Northern Republicans try to make us believe that theirs is a prohibition party, but this does not look like it.

An edict signed by the Czar and published in the official Gazette of St. Petersburg virtually bankrupts every wealthy Jew in Russia. It provisionally suspends all payment for contracts or debts due to Jews, prohibits them from settling outside towns and villages, and otherwise provides for their speedy extirpation throughout Czarland.

SENATOR TELLER, of Colorado, who has been made Secretary of the Interior, is the first person in that office for a long time who knows anything about taking care of the Indians. He is rapidly disarming our red brethren, and Gen. Forsythe, the famous Indian fighter, says that good results are already visible.

On the 20th of June Queen Victoria completed the 45th year of her reign—a record which has been excelled by only three English sovereigns—Edward III, with 50 years; Henry VIII, 56 years; and George III with 60. Queen Victoria has been surpassed in age by eleven English sovereigns since the Norman conquest.

With that kind of a law in Oregon rigidly enforced, we could soon pay off our State debt, finish up our State House and Insane Asylum, buy the Willamette Locks secure the services of Jess Irvine to revise the code and do considerable other financial business of considerable moment to the taxpayers. We recommend the scheme to our newly-elected Legislators.

This week the newly elected county officers entered upon the discharge of their duties. We have only a kind word for those who have just retired "to the shades of private life." The retiring Clerk, Sheriff, Treasurer and all, have made efficient and accommodating officers, and we will be the last to say aught against them because they differ with us in politics. So long, however, as we have just as competent men in the party whose principles we advocate, it will always be our endeavor to defeat our republican brethren at the polls, not "because we love Casses less, but because we love Rome more."

This occurrence by the House in the Senate amendment to the Army Appropriation Bill, making it compulsory for all army officers to retire at the age of sixty-four, gives General Sherman about two years more of active duty as General of the Army. He will retire under the provisions of the Bill February 8th, 1884, when he reaches his sixty-fourth year. Major-General Irwin McDowell will be retired on the 1st of December next, and succeeded by Major-General Schofield in command of the Military Division of the Pacific. As the new law does not repeal existing laws it is still optional with the President to retire an army officer when he reaches the age of sixty-two. The officers of the navy now ask that the compulsory clause affecting their retirement may be extended from sixty-two to sixty-four years.

RAILROAD MONOPOLY.

In a comparatively young state like Oregon, where the building of railroads is essential to the rapid growth of the country, people are, as a rule, afraid to exert themselves to check the power that gradually centers in great railroad corporations, for fear of putting some stumbling block in the way of the development of our resources by doing some injustice to the railroad corporations. The New York Journal of Commerce tersely says:

"Persons engaged in trying to curb the railroad power need not be afraid of going too far. They do not and will not go far enough. That is the danger. All men who approach the railroad question from the anti-monopoly side are apt to be over-timid and conservative. They fear to do something rash and injurious to the rights of railroads. They may calm their anxieties now and forever. The railroads are perfectly competent to take care of their own interests, and will not suffer from the extreme measures proposed by the radical reformers. 'The man who aims at the sun may hit the moon,' says the proverb. Starting out to accomplish certain great results in railroad legislation, we may obtain but little in comparison with our aims. But we shall get some security for the public as the result. For that—whether little or much—we shall continue to strive."

The remarks of the Journal of Commerce are peculiarly applicable to the situation in this State. The people are in the hands and at the mercy of the one great railroad corporation that owns and controls all the avenues of our state commerce. As it has been, by public and private land grants, as well as by private subscription, it, nevertheless, has the effrontery to exact the most exorbitant rates for freight and carriage from all who, from force of circumstances, are compelled to patronize it. It has boasted through its president, that it has, so far, kept out of all competing lines of railway, and boldly announces its intention to continue to do so in the future. In furtherance of this design, it has succeeded in buying out the only competing line in the Willamette Valley, and when those, who so ignominiously sold out their birth-right for a mess of pottage, are upbraided for their treachery to the people along their route, they cry out with righteous indignation that theirs was no sale, but simply a lease of its privileges and franchises for a term of ninety-nine years! Through its lobbyists and hirelings, it has endeavored to frustrate and defeat all legislation intended to put down its oppression, whether such legislation be direct or for the encouragement of other railroads. It endeavors to insinuate itself into the good graces of every branch of our state government, by tendering free passes and unlimited privileges to those in public life—or is the sacred shrine of our judiciary let alone from its insulting blandishments.

It controls newspapers and newspapers, and the names of its officers and paid attorneys are prominently mentioned in connection with the Senate of the United States. With all these facts staring the people in the face—facts too, that are susceptible of proof—it seems to us that the time has come for decided and united action on the part of those most seriously affected. The farmers, who are the bone and sinew of the nation, are the greatest sufferers by this licensed robbery, because out of their hard earnings must eventually come the money that goes to make up the enormous dividends annually declared by this great railroad corporation. The next legislation will be composed in great part of those engaged in agricultural pursuits, and it will be with them, and with those who will stand by them through thick and thin, to remedy the great evil imposed upon them by the present system of railroad charges. Let the members of our Legislature but act together, determined to regulate railroad freights and charges and all will be well. THE CROPS. The present indications are there will be a partial failure in the wheat crop in the Willamette Valley this year. Especially is this so in Lewin county. Here, the wheat there was so on in the fall, suffered in many places on account of an unusually severe winter. A late spring prevented the farmers from getting in an early spring crop, and the late grain has been damaged by dry weather. The Oregonian several weeks since placed the surplus yield of wheat for export in Western Oregon at 230,000 tons for this present year, whilst the Farmers place it at 100,000. At present the better opinion is to be a nearer estimate. The surplus the past year was only about 120,000 tons, and basing our estimates on information received from various parts of the valley, we have reason to fear that there will be a considerable falling off from last year. This may be compensated for in part by better prices, and cheaper freight rates. The California crops are likely to suffer more from drought than those of Oregon, and the probabilities are that there will be no difficulty in procuring charters at more reasonable prices than last year.

PRESIDENT ARTHUR'S COMMISSION.

As was anticipated, the commission appointed by the President for the purpose of revising the present revenue system, consists in the main of men who are supposed to be special advocates of protection, and high tariff, and the people can expect no relief at their hands. Instead of selecting men who stand as the representatives of the interest, most injuriously affected by the present high tariff, he has seen fit to appoint a set of political dead-beats, and party tramps, who represent no business enterprises whatever. Selected, as these commissioners have been, without any regard to their fitness for the duties to be performed by them, without more than the mere shadow of geographical distribution in their appointment, what good can be expected to result from this packed commission? Congress disgracefully shifted the responsibility of revising the revenue system upon President Arthur, and he, inasmuch as he does not expect to enter the race for a second term, willfully abuses the powers vested in him by the act, and appoints such a commission as will subvert his wishes, and not those of the people.

The enormous revenue raised by the government is far in excess of the amount actually required, and there can be no reason to overburden the people with taxation.

If Congress continues, session after session, to carry on a sort of school-boy flirtation with such legislation as is most needed to curtail the expenses of the government and to reduce the enormous rates of taxation, then the best thing it can do is to appoint a board to invest the surplus funds that are accumulating in the treasury.

There would be as much sense in the appointment of such a board, as there is in some of the commissions provided for by congress, and more good would likely result from it than will ever be accomplished by the tariff commission.

THE END.

One week ago to-day, Charles J. Guitau expiated his crime upon the gallows. When we consider the consequences of his act, we cannot but think that his punishment has been long delayed. The taking of Garfield's life was, in itself, no greater crime than the taking of the life of the humblest citizen; but the assassination in cold blood of the chief magistrate of fifty millions of people was a national calamity; nor can the cost to the nation ever be estimated. By Garfield's death, the whole administration of the affairs of government was changed, and a policy adopted by a new president and a new cabinet that is likely to sow the seed from which will spring many more of Guitau's ilk.

The execution of Guitau will not compensate for the loss of the chief magistrate, but it will serve as a reminder to those who may hereafter seek such notoriety as was sought by Guitau, that the government will still live without bloodshed, even though deprived for a time of its chosen head.

It is the pride of American institutions that the governing power rests in the people, and not in one man, and in two critical periods of the nation's history this principle has been put to the severest test. Though by reason of the law's delay, the punishment of Garfield's murderer has not been as speedy as was that visited upon the murderer of Lincoln, it is certainly as complete, and Guitau will only be remembered as the cowardly assassin of J. A. Garfield.

THE Jews are still being driven from Russia, the bitter feeling against them remaining unabated. The word Jew would seem to "sink in the nostrils" of the Muscovite. From cities, towns, villages, the Israelites had to depart taking with him his family and household goods. In cases too numerous to mention, he is ruthlessly plundered and set adrift in the wide world without a ruble. From one city, Balta, no fewer than ten thousand were expelled, and this is but an index to the work of extermination that is still going on. The Russian ones roused from the apathy of Yodky are a dogged, determined race, and once in possession of an idea they work it threadbare. The idea of exterminating the Jews is now uppermost and it will take some time to allay the inflammation in the Muscovite mind.

BISMARCK has certainly been taking lessons from some of his American cousins, as he is getting to be the prince of monopolists. His last effort was to secure the passage of a measure lodging in the Government the entire control of the purchase and manufacture of raw tobacco, of the whole of the manufactured tobacco throughout Germany, and giving him the right to determine annually the amount of tobacco to be planted, the method of cultivation and delivery etc. The German Reichstag sat down upon his little scheme by a vote of 276 to 43.

The annual meeting of the Society of the Army of the Potomac was held in Detroit last week, and was very largely attended. The stated report was delivered by General E. S. Bragg, of Wisconsin, who made an elaborate defense of General McClellan's organizing abilities and military skill, praised Fitz John Porter, and incidentally strongly condemned General Pope and Secretary Stanton.

LEBANON NOTES.

LEBANON July, 5th, 1882.

Ed. Democrat: On last Monday G. W. Smith, who has been Justice of the Peace for Lebanon precinct for the last four years, turned over his docket to G. W. Cresson, Justice of the Peace, and during his entire term has given very general satisfaction. Being a man of good judgment, combined with more than ordinary knowledge of law, he was able to decide in such a way as to leave little ground for complaint. Among his last official acts was the uniting in marriage of A. Giesler and Miss Kate Brown. The wedding took place in Lebanon in such a happy way that the parties were indeed sorry that the knot had not been tied long before. He retires from office with no stain upon the robe of justice, which he has so long worn, and which fits him so well.

A rather serious accident befell Hoff Hiatt a few days ago. Having occasion to ride a short distance, he mounted a horse, and, thinking it hardly worth while to bridle him, proceeded on his way. He had not gone far when the horse became frightened, and started to run away. In trying to hold him, he lost his balance, and was thrown upon his left shoulder, which dislocated the shoulder blade. Dr. Foley was called upon, and set the bone. Two weeks rest is the result of trying to ride a horse with simply a halter, besides a doctor bill with the usual amount of pain.

For more than a month the citizens were getting everything ready for the celebration of the Fourth of July. Preparations of an extensive kind, and expense without stint were made. As the day approached, the details were more fully arranged and everything seemed favorable for a good time. Nothing seemed lacking except a bright day to make it successful. You can imagine the disappointment, when, as the day dawned, the Oregon mist began to descend, and, as the people poured in the rain poured down. It looked gloomy after so much preparation, and yet there was a feeling that no better Fourth was ever enjoyed after the long dry spell than to listen to the falling music of the pattering of the rain. The attendance was very large, even under the discouragement of the weather, numbering nearly 1500. The exercises, instead of being held in the grove, were conducted in the afternoon in the square. The bands from Albany opened with an appropriate piece, after which the choir followed. The chaplain then offered prayer, when Hon. W. R. Blyen, in a clear and impressive manner, read the memorable Declaration of Independence. The day closed with a brilliant display of fireworks, also with a grand ball at the Bona ball. The best of order was maintained and great credit is due the marshal as well as the President of the day for the successful manner in which they discharged their duties.

Ordinance No. 116.

An ordinance of the City of Albany relating to taxing dogs and regulating their running at large.

Be it ordained by the Common Council of the City of Albany: Sec. (1.) That section 1 of an ordinance relating to taxing dogs and regulating their running at large, be amended so as to read as follows to-wit: Every person owning or keeping within the city of Albany any dog or dogs, shall pay a yearly tax of one dollar on each dog so owned or kept; said tax to be paid to the City Treasurer by August 1st of each year; and if the owner or keeper of the dog or dogs shall fail to pay said tax, he shall be liable to the City Treasurer for the sum of fifty cents as compensation for his services for such collection; provided, further, that each dog or dogs owned or kept in the city limits shall be taxed the sum of \$2 and if not paid by August 1st of each year, that the Marshal shall collect the sum of \$3 and be allowed to retain \$1 for his services. Sec. (2.) That ordinance to take effect, and be in force from and after the date of its publication.
