

Dorsey is ready for another Indiana deal.

Morrison of Illinois, heretofore classed as a free trader, comes out squarely for a tariff for necessary revenue.

There is a big ditch that intersects the road leading to the Presidential fall of 1884, and either party is liable to fall into it.

Labor troubles are becoming more numerous in the East, and protection does not protect.

The French are having trouble with the Annamites and the English are having trouble with the Dynamites.

Under the new tariff Chinese goods are to come in free. This is another "infant industry" nipped in the bud.

It is hinted that as soon as all of Mahone's demands are complied with President Arthur will issue a thanksgiving proclamation. The date is not yet fixed upon.

Indiana is a pretty big State, but scarcely large enough to accommodate the booms of McDonald and Hendricks at the same time.

The thieves who stole the Presidency for Mrs. Hayes' husband will never be able to do it again for any one else.

The Western cyclone continues its activity, and that reminds us that the greatest of them all will come out of the West in November, 1884. Prudent Republicans will keep out of its path.

Senator Sherman sounded the Republican keynote of the Ohio campaign at Marysville, the other day, and its discordant noise resembled a brass band with the bronchitis.

Senator Slater was serenaded a few evenings since by his many friends in Portland. The Senator is justly held in high esteem by the people of Oregon without regard to party.

The Oregonian, with a reckless disregard for consistency, criticizes the Democratic party for not having the courage of its convictions on the tariff question claiming that the party professes one thing and practices another. The Oregonian, if it were candid, would inform its readers that the Democratic party has had no opportunity of making a practical application of its tariff views for twenty-two years. It would be folly in the extreme for the Democratic party in the lower House of Congress to pass a revised tariff law knowing that it would never pass the Senate, and that it would meet the Presidential veto, even if it should pass the Senate. But how is it with the Oregonian? While claiming that the whole tariff legislation of the Republican party is iniquitous and an outrage upon fair dealing and common sense, yet as often as our election for congressmen takes place, so often does the Oregonian enter the political field and use its influence to elect the very men who support and maintain this iniquitous legislation.

JUDGE HOADLEY.

This gentleman was nominated last week by the Democrats of Ohio for governor. The nomination in point of ability and personal worth is the best that has been made in that State by either party for many years. Mr. Foraker, the Republican nominee, was not known outside of the State, nor in fact but little outside of his own county at the time of his nomination. The Democrats are very sanguine of success. Their platform reaffirms the principles of the party as expressed in the primaries, state and national platforms in regard to personal liberty and true functions of the government of the United States as embodied in the political creed expounded by the great founder of the Democratic party, Jefferson. The application of these principles demands purification of public service, the punishment of robbers of the public treasury, the equalization of all public burdens, the arrest of profligacy and extravagance that corrupt the administration of public affairs, and a total change in the policy that has been so long pursued by the Republican party, favoring individual and class interest at the expense of the laboring and wealth producing people of the country; and we reannounce our previous declarations for staple money, the gradual extinction of the public debt, and the payment of pensions to disabled soldiers and their widows and orphans.

Favors a tariff for revenue, limited to the necessities of the government, economically administered and so ad-

justed in its application as to prevent unequal burdens, encourage protective industries at home, and afford just compensation to labor, but not to create or foster monopolies.

The act of a Republican congress in reducing the tariff on wool, while at the same time increasing it on woolen goods already highly protected, was iniquitous legislation, discriminating in favor of monopoly and against an agricultural country, and ought to be corrected.

The Dem. party is and always has been opposed to any summary legislation and unequal taxation in any form, and is in favor of the largest liberty of private conduct consistent with the public welfare and the rights of others, and of regulating the liquor traffic and providing against the evils resulting therefrom by a judicious and properly graded license system.

The comments of the press are generally very flattering to the ticket. The New York Herald, (Ind.) in speaking of the manly way the convention did its work, says that the Democrats have made a platform on which sensible citizens desirous of honest government can stand. They have nominated a man upon whom they fairly and fully rely to carry out their policy. Hoadley is an able and honest Democrat in the true sense of that word. The work of the Democratic committee yesterday seems solid, and is of very great importance to the convention. It compels thorough discussion of the tariff question, which is very necessary for the enlightenment of voters. It shows that in a most important canvass, on which the presidency may easily depend, that the Ohio Democrats have the courage and knowledge to place themselves on a sound policy, and the shrewd sense, at the same time, to state those policies too clearly for their opponents to successfully misrepresent them. The nomination of Hoadley completes the work. He is not an amateur. He is a man who understands political principles and politics, and knows how to explain them to voters.

WOOL AGAIN.

We showed last week that if the decline in the price of wool is to be attributed to the reduction in the tariff duties made by the last congress, then the Republican party is responsible therefor, as the law passed both houses almost exclusively by Republican votes. But we believe that the price of wool is regulated, as the prices of all other commodities, by the law of supply and demand. The Boston Advertiser, a leading Republican journal, in an article on the decline in the prices of woolen goods says that there are undoubtedly more sets of cards in New England not being operated than being operated. This indicates conclusively that many woolen mills are shutting down, that depression in that industry is not idle talk, that the reduction in wool must represent over one hundred thousand sets of cards, which would consume three million, two hundred and ten thousand pounds daily. Some mills which are reported running on full time may shut down later if the dry goods market does not improve, and some mills have increased the production of goods and are still working full time.

Herein lies the immediate cause of the decline in the price of wool. The market for woolen goods is very dull. Hence mill owners cannot afford to run their mills to manufacture an article of which the market is already overstocked. And as mills shut down, dealers in wool stop buying, and thus, as the demand for wool decreases, the price of wool decreases. All of these economic conditions in trade are as likely to arise under a protective tariff, as under a tariff for revenue. These facts prove the folly of attempting to bolster up the price of any commodity by a high protective tariff. The immediate effect of a high tariff, as a rule, is to appreciate the price of the protected commodity, but the ultimate effect is universally to depreciate the price of such commodity. For a high rate of duty on a commodity will prohibit, more or less, the importation of that commodity from foreign ports, which reduces the supply. As the supply decreases the price increases. But as the price goes up a greater number of persons will engage in the production of that commodity because it will pay. As the number of producers increase the supply will increase, and as the supply increases the price decreases and often falls below the price which ruled before the high duty was laid. Then there is a panic in the trade and thousands of dealers, manufacturers, and producers, are financially ruined. This is the inevitable result of high duties. Thus all trade in a highly protected article is always either feverish or lifeless. The price is either at a speculative point or down to a ruinous point. It would be well for every voter in the land to look at these facts with unprejudiced eyes. The only object we have is to lead people up to a correct solution of this great economic problem. The best interests of the whole country should always be kept in view.

New Money Order Regulations.

On and after July 2nd, 1883, a single domestic money order may be issued for any amount from one cent to one hundred dollars inclusive. Three orders may be issued to the same remitter in favor of the same payee in one day. The fees charged for orders will be as follows:

For orders not exceeding \$10 and not exceeding \$15—10¢
For orders exceeding \$15 and not exceeding \$20—15¢
For orders exceeding \$20 and not exceeding \$30—20¢
For orders exceeding \$30 and not exceeding \$40—25¢
For orders exceeding \$40 and not exceeding \$50—30¢
For orders exceeding \$50 and not exceeding \$60—35¢
For orders exceeding \$60 and not exceeding \$70—40¢
For orders exceeding \$70 and not exceeding \$80—45¢
For orders exceeding \$80 and not exceeding \$90—50¢
For orders exceeding \$90 and not exceeding \$100—55¢

The Game Law.

After the first of July male deer can be shot under the new game law, but female deer or does can not be killed until the first of August, and female at no time. Elk, moose and mountain sheep have to be left to graze on their mountain home until the first of August. On and after the 15th day of July grouse, pheasants, quail and partridges may be shot, but not until the first of September is it lawful to attack the poor, innocent, wild swan, mallard duck, wood duck, wildgeon, teal, spoonbill, gray black, or sprigall or canvas back duck.

The laws have been regarded much better than was expected, so that at the times mentioned our hunters will be excused for spreading shot in a festive manner.
