WHAT WE THINK.

The *Williams Farmer* asks us what we "think should be done with money when real estate is assessed at one-third its value." Why, bless your soul, we would still assess money at its value and insist on assessors valuing real property at its reasonable worth. This is what our law requires, and this is what we would insist upon being done by the assessor.

The assessor takes an oath to assess property of all kinds at its cash value. Public morals, good conscience and fair dealing all require that he should faithfully observe the law. If it be true that an evil exists in the manner of making assessments by discriminating against capital and in favor of real estate, then every good citizen should lend his influence to correct this evil. Is this evil to be attributed to the law? We say not, for the law requires that real estate shall be assessed at its full value. Hence, it is folly to talk of repealing the law for the purpose of correcting this evil. The evil, if it exists, springs from the manner of enforcing the law, and not from the law itself. Our friend of the *Farmer* would violate the law a second time to equalize the results of its first violation. We would insist upon its full enforcement to bring equality of taxation. If real estate is assessed at less than its value, then the way to correct the evil is to require assessors to assess lands at their full value, instead of asking assessors to violate their oaths a second time by assessing money at one-third its value. Every one concedes that if our present laws of assessment and taxation were enforced and carried out in letter and spirit there would be no cause for complaint from any one. If to be in favor of equality of taxation among all citizens, the holders of real estate, the money lenders and all property holders, subjects us "to the charge as made by the *Farmer* of unworthy journalism, then indeed do we plead guilty to the soft impeachment. To say that we are pandering to prejudice when urging that all property shall be taxed equally, (which every doctrine the *Farmer* says is a good one), is indulging in a species of unworthy journalism, which we have no desire to imitate. But if our course should unconsciously be biased at all in the matter, we should prefer it to lean rather to the interests of the great body of tax payers, than to the interests of a few money lenders and moneyed corporations. But we would have justice done all parties, by taxing all property up to its value.

The *Farmer* says that money cannot be had at all on real estate anywhere in Oregon. Now the records of every county clerk's office in the state will contradict this statement. We have no objection to the repeal of the mortgage law, if, in its stead, a new law shall be enacted, which will more nearly secure an equal and equitable assessment of all the property values of all tax payers in the state. As an evidence of the propriety of the present law we notice that many men's taxable property has increased from one-fourth to one-third over that of last year, thus, doubtless, disclosing to the assessor much property not heretofore brought to his knowledge.

As we understand the position of farmers and land owners on this subject, it is that when all money, notes, accounts and other representatives of value are submitted to the assessor and assessed under the law at their true value, then fair dealing, justice and public policy will require land to be assessed as what it is worth. It is a matter of wonder as well as regret that the *Farmer*, which is supported largely by land owners, should take a position on this tax law question in such sharp and radical antagonism towards those who are only asking that justice be done to all tax payers. It is not to be wondered at that the *Farmer* deems it necessary to inform its readers that it is not under the influence of railroads and other moneyed corporations.

TEACHERS MEETING.
We are informed by those who were present that the teachers and director's meetings held at Lebanon last week were abundantly successful. About 60 teachers attended the teachers' institute, and 30 directors the director's meeting. Much interest was awakened in behalf of our public schools. Supt. Moore is throwing much energy into this work, and deserves much credit therefore. The teachers speak in words of praise of the genuine hospitality of the citizens of Lebanon. We knew when the meeting was appointed, at that place that the hospitality of her citizens would be a success.
