Calixto Garcia at Jignani and Zarzal, Angel Mestre and Antonio Bello at the Bermeja, the defeat of Montaner at Caonao, the capture of the forty-two recruits on the road from Canto to Bayamo, the seizure of many a convoy, give sufficient proofs that the insurrection in this its fifth year has gained ground .-And this, notwithstanding that we are told from day to day by the is land press that the insurrection is expiring, the war still keeps on, and we find the contending parties, in the third period of its history, and after five years' of fighting as far from peace as the day the standard of . rebellion was raised at Yara.

LATE NEWS.

PARIS, Nov. 26 .- The following dispatch bas just arrived in cipher from the New York Herald's correspondent in Madrid: The situation is a grave one. On the 19th instant General Sickles, by order of President Grant, delivered the formal ultimatum to President Castelar, demanding prompt and vigorous reparation for the insult to the United States flag, indemnity to families of the murdered, and punishment of the murderers, and also a guarantee against further outrages in Cuba .--The demand was couched in kind and sympathetic tone, but no alternative was given and General Sickles was also instructed to say that if Castelar dil not comply with the demand in a week he should ask for his passport and leave Madrid with the Legation. The time expires to day and no answer has yet been received .-Everything at the Legation is pack. ed ready for immediate departure .--Sickles has no hope that the ultimatum will be complied in. He telegraphed to Paris yesterday to have all his official correspondence that might be there kept for a few days. General Sickles in conversation said he did not see how war could be avoided, as Castelar can give no assurances that his orders will be obeyed in Cuba. Public feeling is also opposed to concession. Unless Castelar responds this evening General Sickles will leave immediately. All American ships in the Mediterranean have been ordered to Key West. In the event of Gen. Sickles leaving, the British Minister will probably protect the archives and American residences. President Castelar is personally anxious to accept the British Minister's good offices to effect a compromise, but there is no hope to night. WASHINGTON, November 27.-It is stated on good authority that our government has extended the time to make a definite reply to the ultimatum. Dispatches of an elaborate character were received from Mad-rid to-day, giving an account of the interview between Sickles and the Spanish Minister of Foreign Affairs.




