We are too poor, in this county, to give so large a sum for that which might probably become only a change of masters. We are in favor of a railroad, but we want two ends to it, one at the East, where the true market of Baker County is, and the other on the seaboard, at Portland or elsewhere, not especially for our accommodation, but for the rest of Eastern Oregon, and more especially the grain-growing counties. Our interest here is to have an Eastern connection, to procure machinery, Eastern merchandise, and a market for the base ores known largely to exist in our county. When our mining interests here are even partially developed, all the cereals grown here will have a home market. Even now we are largely dependant on Union County for breadstuffs and vegetables. It is to the Orient we look for substantial aid in developing our mineral resources, and the necessary immigration to give us wealth and population.






