NEW VOLUME—CHANGE OF FIRM.

By reference to the head of our paper on the first page it will be seen that this number of the paper closes volume five of the DEMOCRAT. During the past five years the paper has never failed to make its appearance on the regular publication day. Since we have had control of the DEMOCRAT we have never asked a dollar's worth of assistance from any one to enable us to carry on our business. We are under obligations to no one for assistance either monetary or otherwise as a gift to the paper. The DEMOCRAT is now on a firm and paying basis, and we are free and untrammelled and no one, be he ever so high or low, can say to us that we must do this or that. Our position is a proud one—we are beholden to no one—we are free and independent of all politicians, cliques or rings, and in our writings in the future as in the past we will only be guided by what we believe to be just and right, and for the best interests of our country and our party.

The DEMOCRAT, as its name indicates, is a Democratic paper, and as long as we have control of its columns it will be nothing else. We will advocate Democratic principles as we understand them, but in doing this we do not conceive it to be our duty to advocate the interests of any one individual, or to foster and build him up to the detriment of as good or better man than he is. If a politician wants us to advertise his stock in trade in the way of his line of business to foist him into office he must pay us for our labor and the use of our material the same as men trading in our other goods, wares and merchandise. If he expects to make a living from office, he must pay for the use of our printing press and material, and for the labor he demands of us in placing his case before the people, in the same ratio that our merchants advertise their goods. If we do publish a Democratic paper this does not compel or demand of us that we shall use our means and our labor to advance the interests of any individual member of the party by devoting our means to his advancement, unless we receive an equivalent therefor. Our press and material are our own, we have paid for it out of our own pocket, and by carrying on the printing business we expect to make an honest and comfortable living, and to do this we intend to have pay for our labor.

With the next number of the DEMOCRAT we take a partner into the business with us, who will attend to the books of the office, and will have full charge of the workings of the DEMOCRAT during our absence from the office. H. C. Shepherd has been in the office for some three years. He is a good printer and understands the wants and wishes of our people, and, with us, will use his best endeavors to make the DEMOCRAT a most interesting paper. By associating our son with us in the publication of the DEMOCRAT we will be enabled to make various improvements in our paper that cannot fail to make it in the future, as in the past, acceptable to our people. The change in the firm makes it necessary that the old business of the office be settled up, therefore, all those indebted are expected to call and settle their accounts either by cash, note, or in some other way acceptable to us. With the commencement of the Next Volume, next week, we shall commence the publication of our subscribers names, and all who owe us for more than one year's subscription, will be placed in the Black List, or designated as not good; those who have paid their subscriptions regularly will be given credit for the same. We will commence this publication with our Baker City List, and continue it from week to week until we go through our whole list. Those who do not wish to see their names in the delinquent list can obviate the same by calling and settling their accounts, we intend to discriminate in favor of none. We will not discontinue any man's paper until he pays up arrearages, and as soon as his name appears in the Black List we will proceed to the collection of his account by law. We want our money, and delinquents must pay up if they want to save costs, &c.

SUBLIME IMPUDENCE.—Mr. R. B. M. Boyd, formerly of the Baker City Herald, passed through here with his wife and children on his way to his home in Iowa. Mr. Boyd published an excellent paper, but he says the county was too poor to sustain him and he lost considerable money in the enterprise.

We clip the above from the Boise Statesman, and we see it copied in the Avalanche. Bob Boyd is gone and we have no tears to shed. He didn't owe us anything, but there are numbers here who shed bitter tears of vexation, first, that they didn't have a chance to arrest him for debt, and second, because they couldn't get anything if they did. He left Baker County between two days, fearing, perhaps, that the rosy daylight might blush still deeper at the sight of the scoundrelism he was perpetrating on his creditors.—This county, though the richest in Oregon, was indeed too poor to support such a cheek as Bob Boyd's. He bought the Herald on check, betrayed the friends who helped him buy it, and got for selling himself just what he was worth—nothing. He lived on check, drank on check, and did other things, not quite so reputable, on the same original capital. If his check was cut up into decent sized pieces it would make souls enough for a thousand hogs. As an editor he never rose to the dignity of failure, as a politician he went on the principle that no administration could charge faster than he could, as a man—we beg pardon of mankind and leave the subject in disgust.

OUR WASHINGTON LETTER.

WASHINGTON, April 12, 1875.

Discussions in the Republican Camp.

The Republicans in Washington are very much depressed by the signal defeat of their party in Connecticut. The Grant men ascribe it to the malevolent influence of Blaine and his adherents, while the republicans who oppose Grant's third term project stoutly maintain that the people have merely recorded by their vote their determination to defeat him, if a packed convention of office-holders' dares to renominate him in '76. I have heard, during the week, dozens of republicans declare that they shall not consider themselves bound by the action of a convention that renominates Grant. The breach between the two factions, the Grant and the anti-Grant men, is growing wider every day, and there is no doubt that, by the time Congress convenes, criminations and recriminations will have made reconciliation impossible. So much the better for the country.

The Next House.

It is to be hoped that the Opposition members of the next House—especially those of them who are recognized as leaders—are devoting their best thoughts to maturing measures for leading the people out of their troubles, and making peace, plenty of and good feeling the rule throughout the land, instead of intriguing for the Speakership, which is a comparatively unimportant matter. Randall, who so signally distinguished himself during the late protracted struggles against the Civil Rights Bill and the Force Bill, has been for some time the acknowledged leader of the democracy in the House, and possesses, perhaps, more of the many qualifications necessary for a Speaker than any other candidate spoken of. Blaine and Colfax are my authority for pronouncing him the best parliamentarian on the democratic side of the House; besides which, he is a "ready" man, industrious, blessed with great powers of endurance, of remarkable urbanity, and, although as strong a partisan as a true gentleman ever dared to be, (and who would or should be more than that?) nevertheless, a man who would be as impartial in his rulings as any man who ever occupied the Speaker's chair. But there are a half a dozen other men, any one of whom would make a good Speaker. Banks, Kerr, Wood, Cox, Saylor of Ohio, and, perhaps three or four others, would fill the chair quite creditably. What the country most needs, however, is men on the floor of the House with the ability and will to inaugurate a system of wise and impartial legislation. The people will not be satisfied with spread-eagle speeches, with denunciations and expositions of republican robberies, frauds and blunders, and with long and costly investigations. They already understand to their sorrow, that the republican party has been stealing, cheating and blundering. That's why they have put the democracy on trial, by giving it charge of the next House; and they will surely expect from it wise and impartial legislation, to the extent of its power, limited, as it will be, by a corrupt majority in the Senate, and by still more corrupt Chief Magistrate. It is of the first importance, therefore, that the members of the leading committees, Ways and Means and Appropriations, especially the chairman, shall be something more than orators, and wits and politicians. They must be broad-minded statesmen and hard workers, and be fully alive to the fact that the result of the next presidential election will depend, largely if not wholly, upon their official conduct. It is true that there is legislation that the House can not effect without the cooperation of the Senate and the approval of the President; but the constitution gives the House the exclusive right to originate all bills for raising revenue, so that the Committee of Ways and Means can, if it will, and is backed by the House, insist upon many needed changes in the tariff laws, and those of the Internal Revenue. The power of the House Committee on Appropriations is also large, and can be used by the right kind of a chairman to the great benefit of the public service. There are eleven men on each of these two important committees, and the twenty two occupy, during a session of Congress, as much of the time of the House as all the other 270 members put together. It is difficult to see why Mr. Randall, or any of the other gentlemen named above, if he have ambitious dreams of continuous preferment away up to the highest office in the gift of the people, confide in his powers, in his "true inwardness," and in his capacity to distinguish himself on the floor, would not prefer the chairmanship of either of these committees to the Speakership; for, never since the foundation of the Republic, has any man had such a chance to distinguish himself in civil life as will be afforded to the democrat of the next House who has the sagacity to perceive, the nerve to seize, and the ability to improve, the opportunity to become the leader of the next House on its floor. The Speaker will have the opportunity to distinguish himself only as a parliamentarian—at best as a political tactician. The leader on the floor may show the world that he is a statesman; and upon him, and upon his acts; at this crisis in the life of the country, will the general eye be fixed.

The Pacific Mail Steamship Company.

Many of the best lawyers in Washington pronounce the law of Congress annulling the contract of the government with this company unwarranted by the evidence before the Ways and Means Committee, and there is reason to believe that the Forty-fourth Congress will restore the company to its former status. No one doubts that the funds of the company were misapplied by its former president; but the testimony showed clearly that it was the stockholders that were wronged, and not the Government, and that a majority of the directors were wholly ignorant of what was going on. Now that the management of the company has passed into more able and honest hands, there should be no delay in securing its services and paying liberally for them. It is not a question of helping the company, but of enriching our country and augmenting its power. Self-interest, alone should induce us to foster our mercantile marine, and especially that portion of it which is endeavoring to secure for us commercial supremacy in China and Japan, which countries are every year opening more and more of their seaports to foreigners. It would pay the people of the United States to give, during the next five years, even twice as large a subsidy to the Pacific Mail Steamship Company as that which has lately been taken from it; for that line of American steamships and the Pacific Railway would secure to us, if liberally encouraged by the Government, the entire monopoly of the transportation between Europe and China of all valuable articles of commerce of comparatively little bulk. The United States would become the great passenger route of the world; and every city, village and farm along the line of the Pacific Railway would be immensely benefited by this increased trade and travel. There is, really, only one side to the question. It is to the interest of the people of the United States to make, at any reasonable cost, the Pacific Railway and the Pacific Mail Steamship Line the most desirable media for travel, and for the transportation of the more valuable kinds of merchandise, between the several countries of Europe and China and Japan.
