THE MYSTERIOUS ROBBERY.
Marmonte was a walled town in a province of France. In one of the houses near the ramparts lived a carpenter named Benott. He was a sober man, who said little. He had followed several trades, had been a soldier, traveled a great deal, and had many adventures, but as he never spoke of them, the town people thought he had nothing good to tell.
The only person that he was at all familiar with was an old soldier named Trappe who had saved his life in battle. This man was a great talker and boaster, and Benott suspected him of being a knave. He had set up a barber shop in a street near by. One evening he called on Benott to ask him to drink a bottle of wine at the Cheval Noir, with two old comrades who had served in the same regiment.

He remembered this afterwards, but thought little of it at the time, he was so sleepy with the wine. He then fastened his doors and went to bed.
The next morning he was astonished to find his shop door ajar, and on going to his lumber loft, that the window was open. He said nothing, for it was not his custom to talk about what he did not understand. On going to his work, he found the whole town in excitement, and talking about a great robbery that had been committed during the night. He soon perceived, too, that he was avoided, and many cast strange glances at him. Then he overheard a neighbor say:

Others declared to her what they thought.
After defending her husband warmly, she returned home weeping, and saying that she would live no longer in Marmonte.

"If I go away," said Benott, "I shall leave a bad name behind me."
"But what good will it do you to stay in this place?" asked Madame Benott.
"I mean to recover my good reputation," answered he.
"But you will lose all your customers."
"No," said Benott, "for I will be the best carpenter in town."
"There are others quite as good as you, what will you do to make yourself better than they?"
"By taking the most difficult work and trying to make it perfect."
Benott had work on hand when he was arrested. He hastened to finish it. He did it so well, so promptly and so reasonably, that the firm continued to employ him in spite of their bad opinion of him. He arose two hours earlier than usual every morning, and retired later; he labored diligently, so as to hire fewer workmen, and be able to work cheaper, although he furnished the very best material and workmanship. Thus he not only kept his old customers, but acquired new ones.

Publishers of Newspapers.
Publishers of Newspapers—and more particularly local newspapers, have to depend mainly upon their advertising columns for their support. Yet, how many are there who seem not to realize this fact. Instead of giving their paper a liberal advertising patronage, they perhaps give it none, and if a lover or entertainer is got up in the place, the paper is expected to notice it for nothing.
Now if all the patronage that a paper can expect is that of the locality for whose interest it works, it would seem that every one should give it the advertising that legitimately belongs to it, and not try to get it without paying for it. There is a class of people that seem to begrudge every dollar that goes to their local papers; and still borrow it and read it, and are the severest critics of its shortcomings.
The publisher has to pay for labor and paper, and every notice of any kind, in the nature of an advertisement, he ought to have his pay for. He has got to get his living out of his advertising columns, and any society or individual can with just as much propriety beg five dollars of any other individual, as to expect it gratuitously of a newspaper.
Any man who does not think enough of his town's paper; and every trader, who does not believe in advertising, should move into some town where they have no paper.
COUNTING THE CURRENCY.—That exceptionally honest old "pub. func." and marvellous chirographer, Spinner, is to retire from his office, as Treasurer of the United States, on the first of next month, when the newly appointed Treasurer, Hon. J. C. New, will take charge. Mr. New is expected to arrive at Washington day after to-morrow, the 25th, when arrangements will be made for an actual count of all the money on hand, in order that the new Treasurer may receive to this predecessor for the amount delivered by him. There are about \$400,000,000 of U. S. bonds held in trust for National Banks, all of which will have to be taken from the vaults and counted; as well as all the money in the cash vault, including coin and fractional currency. There is usually between \$50,000,000 and \$40,000,000 in cash on hand, but an effort has been made to reduce the amount somewhat on the day the count is to be made by a circular sent to the banks, requesting them not to send forward sums for redemption or exchange for a day or two. The work of counting this vast amount of money and bonds would seem to be a most enormous one, but it is said that a force of ten or 15 experienced counters can accomplish it in one week. The most troublesome part of the job will be, of course, the counting the fractional currency, which will require much labor and patience. The books of the Treasurer show the amount on hand at the close of business on each day, and the object of the count is to verify the statement of the 30th of June, for which the new Treasurer will be required to receipt.
