TEAM RUNAWAY.—Last Friday as Wm. Yantis, of Linn county, was driving across his farm with a team and farm wagon, the neck-yoke gave way and the pole came down. The horses immediately started to run and the pole soon ran into the ground, completely upsetting the wagon and throwing Mr. Y. to the ground with considerable force, but without injury beyond a few painful bruises. The team freed themselves of the wagon and soon stopped without injury, so the damage after all was but slight.

Mr. Scott, of Scott's Mills, Batte Creek, Marion county, who arrived in this city yesterday, brings news of a horrible outrage committed on Sunday morning at Crooked Finger Prairie, at the head waters of Batte Creek.

A Mrs. Jackson, wife of a respectable farmer, was waylaid by a tramp who struck her over the head and outraged her in a fiendish manner. The residents on the prairie are hunting for him with shot-guns, and it is hoped that he will be found.

A Mr. Kiroos, of Portland, Oregon, who figured so prominently in the disgraceful pretended band contest at that place during the first part of the present month has no doubt brooded over the unprecedented wrongs done to the several bands on that occasion, until it has had some effect upon him, that the Standard chronicles the following:—Mr. Kiroos, the well known vocalist, took a pleasant drive on Sunday, and on his way home stopped in at President's music store, about 12 o'clock, to write a letter. When he had finished it he stepped out to put in a post-box, and forgetting his team, kept on home about 6 p. m. the proprietor of the livery stable, from which he had hired the outfit, called at his house to see what had become of him and the team. He was informed that it had been tied up in front of the music store as aforesaid, and if it wasn't gone it was standing there still. On repeating the place it was found all right, only the horses were probably a little hungry after their six hours' fast of post.

STATE NEWS.

Harvesting has commenced in Jackson county.

The weather has been very warm in Portland the last week.

The salmon catch on the Columbia has not been half as abundant as usual this year.

It is reported that in Medoc county, California, and Lake county, Oregon, crickets are plenty and very troublesome, destroying vegetables and everything else green.

On the farm of Major Moor, near North Yamhill, a twig sixteen inches in length was cut from a cherry tree, and contained 204 cherries.

East Portland on last Thursday night was visited by a thief who stole a week's washing from a lady who had it tied up in a bundle. Another party lost half a dozen chickens.

DROPPED DEAD.—Christian Erickson, a fisherman employed by Booth & Co., dropped dead in his boat while he was fishing Thursday evening. He leaves a family at Upper Astoria. Heart disease is supposed to be the cause of his death.

Mr. Wm. Reid, of Portland, informs a reporter, says the Standard, that rumors going through the papers to the effect "that the 99 years lease of the Oregonian Railway company had fallen through with" is untrue, and that the lease will probably be signed by both parties some day next week.

The body of an unknown man was found on the Ocean beach, opposite Nehalem Sand-spit last Monday. The fact was at once made known to the county Judge at Astoria, and the body buried. There was nothing on him by which he could be identified, and had been dead for several days.

Thomas Bonner claims to have been robbed of \$180 in the back yard of the Norton House in Portland last Sunday night. He claims that he was struck on the head and stunned and his money taken. He was drunk at the time of the alleged robbery, but the landlord says he had that amount of money on Saturday.

Our fishermen appear to be altogether out of luck this year. The catch being so small it was hoped the price might advance, but now advice from British Columbia says the take there is immense, only limited by the means for catching and canning. This will probably keep the price down, and so canneries in the Columbia must be content with small profits this year.—Standard.

STABBED.—About 8 o'clock last Friday evening a man rushed into the room where a lot of Chinamen employed at the oil works below Astoria were preparing to go to bed and commenced cutting right and left. He succeeded in cutting one Chinaman severely in the head and two others about the head and face. A man has been arrested, but two other parties say he is not the man.

Articles were filed in the Clerk's office of Multnomah county on last Monday incorporating the Silver Wave Consolidated Mining Company, with a capital stock of \$106,000. The principal office of the company is to be at Portland. The object is to mine for gold and silver and to buy and sell quartz claim ledges, in this State and Idaho. The incorporators are Geo. F. Wells, Geo. Woodward, G. W. Gardner, R. R. Irwin and Ben Simpson.

Captain Charles F. Powell, superintendent of construction of the Cascade locks, is ordered by the United States to have a government tent constructed, to be in length 160 feet; breadth of beam, 23½ feet; depth of hold, 6 feet, with two 20-inch cylinders, 6½ foot stroke, and a steel boiler capable of sustaining 175 pounds. She is to be a steamer of fine model, with stern wheel and a neat cabin, and when completed is expected to be the fastest boat on the Columbia river.

Life whipping is becoming too common. Last night a fellow named Devin took it upon himself to assault a poor little woman he called his wife. She was probably not worthy of the name of wife, perhaps she was, but the brute had no right to assault her. In California a law has been enacted inflicting the penalty of the whipping post upon any man who assaults and beats a woman. That is right and we hope to see a law of the kind enacted in Oregon. The dirty brute who will assault and beat a woman deserves severe punishment, and we would not only suggest, but advocate the enactment of a law punishing such crimes without stint or limit.—Telegram.

A serious railroad accident occurred at Waitsburg on the 14th. Just as the train passed Huntville at a rapid rate, and as it entered a field near by, a hand of cattle started across the track. One of them, a large white mottled bull, as he reached the track, turned and ran down the track ahead of the train. The cars immediately caught him and he went under the forward car, which at once jumped in the air, throwing the people aboard in every direction, killing Dr. Sutherland and Ben Hardman. The first car went off to the left, and turned over a perfect wreck, the other cars piling upon it. Five cars were smashed to pieces so that nothing appeared left but wheels and iron rods. The track was torn up and ties broken and scattered all around.

As Surveyor Rockhold was returning from a surveying expedition a few days since, says the Palouse Gazette, and when about three miles east of Cottonwood, Spring, eight Chelan Indians accosted him and demanded tobacco, then money. They then took the horse by the bit and held him.

Mr. Rockhold is an old frontiersman, and didn't scare worth a cent. He broke his compass over the head of one warrior, and in the struggle dismounted and fled, when the Indians killed his horse. Mr. Rockhold ran for a house near by but meeting the mail carrier, who had a revolver, the two returned and galloped up the broken embankment and found the horse so badly stabbed that he lived but a few minutes.

It is further stated that the Indians are enshamed and demoralized. The settlers in that part of the country only ask that guns be furnished them and they will not ask the aid of government troops.

SOUTHERN OREGON.

J. A. Cardwell proposes inaugurating a horse fair in Jackson county this Fall.

Josephine county hopes for a railroad since her mountain passes are being examined.

J. P. Lewis of Democrat gulch fell from a ladder leading to his hayloft on the 6th, but escaped with some painful bruises.

The new bridge at Ashland cost \$1,650 68, of which Jackson county paid two-thirds and the town of Ashland one-third.

Grasshoppers are still doing damage in Sprague river valley, Lake county.

Wm. Krenzer opened a German school in Jacksonville this week, which is well attended.

Andy Davison and Jasper Crenshaw will soon be in receipt of a steam thrasher, which will be the only one of the kind in Southern Oregon.

Reports from different portions of Southern Oregon indicate that crops will be generally good. There will be less straw than usual, as the grain is shorter, but nevertheless well filled.

The other day, as Henry Hutchins of Sucker creek, Josephine county, was being drawn out of a well by a horse, the harness broke when he was about 15 feet from the top, precipitating him to the bottom with great force and fracturing his right leg at the ankle.

As Jas. Lewis, Jr., of Democrat gulch, Josephine county, was driving a span of colts to a hay-wagon on the 6th, they ran away and threw him violently to the ground, bruising him severely, but fortunately breaking no bones. The wagon, as also a rail fence near by, were thoroughly demoralized in the fracas, however.

While digging a hole in the rear of the U. S. Hotel, L. A. Heberich picked up several pieces of gold, some of which weighed as high as half a dollar. There is no doubt but what the site of Jacksonville contains more riches than any mine in the State.

John Bolt of Applegate, who has just returned from Galice creek, reports that Green Bros. have struck their quartz ledge by the new tunnel and found a better quality of ore than ever and plenty of it.

Camp meeting has closed, it was not as much of a success as it might have been under different management.

The continual rattle of the movers can be heard from early dawn till late at night.

Threshing will begin this year about ten days earlier than last.

The principal topic of interest here is the Yaquina rail road. Everybody wishing it the most abundant success, and also that it may be finished in time to carry some of these years crop thereby causing the producers to realize a handsome profit over what they will provided they will have to ship through Portland.

Messrs Housck & Son of Monroe are putting up a new building at the same place the old one formerly stood, and when finished it will be one of the most town places of the town.

Messrs Wortman & Sons, are closing out their stock of dry goods, and etc., at auction. The increase of their business at Junction demands their entire attention, thereby compelling them to close out at Monroe.

There has been more land summer followed this year than ever before: a thing which more generally precised would be a financial benefit to the farmers.

THE STATE UNIVERSITY.

A meeting of the Board of Regents of the State University of Oregon was held at Eugene City on Friday.

The following members of the Board were present: Judge M. P. Deady, President; J. J. Walton, John Thompson, Thos. Hendricks, B. F. Dorris, Dr. S. Hamilton, Dr. E. R. Geary.

The reports were received from each teacher connected with the university, read and taken under advisement.

After some discussion it was decided by the Board to increase the salaries of teachers ten per cent.

An indebtedness of \$6000 exists against the University—\$4000 of which is in the form of judgments—the entire amount drawing interest. The creditors threaten to foreclose and sell the building if the claims are not paid soon.

Dr. S. Hamilton, Thomas Hendricks and John Thompson were appointed a committee to confer with citizens of Lane county to devise means by which creditors will withhold immediate action and by which the indebtedness need be paid off.—Oregonian.
