FATAL ACCIDENT.—On last Friday, Thos. B. Logsdon, a well to do farmer and highly respected citizen of this county, who resided about four miles north of this city, went into his barn, and stepping up behind one of his farm horses, slipped it with his hand, when the horse kicked him, striking in the side just over the heart. Mr. L. fell to the ground and instantly died. Mr. Logsdon has lived in this neighborhood for a number of years, and was universally respected, and by his immediate neighbors, who knew him best, he was loved most. No one could possess a more kind and generous nature and disposition than the one in whose memory these lines are penned; yet his generosity did not show itself in large donations to remote possible charities, but in acts of loving kindness to those around him. He leaves a family who deeply mourn the loss of a loving and faithful husband and a devoted and affectionate father. On Saturday evening a large assembly of sorrowing neighbors and friends followed his remains to the Loge cemetery, near his late residence, where all that was mortal was laid to rest, with the beautiful and appropriate ceremonies of the Masonic fraternity, of which he had long been an honored member. His life work is accomplished, and he has now solved the mysteries of the spirit world. He was a good man, and as such is mourned by his friends.

MEN WHO DON'T ADVERTISE.—There is a class of business men, most truly says the Union Sentinel, that are not worthy of public favor, and this class of men is the class who are strangers to the use of printer's ink. A class so stingy and close that an ordinary branch of business will naturally dry up and blow away in their charge, while if controlled by a wide-awake and farseeing man, a man with an eye to the prosperity of his town, as well as a disposition to help himself, would draw friends and customers, would show up as an acquisition to our town, from a business standpoint as well as a social co-mingler in the public spirit of prosperity. Some of these qualifications are points very essential to business men, and no town on the green foot-stool we tread has ever been known to prosper where the business was represented and monopolized by the class of leeches or blood-suckers we have described. Whenever and wherever a curse of this character is known to exist, it is nothing more or less than the duty of the public press to make known the wants of a community and endeavor to have them supplied, by a class of public benefactors. This we shall endeavor to do in connection with our own town, at an early period of our city's history.

A CASE OF SYPHILIS.—Oregonians are so accustomed to mild and humid air that if perchance the mercury reveals for a day or two among the eighties, or by extraordinary exertions on the part of old soldiers the astringents, people puff and exclaim at the heat as though it was particularly fierce and well nigh intolerable. Beyond these exclamations, however, there are seldom any serious results from heat in Oregon. Therefore, the announcement of a case of sypilis in a harvest field in Washington county last week, is received with astonishment and incredulity. The Hillsboro Independent is, however, authority for the statement, saying: Wm. Smith, son of L. Smith, of Forest Grove, was struck last Thursday afternoon, while in the harvest field. Dr. Bowly attended on him, and by faithful attention succeeded in bringing him out all right. This is the first case we know of in Washington county.

This troupe comprises not only the minstrel performers, but also several accomplished vocalists for singing songs, ballads and jubilee songs like the Hutchinson family. Miss Maggie Webb sings the "Swanee river" in her usual pleasing manner, which is greatly admired by those who have listened to her melodious voice. It is very rarely that we have the opportunity in this country of seeing a genuine negro troupe, and no doubt this opportunity will be sought after and appreciated by all.

MATRIMONIAL.—On last Saturday Peter N. Zierolf of this city was united in marriage with Mrs. Amelia Warrior also of this city. The marriage ceremony was performed by Rev. Father Van Linn at the Catholic Church at the hour of high mass in the morning. After which the happy couple made a short visit to the friends of Mr. Z. in the southern part of the county, but have returned, and the smiling countenance of Mr. Zierolf may be seen as usual at his place of business. The GAZETTE was not forgotten by the newly wedded people, and the editors, printers and devil all unite in wishing the new family a happy and prosperous voyage through life. May their only cares be such as will eventually become blessings. May they live long and when at a mature old age surrounded by all that makes life pleasant, may they like autumn leaves fall to the earth together.

BISHOP KAVANAUGH'S SERMON.—On last Sabbath Bishop Kavanaugh preached at the College Chapel in this city to a large and attentive congregation, and we think that we speak the words of truth and soberness when we say it was the best sermon we have listened to for many a long day. Although the Bishop is eighty years old yet his mind has lost none of its original brightness and he brings with him the ripe scholarship and experience of a long life devoted to the study of the subject upon which he talks. His subject was "The new birth," and his position that with the greater portion of mankind there was a constant war between judgment and inclination. Every proposition that he made was so clearly proven that all were forced to admit the truth of his arguments.

LONG TOM MEASUREMENT.—It was a Long Tom carpenter who had contracted with a feminine to build a house and porch thereto six feet wide. She disputed the width of the porch when she came to examine the job. Two switch engines, formerly used on the Pennsylvania Central R. R., arrived on the large Atlas Saturday evening. They were taken to the shops and put in running order.

An immense fire broke out on the night of the 3rd at Truckee, and destroyed the whole business part of town except one store, a hotel and the Truckee lumber Co's office. The loss is estimated at \$300,000. The charred bones of some persons was discovered in the debris.

BELLSOUNDING.

The gentle rains descend, making the average farmer somewhat blue. Some fear a wet harvest; others rust, which by the way has been seen on some pieces of late sown grain; but I do not think there need be fear of it being general, as grain in the majority of cases is too far along to hurt.

Monroe has weekly fights it seems of late. Two or more persons comes with the full intent of hunting a quarrel, and see who is the best man in town on the fighting day which is Saturday. The first place they visit is of course the saloon, and then get on the outside of as much whiskey as possible. The next place is in some respectable crowd, and there begin their abuse by vile epithets and slang, before both ladies and gentlemen, on some poor unsuspecting person, and if he does not resent it they will be four or five, as the case may be, pelting him promiscuously on the face and head, and in fact most any-where that comes handy.

Our officers are some-times on the ground and by wild waving and flourishing of hands exclaim, stop that! stop that! or I will arrest you! stop that! stop that! or I will send you to Corvallis and have you fined, and jailed. That will be all they can, or will do, towards taking the parties in custody. So Monroe had better do one of two things; either not be a town or else have the present officers to resign and have officers put in their place who will keep peace, or at least try it, than be in hands where such indecent things transpire; which insult the better part of the community. Such things must stop somewhere, and the sooner the better it will be for us all.

MONROE ITEMS. (Regular correspondent to the GAZETTE.)

The rain has put a check to the headers and hay-handlers. The rain has not done much damage in this vicinity, further than stopping work. There was considerable hay out, but it is not hurt much.

It is the talk that Monroe is to have a brass band this fall.

John Huffman, one of your city dads, is stopping here for a while. He is handling the saw and hammer. John went hunting one day last week; he killed birds enough to supply the town. He says he will not tell where he found them. Some of them looked like young geese. It would make one's hair stand on end to hear him tell what narrow escapes he had.

Last Saturday was the last of Mr. Wortman's sales. There was a larger crowd in town than any time previous, and everything passed off smooth, without any fighting. It seems Uncle Will Kelly's trip to Corvallis had some effect on the fighting part of our community.

RAILROAD RACKET. (From The Dalles Times.)

The lack of cars is still greatly felt at the wharf-boat.

Vast quantities of wheat and flour are arriving from above.

Twenty-five cents apiece are paid for ties in Union and Umattilla counties.

Over 100 sacks of coal arrived Monday night for use on the new switch engines.

The company have now about 6000 men on their pay roll in Oregon and Washington Territory.

The Atlas unloaded a large number of ties and fish-plates yesterday, also a quantity of railroad iron.

A large number of car axles arrived yesterday morning, and mechanics at the car shops will be busy hereafter.

The new Howe Trestle bridge over Five Mile Creek is nearly completed. It will be erected below the old one, and a new track laid over it.

Freight has accumulated so fast during the week that barges have been used in the carrying trade.

A new time-table went into effect Sunday at noon. Passenger trains now leave The Dalles at 8:20 p. m. and arrive at Walla Walla at 9:40 a. m., at Dayton 9:50.

The graders are making the dirt fly near Pendleton, and expect to get through with their work in a few days, when they will be placed on the road between this city and Portland. The engineers have also been busy locating the depot and switches at that place during the week.

The Columbia Chronicle says: Track laying on the Grange City road will begin next Monday. Between seven and eight miles will be laid at present, when the men will be transferred to the Umattilla and Pendleton branch. It is thought to be cheaper to utilize this track to carry bridge timbers than to hire the same hauled on wagons.

The yard at the Dayton depot, says the Chronicle, presents an animated appearance. Crowds of white men and Chinamen are engaged in straightening and ballasting the several tracks, excavating for the turn-table and round house and handling lumber and material. Their white tents dot the grounds and creek banks and are strikingly picturesque.
