The Five Rivers Tragedy.

Slight mention was made in the GAZETTE last week of this horrible affair, but full particulars were unobtainable at that time. It now appears that two weeks ago Mr. G. W. Hunt of this city, lost a tarpon from a hay stack on the Jas. Foster place, and that suspicion pointed strongly to Ad. Hood, John and Ed. Horton, of that neighborhood, as the parties who had feloniously purloined the same. On Monday evening of last week Marshal Pygall started in pursuit of the suspected parties and followed them to Five Rivers, where they had gone on a hunting expedition, evidently with the intention of remaining some time, being well supplied with provisions and camping outfit, having made a tent and several suits of clothes out of the tarpon which Mr. Hunt had lost. On Wednesday morning about 10 o'clock and near their camp Pygall met John Horton coming out to the valley for help, saying that about two hours previous he had shot Ad. Hood for a deer, killing him instantly. Pygall arrested the two Hortons and lodged them in the county jail here on Thursday of last week. They have since had a preliminary examination before Justice Quivry, and John Horton pleaded guilty of the charge, and now, in default of bail, awaits the action of the grand jury. Sufficient evidence could not be found to convict the other Horton, and he was accordingly released. Willis Vidito, Justice of the peace for the Alsea precinct, was summoned and held an inquest over the body of Hood. He writes: "On examination of the body at the inquest, it was found that the ball had entered the body under the right hand side of the lower jaw, passed obliquely and downward, and came out at the lower point of the left shoulder blade. The ground is very steep and is covered with a dense growth of underbrush. Upon actual trial it was found that a man dressed as Hood was dressed, standing where he stood, could not, from the place where the deer was found and the shots were fired, be distinguished from a deer. The jury without any hesitation, found a verdict of death by a shot from a gun in the hands of John Horton, who mistook Hood for a deer. After the inquest, Hoot's body was placed upon a horse, carried twenty miles over a steep mountain trail to the wagon road in Lohr valley, where it was received by his parents and taken home for burial."

Farewell Party.

Last Saturday evening the members of the Alumni association of the Agricultural College tendered Rev. Jos. Emery a farewell party at Pittman's hall. Judge Bryson, representing the Alumni, delivered the farewell address, which was feelingly responded to by Prof. Emery. Hon. E. B. McElroy, Pres. B. L. Arnold, and Senator Cuthbert, were then called upon and delivered appropriate remarks, all expressing regrets at the departure of Prof. Emery and his family, and wishing them health and prosperity in their new home. The evening was spent in social intercourse, partaking of excellent refreshments served by the alumni. Mrs. Layton, Miss Hitching, Mrs. Arnold and Mrs. Leo rendered some beautiful solos during the evening. All in all the evening was a pleasant one, tinged with sadness only with the departure of him who has labored so faithfully for the success of the College for the past eighteen years.

The Oregon School for the Deaf.

The Oregon school for the education of deaf mutes began its year's work at Salem on Wednesday, the 16th inst., says an exchange. According to the tenth census there was a total of 102 of these unfortunate in this state. Immigration within the past five years most likely added its regular quota to the number. Probably one-third of the whole are of school age, and it is hoped that the parents and guardians of these will make the necessary effort to place them in school. Helpless enough at best are these children, who, with wisdom at one's entrance quite shut out, are compelled to combat circumstances for a livelihood, but their helplessness is immeasurably lessened by the endeavor which philanthropy makes for their education. The most intelligent effort has been made in connection with the school for deaf mutes in Salem, and its past record is a credit to the state.

Newspaper Etiquette.

It frequently happens that visitors to newspaper offices do and say things which are improper, and rude and annoying. For this reason, we wish to throw out a few hints that will enable the visitor to avoid unintentionally giving offense.

When you enter the printing office do not handle the type in the cases. If you wish to examine the type say so to the printer, and he will be glad to stop his work and empty the case out on the editor's table, where you can sit in his chair and examine the type at your leisure. Never mind putting back the type the printer can do that after you get through. Don't read the proof-sheets, clippings of manuscript. If you want to know what is going to appear in the next paper, ask the editor to read it aloud to you. Never ask for a sample copy, but take half a dozen. Never spit tobacco juice on the floor; always spit on the exchanges or on the walls, otherwise the editor will think you are not accustomed to a newspaper office. Make the editor feel that his presence does not annoy you. Never ask for old exchanges. Just help yourself to the unopened ones for they always contain much later news than those that have been opened. Ask the editor, if you are a perfect stranger to him, to supply you with a duplicate key to his postoffice box, so you can get his papers regularly. If he is a gentleman he will furnish you with a duplicate key without asking, but some editors are not gentlemen.

Robbery.

HENDRICKS AND THE IRISH.

EDITOR GAZETTE.—The speech of Vice President Hendricks delivered in the city of Indianapolis on the 8th inst. to a meeting of Irish Agitators brings at once squarely before the American people a subject of deep significance. The open and avowed hostility to the British government as expressed by a portion of our Irish American citizens at their public meetings in this county does not so much impress upon the native American belief in the present or traditional wrongs of Ireland under British rule as it does the growing opinion that the masses of Ireland are incapable of self government. Centuries of experience and opportunity finds Ireland to-day no farther advanced in wealth, culture or in the line of national progress.

Her people in instances without number, have been betrayed by her own sons. Unscrupulous and dishonest leaders professing patriotic motives have so worked upon the passions and the prejudices of the ignorant masses, that they have been led to look upon any form of government only as another form of oppression.

Our own country does not escape the baneful influence of these so called Irish patriots. They come here professing patriotism and love for the land of their birth. They dwell long and loud upon Eria's wrongs endured at the hands of English oppressors.

The result is that in every large American city demonstrations by Irish American citizens are continually being held wherein are expressed the sentiments of avowed enmity toward a government with which our country is at peace.

It is certainly time for Americans to call a halt. Demonstrations of hostility to foreign governments by naturalized American citizens for the purpose of encouraging and perpetrating foreign feuds and animosities, should not be countenanced or tolerated upon American soil.

The foreigner who comes to our country seeking a home and citizenship renounces all allegiance to the land of his birth and also makes oath that he will obey and uphold the laws of this country of his adoption, this entitles him to all the protection and privileges of American citizenship.

This sacred trust is violated by thousands of Irish Americans who allow it to be prostituted in the interests of scheming adventurers who come here and upon our soil, with their mouths, fight the battles of Ireland against England.

In this way American citizenship is degraded and hundreds of thousands of dollars annually sacrificed in the support of a class of demagogues and swindlers in their efforts to encourage strife and enmity against a government friendly to ours.

This is certainly in direct defiance of American sentiment and shows an utter disregard of the obligations and responsibilities of American citizenship, and should no longer be countenanced by the American people.

To the American citizen who is somewhat familiar with the political history of his own country and the public records of American statesmen the speech of Mr. Hendricks to the Irish Agitators is peculiarly interesting.

This spontaneous outburst of sympathy in behalf of the downtrodden and oppressed and his strong advocacy of the rights of the toiling classes to have a voice and a vote in their government is indeed a new departure on the part of Mr. Hendricks.

During thirty-five years of public life as a recognized leader of one of the great political parties of his own country Mr. Hendricks has not been placed upon record as having ever uttered a sentiment in favor of the personal liberties or the political rights of the four millions of people, who, until lately were held in bondage as property and governed with the lash in the hands of men who constitute the controlling element in Mr. Hendricks' party to-day.

During the crisis when our government was struggling to put down armed treason and to prevent the destruction of our Union Mr. Hendricks steadily protested against furnishing men or money to enable the government to protect itself, but on the other hand, his sympathies were with those members of his party who were striving to destroy our republic for the purpose of founding upon its ruins a government, the cornerstone of which was to be human slavery.

Mr. Hendricks loses sight of all of this in soaring across the Atlantic in his efforts to take in the earth. The average American does not require a telescope to discover the motives of Mr. Hendricks.

The gentleman from Tipperary will in due time be impressed with his obligation to Mr. Hendricks. In the meantime Mr. Hendricks should go to Mississippi and ascertain why a majority of American citizens of that State are not permitted the free exercise of those privileges of citizenship which he is so anxious that the people of Ireland shall secure.
