

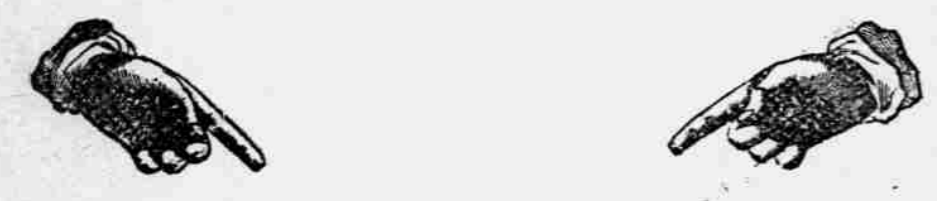

Rev. Joe Waldrop, a noted orator of the people's party in Oregon, addressed the citizens of Corvallis at the court house last Saturday night. Had the lecture been more extensively advertised the crowd would have been much larger.

Rev. E. J. Thompson, who has been attending the Presbyterian Synod recently in session at Albany, has returned, and will conduct services as usual both morning and evening, at the Presbyterian church. A cordial welcome to all.

About 350 delegates attended the state convention of Christian Endeavor societies, which convened at Eugene last Friday. Corvallis Y. P. S. C. E. societies were represented as follows; Congregational—Mr. Martin, Miss Nellie Hogue and Miss Fisher. Christian—Misses Lou Burnett and Addie Bristol, and Messrs. Erwin and Callison.

Rev. Geo. Gillespie, of Newport, was appointed, at the recent session of the Synod held in Albany, minister of the Presbyterian church at Dallas. Rev. Gillespie is a faithful worker in the Christian cause, and Dallas will gain a good citizen, much to the regret of Mr. Gillespie's many friends in Newport.

Rev. L. J. Trumbull, missionary of the Baptist association for Eastern Oregon and Washington, will preach in the Evangelical church, in this city, next Sunday at 11 o'clock, and will address the young people at 6:30 in the evening. Mr. Trumbull is an excellent speaker. A cordial welcome extended to all.

Sammel Price, of Yaquina, while on a spree proceeded to paint the railroad terminus by the blue sea, a vivid red, and was arrested for maliciously defacing property. He had a hearing before Justice Russel, who sentenced him to 50 days confinement, in the county jail, where he now takes his regular meals.

V. C. Brock, cashier of the Wasco county bank, accompanied by his family, spent a portion of the past week in this city the guest of his brother-in-law, S. N. Wilkins. Mr. Brock was raised in Benton county, and took great pleasure in meeting old acquaintances, and visiting the carriage factory and agricultural college.

Circuit court for Linn county convenes at Albany, next Monday. The docket is the longest in the history of the county, and contains about 180 cases, of which twelve are suits for divorce, and sixty-two are attachment suits, suits to recover money and foreclose mortgages. Columbia county has fourteen divorces, and only three civil suits on the docket at its present term of court.

J. E. Fenton and George Belt, now of Spokane, are both candidates for office. The former has secured the nomination for prosecuting attorney, and the latter is striving for the place of superior judge. Both are well known in this city. Mr. Fenton being a former resident of Eugene, and Mr. Belt an erstwhile citizen of Independence.

The Marine band, of this city, held a special meeting last Saturday evening for the purpose of discussing the matter of incorporating and reorganizing. After considerable discussion on the subject, in which all present took an active part, a committee was appointed to investigate the cost, and benefits to be derived from incorporating, this committee to report at a meeting held Thursday evening.

PROBABLE REMOVAL.—D. Nash, representing the Halsey drain tile factory, of Halsey, Ore., was in Corvallis, the first of the week, negotiating with the agricultural college for a contract to furnish tiling for that institution. Mr. Nash, was very favorably impressed with our town, and should be found a suitable location, will probably remove the factory to Corvallis.

He has already established a good business for that company in this city, which bids fair to become constantly larger. J. H. Edwards, of Monroe, received from David Craig, of Marion county, by express the first of the week, a fine specimen of Cotswold sheep and Poland-China hog. Mr. Craig makes a specialty of raising these special breeds of sheep and swine and has built up an extensive and profitable reputation for them. If more of our farmers in this county would follow Mr. Edwards' example and increase the grade of their flocks to the highest standard by breeding to the best blood, they would receive more profitable returns in the end.

The Salem Journal in a recent issue pays the following tribute to enterprising Corvallis: "Corvallis is making some needed improvements in the line of graded streets, coated with a liberal amount of fine gravel. In this growing city many new homes are being built, and business in general is steadily moving along. The agricultural college opened this year under very flattering prospects, having several more professors than formerly, and its halls instructing over two hundred and fifty students. The new five story dormitory for boys, recently erected, and supposed to meet the demands of the institution for several years to come, is already crowded."

DEATH OF A NOTED PIONEER.

One of the earliest pioneers and enterprising citizens of Oregon, W. W. Chapman died at his home in Portland Tuesday, aged 82 years. It is a fact not generally known that Col. Chapman was a former resident of Corvallis. After distinguishing himself in public life as one of the pioneers of Iowa, he crossed the plains with a small company, consisting of the Chapmans, Gilberts, Starrs and Belknap, who on the evening of November 13th, 1847, reached Mary's river, near what was then called Maryville, now Corvallis. Col. Chapman and family remained during the winter, and moved to Salem where he engaged in the practice of law. From there he went to Oregon City, and made his way to Portland, where he became one of the town proprietors, and was instrumental in making that place the commercial metropolis of Oregon over Millwaukie and Oregon City, who were then striving for that position. He was also the moving spirit in the establishment of the Oregonian newspaper, and gave it its name. Mr. Chapman assisted all night to get out the first issue and hired a man with a horse to distribute them over the country on the west side of the Willamette as far up as Corvallis, and to return on the east side. Afterward during the Indian war troubles, John Kelsoy, of this city, was chosen colonel and Mr. Chapman lieutenant colonel of the Second Regiment of Oregon Volunteers. In the latter part of 1856 Col. Chapman returned to Corvallis with his family, and next year removed to Eugene where he was appointed surveyor general. From there he returned to Portland, where he was one of her most enterprising citizens up to the time of his demise.

ADJOURNED CITY COUNCIL MEETING.

The city council held an adjourned session Tuesday evening. All the members of the council were present except Job, Wilson and Gilson. An ordinance providing for the appointment of J. G. Kelley as engineer to prepare plans for the construction of sewerage and water works, to supersede the same; and his compensation for such work to be 10 per cent of all money expended for such improvements under \$25,000, and six per cent of all over that amount. The rules were suspended and after the ordinance was read the third time, all the members present except Edna voted for its passage. An ordinance was introduced providing for the awarding of contract for the repair of certain streets to D. A. Osburn. Hartless suggested that he be allowed until June 1st to complete his contract, and made a motion to that effect, which failed to carry. Wagoner then made a motion that it be specified that the contract be completed in sixty days, which carried. On motion the rules were suspended, and the ordinance was read the second and third times, when it was placed on its final passage, and defeated. On motion the council adjourned until October 31st.

THE CURFEW BILL.

It is an undisputed fact the curfew ordinance requiring all children to be off the streets by nine o'clock in the evening, unless they have legitimate business, is productive of the best results, notwithstanding statements to the contrary. As soon as the toll of the first bell denotes that the hour of nine is departing, there is a scattering among the "kids" in the direction of home, that is refreshing. When the curfew ordinance is strictly enforced in all its provisions, the tap of the fire bell answers a two-fold purpose. Besides the timely warning it gives to stray archers, it serves as a forcible reminder to husbands who are in the habit of staying out late at night, that it is time to his homeward, unless the lodge has a special call meeting.

AN IMPORTANT DECISION.

The supreme court decision in the case of J. E. Hamilton vs. T. J. Blair, et al, appealed from Benton county, has been published in full. The decision of the lower court was affirmed for the reason that the Salem Capital Flour Mills Co., who were a party to the suit in the trial court had not been served with a notice of appeal. The court found that the plaintiffs and defendants, Thomas Cooper, Marion Cooper, Cooper Bros., and G. H. Anderson have not received any part or portion of the wheat so stored in said warehouse, and thereafter made a decree in favor of the plaintiff, and the defendants in favor mentioned. From this decree the defendants, Hamilton, Job & Co. and J. E. Henkle & Co., appealed to the supreme court with the result above mentioned.

THE SUPREME COURT.

The supreme court has unanimously sustained the constitutionality of the Idaho test oath law. This provision refers to Mormons who apply for registration for the purpose of voting, who are required to subscribe to the constitutional provision which requires that he shall not practice polygamy or belong to an organization that teaches or encourages it. The additional qualifications passed by the last legislature, is that the elector shall not since January, 1888, have belonged to an organization that teaches or has taught, encouraged or had encouraged polygamy.

THE FOLLOWING OFFICERS.

The following officers of the Congregational Sunday school were elected for the ensuing year at its meeting last Sunday: Superintendent, Mrs. W. C. Kantner; assistant superintendent, C. C. Hoque; secretary, A. Wilkins; librarian, Miss Hattie Gaines, choirster, Henry Kothaner; organist, Mrs. F. Berthold; assistant organist, Miss Louise Fisher. With such an efficient list of officers and an able corps of teachers, they are well equipped for an earnest year's work for the master. Instead of the usual sermon last Sunday evening, a most interesting song service was rendered, which was acceptably received.
