LOCAL HAPPENINGS.

Guy Huff, of Eugene, visited friends in Corvallis Tuesday and Wednesday.

Miss Elsie Felling, of Portland, is visiting in Corvallis the guest of her friend Miss Amy Plummer.

Master Suey Hong, of Albany, oldest son of Jim Westfall's partner, made the Gazette a pleasant call Tuesday.

Mrs. Conrad Mayer, of Albany, was a visitor in Corvallis this week, the guest of her mother, Mrs. Philip Phil.

Harry Caples, of Columbia City, a student of the O. A. C. during 1891-93, visited among old school friends last week.

C. D. Ford, a prominent business man of Salem, and brother of the well-known lawyer T. L. Ford, spent Sunday in Corvallis.

President J. M. Bloss has been invited to deliver the address before the graduating class of the Eugene high school February 8th.

Died, Tuesday, the three-year-old daughter of H. H. Starr, of scarlet fever. Burial occurred Wednesday afternoon in Bell-fountain cemetery.

Segregations from the 1894 tax roll show total amount of assessable property within the city limits to be \$731,128, and in school district No. 9, \$925,305.

W. W. Collins, one of Polk county's well-to-do farmers, spent Friday and Saturday in Corvallis visiting his daughter Laura, who is attending college here.

Rev. J. M. Shules, a prominent minister of Salem, has been assisting Rev. Hiram Gould, of this city, in conducting protracted meetings at the Methodist church during the past week.

The council will ask the legislature to amend subdivision 1, of section 27, chapter 5, of the charter, by giving it the power to provide what proportion of the city taxes shall be paid in cash.

P. Nash, who has kept readers of the GAZETTE informed as to doings about the college during the past few months, left Monday for the metropolis, where he will enter the Portland Business College.

John H. Stewart, who took the anti-Dolph petition to Salem last Friday night returned Tuesday, and says the impression prevails at the capital that Dolph's election is impossible. His defeat is conceded by even his warmest supporters.

Our Alsea correspondent writes that "the feeling in the Alsea valley is almost unanimous against Dolph. We are glad to see the GAZETTE take the stand it has in the senatorial contest, and glad to learn that there is yet a possibility to defeat Dolph. He is not the man the people want."

Senator Mitchell has introduced and had reported to the senate from the committee on claims, a bill appropriating \$7000 for the relief of Sidney W. Morse, of Oregon City, for property taken from him by the government at Cape Disappointment in 1892. A similar bill appropriating the same sum for Peter Grant Stewart passed the senate a few days ago.

It may be of interest to the "great unwashed" to know that Panderson Avery has gone to the capital. Hearing that Dolph had a large barrel, he conceived the idea that something might be made by buying and selling democratic votes to Dolph. Look out, democrat. Pun is a shrewd dealer and is sure to make a large profit if he deals with you.

Arrangements are being made for a farmers' institute to be held at Woodburn, February 14 and 15th under the auspices of the Agricultural College. These institutes, held at short intervals throughout the state, are proving of incalculable benefit to the state and at the same time are extending the beneficial influence of the college to every locality in Oregon.

Word has been received that the special car, which has been held in waiting several days by the Southern Pacific to convey Senator Dolph, when elected, back to his duties at Washington, has been moved east. The managers having concluded a senator would probably be elected in which the S. P. would have no special interest, and who would travel on the ordinary train.

Edwin Jackson was examined Tuesday morning on a complaint of insanity, before Justice H. L. Holgate, acting for Judge Hufford, who was absent in Salem. The examination was made by Drs. Pernot and Farrar, who decided that he was insane. Upon this evidence, Jackson was committed to the asylum, and was taken to Salem on the noon train by Sheriff Osburn, assisted by Grover Headrick.

The Ladies' Coffee Club held their regular monthly meeting Monday afternoon, at which time a committee was appointed to confer with the other companies in the fire department, relative to purchasing a piano. For some time, the matter of either purchasing or renting a piano has been discussed, but no definite action in the matter has so far been taken. It is sincerely to be hoped that the plan will be carried on to a successful consummation.

D. B. Irvine and family left with their household effects last week for Salem, where they will reside in the future. Mr. Irvine has rented a building in the capital city, and will at once open a shoe manufacturing establishment. His business here will be continued by his son. Mr. Irvine has been in business in Corvallis continuously for over 25 years, during which time he has made many friends, who will wish him much success in his new location.

Captain M. Buchanan, deputy United States surveyor, located at Nehalem, was married a week ago last Monday evening to Mrs. H. A. Atwood, at the Perkins hotel in Portland. The bride was a resident of Corvallis for many years, where, by her kind and obliging manner and charitable disposition, she became the center of a large circle of friends, all of whom will be pleased to hear of her marriage. The groom is said to be a gentleman of considerable wealth and influence. After a brief wedding tour the happy couple will take up their permanent residence at Nehalem.

Congressman Hermann has been endeavoring for some time to secure a pension for the survivors of Indian wars of 1847 and 1848, in which Dr. Whitman was killed, and for the survivors of Indian wars in Oregon between 1851 and 1856. In order to secure stronger support for these measures he has introduced a general bill to pension all survivors of Indian wars prior to 1856 not entitled to pensions under existing laws. Mr. Hermann has also introduced a bill on which he has secured the endorsement of the secretary of the navy, granting certain ordinance flags to the soldiers' home at Roseburg.

Monday's train carried to the state capital a coterie of professional wire-pullers, which, it was thought, would straightway work a change in the senatorial situation. With such an array of eloquence, influence and shrewdness as was represented by Messrs. Hufford, Moore and Davison, it seems incredible that the fight would be prolonged for a day. The attempt of these men to override public sentiment in the interest of Dolph is meeting with deserved disapproval. It is unfortunate that one of Mr. Davison's promises and usual good judgment should be identified with such an unpopular movement.

Under the management of the King's Daughters of the Episcopal church, a very successful sociable and entertainment was given at the residence of H. R. Clark on Saturday evening. Stereoscopic views and pantomime pictures formed the first part of the entertainment. Of these, club singing by Will Keady was clever and much appreciated. After this, Mr. Clark, daughter and Miss Fisher rendered some choice musical selections. Refreshments were served at 10 o'clock and dancing concluded the evening at eleven. Ten cents was charged each person and a neat sum realized for the benefit of the church.

The "Maid of the Mist" were happily surprised Saturday afternoon at the home of Mrs. Minnie Lee by the advent of a few gentlemen friends whom the hostess had invited to take tea with the club at the conclusion of its meeting. From half-past five until six, merriment reigned supreme. Following the refreshments, dancing was in order. At a special meeting of the council Monday evening the tax levy for the ensuing year was fixed at 7 mills—5 for city purposes, and 2 for street improvements—being the same levy as last year. A petition was presented, asking the council to assume the expenses of Sol Smith, who was injured at the fire Monday morning. This called forth some discussion, which showed that a commendable spirit existed toward the fire department, and a general desire prevailed to assume young Smith's expenses, because he was injured while serving the city in the capacity of a volunteer fireman. The matter was referred to a special committee, consisting of Gibson, Edlin and Lee. A committee was also appointed to confer with the water company with regard to securing more efficient service.

February 9th, Prof. Will Lee will close a very successful term of school in the Bell-fountain district. For five months the school has been in session continuously, during which time Prof. Lee has proved a competent and painstaking instructor and became deservedly popular with his forty-five pupils. On the evening of February 9, a literary and musical program will be rendered, followed by a "shadow social," the proceeds of which will be donated to the school and literary society connected with it. Each lady attending is requested to provide lunch for herself and prospective partner. The selection of partners is to be a novel feature. The form of each lady will be reflected against a curtain, the highest bidder in each instance to take the lunch, together with the girl represented by the shadow.

THREE LOVELY FACES.

Three lovely viages graced the sacred precincts of Justice Wilson's court Monday afternoon. They belonged to Harry White, Jack Dennis and Ralph Daniels, three Corvallis gentlemen of leisure who were charged with the larceny of sundry bottles of liquor from the Palace saloon during Monday morning's fire. All three bore on their countenances the evidence that they had been drinking something stronger than "Willamette." White was tried first and conducted his own defense. He showed considerable aptitude as a lawyer and had undoubtedly been in police courts before. Notwithstanding that he admitted stealing the goods on being arrested, the evidence was not strong enough to convict him. The evidence in the other two cases being similar, on motion of Mr. Yates they were dismissed. Mr. White, the proprietor of the saloon, lost about \$100 worth of goods through theft. Corvallis has quite a number of idle gentlemen whose presence, simply as citizens, would be readily dispensed with. The recent fire revealed a mob of looters whom it is impossible to punish owing to lack of evidence. These fellows, of whom there are at least a dozen, are a constant menace to the safety of property and the welfare of the community. The three in the justice's court Monday were but a fair sample of their kind. The police should invite them to use dispatch in seeking a more congenial climate.

GRANT'S "LIFE AS AN ART."

A Synopsis of the Lecture on This Subject by Dr. Roland D. Grant.

So seldom is it that we hear an address as once so instructive, so fascinating, so charged with food for thought, as that delivered by Dr. Roland Grant, at the opera house last Thursday evening, that we make bold to attempt a synopsis or general outline of this album of word-pictures, for the benefit of those of our readers who were so unfortunate as not to hear it.

"Life," said Mr. Grant, "is far more than a science. Life is an art. Art is an ambiguous term, usually meaning the completion of nature." The speaker proceeded to show, with remarkable clearness, the nice distinction between science and art; deducing from his logical analyses of the two terms the plain and concise conclusion that "science consists in knowing; art consists in doing." Nature overlooks much in perfecting her work. It is science that knows how to make up the deficiencies, and the cunning hand of art that accomplishes the desired result. Science conforms to rules, but art breaks all rules. Demanding freedom from her workings, she laughs at laws, and reveals in the light of her own ingenuity. To be artistic does not necessarily mean perfection. In fact, it is in the very absence of this quality that the art sometimes exists. How much more picturesque and artistic are the decayed and crumbling walls of some old castle, than when they stood in frowning perfection—monuments of the ideal in architecture of their time. Symmetry is but another word for art; but when this resolves itself into set lines and exact proportions it loses its charm. A line may be drawn so true and perfect that it will be displeasing to the sight, just as a discordant tone in music will jar upon the ear.

After a brief exordium, of which the above is a very crude sketch, he passed on to the relation of the beautiful and artistic to our daily lives. We are all artists in the workshop of life, completing or perfecting the work which nature has begun. Our physical, mental and spiritual being are to be developed and cultivated. It is but right and a duty we owe to ourselves, to ornament our minds with the bric-a-brac of knowledge and adorn our bodies with pleasing dress. It is our duty also to cover up the dark and ugly scars wrought by tribulation and trial, and show to the world a countenance fair and inviting. "But," says one, "that would be a cheat and a lie!" Well then, we will cease to deceive, by covering the unsightly laths and rough boards of our homes with plaster and paint, for this too is "a cheat and a lie." Shall we beautify our homes, and permit our lives to be seen forbidding and unattractive? 'Tis well to let our deeds be open and free for inspection, but these are but the glass before the picture; the canvases should be impervious to sight.

Each day we add another sketch to the pictures we have been hanging in life's gallery. Our earlier paintings, and not a few of the later ones, are liberally daubed with green. There are two kinds of greenhorns: "The country greenhorn, who would like to know it all; and the city greenhorn, who thinks he can tell him."

"The future lies behind us, the past is before us," said Mr. Grant. We see the past, but the future is hidden until the shadows of coming events fall upon our shoulders. We should grasp each opportunity as it flashes by on wings of time, and trace thereon some form of beauty, so that all shall be pleasing in our wake, as the rose makes fragrant the breeze as it passes. Life and living are not the same thing. How many walk through nature's galleries, seeing nothing but the outlines of the paintings; feeling no thrill at the grandeur of the productions of the Master artist. Mr. Grant related an incident, which was very amusing and an excellent illustration of this point. In company with one of America's leading artists, and a mutual friend—a very prosaic, unimaginative sort of person—Dr. Grant was exploring the beautiful White Mountains of New Hampshire. The artistic gentleman was in advance of the others, and rounding a point of rocks, came in full view of that massive pile of granite, "The Man of the Mountain." Award by the grandeur of the scene, the artist stood spell-bound, looking through nature's art to nature's God. While he gazed, unconscious of everything but the sublime and awful spectacle before him, his matter-of-fact friend came puffing around the point, catching sight of the huge mass of stone, he wiped the perspiration from his burning brow and exclaimed: "My gosh, what a pile of rocks!"

We are each the publisher of a daily paper, whose files will be the record of our life. How careful and particular we should be in the selection of our copy; and how thoroughly the proofs should be read and corrected! We do not want for subscribers, for all our acquaintances take a copy, and in the event of the publication of a sensational article they take two copies—one to give away. In youth we are apt to do with pride, what in after years we will look back upon with sorrow and humiliation. The very things of which young men boast, old men repent.

Not a moment should be wasted in building the moonlight of character. If we would have our work perfect; no flaw or blemish, nor evidence of crude workmanship, we must improve every opportunity. Life is too brief to complete more than one statue of our character, and the utmost caution should attend every blow given to the chisel, that no fractures shall result. Better to make haste slowly, and strike forty blows to accomplish our purpose, than to strike one heavy one and destroy all our previous work. Michael Angelo could see at a glance, just where an alteration was needed in his model, and could fly at it like a madman, never making a false stroke, nor cutting too deep. But there was only one Michael Angelo. Man is born at a disadvantage over other animals. He is twelve years of age before he has a thought of his own and it is six years more before he has a sensible one. The fish never knows who his mother was, but is obliged to begin life on its own hook, and it is kept busy ever afterward trying to keep off the hooks of others. After reaching the age of 18 or 20 years, there is a period—the speaker placed

much emphasis on the word "period," and descended from this "ridgy" position to note the time taken up by sleep and sickness, which leaves us only a comparatively few years to complete our labors.

We should strive to make our picture original. Our characteristics should name or determine us. It was only necessary for Mr. Grant to trace in imagination the form of a man standing on the deck of a ship, his arms folded, his face lit up with the joy of a cherished hope realized, while at his feet knelt a score of Spanish sailors, and to place upon the vessel's bow the figures 1492, to bring to every lip the word "Columbus." The vision of a man, with powdered hair, and dressed in the fashion of our revolutionary fathers, is brought before us. He is standing, pen in hand, before a table upon which lies a document the only part of whose contents we can see is the final of one word—"Independence," and we see in letters of living light the name "Benjamin Franklin." Again we are in a room in which a man sits writing. His face is wrinkled and thoughtful, yet kind. His brow is marked with deep furrows; each furrow the grave of thousands of Union soldiers. We can catch the word "Emancipation," and our heart thrills, while our very soul echoes the name of the martyred "Lincoln."

It was with much force and a thorough mastery of his subject that Mr. Grant covered the ground so rudely outlined above. He has an air, as natural to him as his breath, of self confidence, that inspires his hearers with belief. Ready, forceful, keen and animated, as well as witty, by turns, and thoroughly unartificial, he makes a most admirable platform speaker.

A REMARKABLE OPERATION.

The Democrat has already mentioned the operation recently performed by Dr. G. W. Maston, of this city assisted by Dr. Frank Cauthorn, of Portland, upon the person of M. P. Taylor of Corvallis. The operation was performed at the Portland hospital January 17th. The case is one that deserves more than a mere mention, for the operation was one of the most wonderful on the Pacific coast, and probably not excelled in extent in the United States. Dr. Maston returned last night from Portland, where he had been and removed the stitches from the wound, and left Mr. Taylor in excellent condition, happy at so favorable a result after so desperate an operation. He brought with him the tumor that caused the trouble, and the resected intestine attached, a sight of which only increases one's surprise at the successful termination of the operation. The editor of the Democrat, in measuring the intestine, done as usual, in measuring the figure showing the length of intestine removed, 44 1/2 inches, instead of 37 inches as reported. After measuring the intestine was inflated, showing the true situation and relative positions of tumor and intestine, and verifying the fact of the impossibility of removing the growth alone. The whole will be placed in alcohol to preserve it, and it will always speak for itself in connection with the operation. The case was Dr. Maston's and the operation was performed by him, assisted by Dr. Frank Cauthorn, of Portland. The work was done in the presence of several surgeons of Portland and the senior class of the medical department of the Willamette university. This operation reflects great credit on the surgeons performing it, and the Democrat takes great pride in giving the facts, as the principal in the case is an Albany surgeon.—Albany Democrat.

DOLPH IN BENTON COUNTY.

The People of Benton Against the Simon Senator—Cooper's Bolt Approved.

On Friday last our city was treated to a novel free entertainment. Word reached here just after dinner that Representative Cooper had bolted Dolph and was on the side of the people. Immediately a spirit of activity manifested itself among the Corvallis worshippers of the senatorial iceberg, and they began searching the highways and byways for signatures to a petition announcing that the people of Benton county were staying awake at night praying for the re-election of Dolph. The First National Bank furnished three names. It is but a half block from there to Mr. Kline's store where the proprietor and his four clerks swelled the document to formidable proportions. Stopping at Tammany Hall three more names were obtained. But even this gigantic list did not cool the ardor of the devotees of the Portland lawyer, who has been dubbed "His Whiskers," against the frantic protests of the Oregonian. Couriers were at once dispatched to the neighboring precincts, and in less than two days a whole sheet of legal-cap paper was covered with signatures aggregating the enormous number of twenty-eight names. It seems inconceivable that Mr. Cooper can disregard this evidence of the will of his constituents. The prime movers in the circulation of the petition were a bank cashier and an amateur money-broker who have long been known as having the interests of the people at heart. The presence of the names of these two gentlemen alone on the petition ought to satisfy our representatives that the popular sentiment in Benton county is overwhelmingly in favor of the deliverer of cold-storage speeches. There is no doubt that Mr. Daly can interpret the will of the people by means of the petition headed by Mr. Peet and Mr. Davison, as favorable to Dolph. It is feared, however, that Messrs. Carter and Cooper will not possess the acuteness of acumen to perceive that the list is an aggregation of all that is good and holy in Benton county republicanism. It is so unusual for banks, corporations, and money-lenders to favor the re-election of Dolph, that the manly and independent stand of the gentleman sending the petition, will insure to their already great and deserved popularity. By this single act they have perpetually endeared themselves to the people. So much confidence have the masses in anything that might be advocated by these gentlemen that several of those who signed the petition did so not knowing whether it asked the county court to fill up a mudhole on the Greasy road or prayed that congress pass the Nicaraguan canal bill. Of the twenty-eight who signed the petition four are known to be anti-Dolph men. As near as can be learned the list was as follows: R. M. Davison, W. T. Peet, M. S. Woodcock, Geo. Lilly, S. L. Kline, W. S. Linville, Luther Smith, Victor Hart, E. Eyer, W. S. Hufford, B. W. Wilson, F. M. Johnson, Norm Lilly, Joe Firestein, A. M. Witham, S. L. Shedd, E. Allen, William Groves, N. R. Barber, Grover Hedrick, Cam Hemphill, John Simpson, Robert Wilson, A. R. Pygall, Wm. Wright, J. G. Wuestefeld, L. Walker, Jake Weber. The last four are anti-Dolph men.

The GAZETTE was one of the first papers to oppose the re-election of J. N. Dolph. It was the contention of this paper first, that he was not the best man that could be chosen for the position, and that the sentiment of the people of Benton county was clearly against him. Events have proven that throughout the state the June election was not the result of any popularity of Dolph. That the position of the GAZETTE is approved by the great body of republicans voters in the county, is evidenced by the enthusiasm manifested over Representative Cooper's change, and also by the numerous congratulatory telegrams and monster anti-Dolph petitions sent him since last Friday. The people of Benton have never forgiven Simon's treachery to his party in defeating Judge Waldo, and later on, in the knifing of D. P. Thompson, who ran for governor against Penney in 1890. The ring, represented by Simon, has ever been in opposition to legislation favorable to the voters of this county. The Oregonian is the organ of the cabal. It has ever sneered at the Yakima law as a harbor, and but recently demanded legislation that would lose to the Agricultural College. Those who hob nob with and further the interest of this damnable Portland clique are disloyal to the best interests of the state. Local pride and local patriotism should cause every honorable citizen of Benton county to work for the overthrow of the Portland political machine. Dolph is the puppet of that ring, and the manager of his campaign is Joe Simon. The people of this county are strongly against perpetuating this Simon combination, and Mr. Cooper, by his vote of Friday, has made himself the most popular man in old Benton. There was no difficulty experienced in getting signatures to the anti-Dolph petition. All day Saturday republicans were calling at the GAZETTE office in search of the man with the petition, which asked our representatives to hold out against the election of Mr. Dolph. In two hours Friday evening seventy-two names were obtained to a petition, commending Mr. Cooper's course, and was sent to him that night by special carrier. Monday, another one from Corvallis was sent to Salem, containing in the neighborhood of a hundred names. Similar ones are being sent from every precinct in the county. Friday one was sent from Philomath, which is said to have contained the name of nearly every republican in the precinct. Every signature thus obtained is a further evidence that the GAZETTE, in its fight against Dolph, is expressing the will of the people and is in touch with their sympathies. One anti-Dolph petition sent from Corvallis contained the following named persons, a majority of whom were members of the Benton County Republican Club, while quite a number were delegates to the county convention last spring.
