A STARTLING REVELATION.

The Oregonian, after a great amount of hypocritical apology, pretends to regretfully inform the members of the legislature, who daily meet and converse with Governor Lord, that he is deaf. It seems that Scott has for some time felt his duty to give this bit of information to the men who have been voting for Governor Lord, but felt a little delicate about it, probably feeling the governor's friends would not know what he was driving at. That's all right, Scott! everyone knows just what you mean, and those who are associating with Governor Lord daily will understand the delicacy you must feel in saying this. However, you should have spoken sooner, you should have let this little secret out before the people selected this man to sit on the supreme bench of the state. He has been allowed to decide arguments made before his court by many of the ablest lawyers of Oregon. What a pity you did not let these lawyers know they were reading and deciding to a deaf man. You might have prevented them from placing themselves in such a ridiculous position, and also saved to their clients the cost of fees paid to them.

Why did you not tell this sooner? You might have prevented your loved state from making an ass of itself by electing this deaf man, by large majorities, to two of the most important offices in the state. O, Scott! what a blunderer you are! Don't you suppose the people at Salem, and indeed most of them throughout the state, know Governor Lord quite as well as you do? Don't you think all will understand the deliberate malice you make so poor a pretense of concealing under expressions of delicacy? But! If you feel it your duty to speak of physical defects, why not overcome your delicacy, entirely, and say that Dolph, the man whom you are trying to elect for U. S. senator, is affected with diabetes, and could not, if elected, enjoy the magnificent dinners to which he would surely be invited by the great corporations. When you feel these impulses to be honest, don't stifle them; tell it all. Say that Dolph is deaf, stone deaf—in the heart—and has been thus many years. So deaf, in fact, that he cannot hear the almost united voices of the people of Oregon, who are demanding in thunder tones that he sit down.

THOMAS H. COOPER is a man. He will not be fooled. Since his visit to Corvallis a week ago last Saturday and Sunday, when he conferred with his constituents, he fully understands that the sentiment in Benton county is overwhelmingly against the Simon ring and the return of Dolph. He knows that the voters want someone else than Simon's puppet to represent their interests in the legislature of the nation. He knows, too, that only the bosses, ringsters and professional federal paper-pushers want Dolph returned. Mr. Cooper is fully aware that Dolph's course has been injurious to the best interests of the state and the republican party. By his action in again leaving the support of the senatorial ring last week, notwithstanding the heavy pressure brought to bear against such a move, Mr. Cooper showed that he was made of the right material. The courage and manhood displayed by him at that time will never be forgotten. His constituents almost unanimously commend his course. While it may be true that by his change he has incurred the everlasting displeasure of the Simon ring, and lost the political friendship of perhaps a half dozen Benton county bosses, the rank and file of Benton's republican voters will always remember Don Thomas H. Cooper as the representative who dared to raise his voice and cast his vote for the people.

THE Oregonian, with its usual duplicity, complains that the anti-Dolph members in the legislature are obstructing useful legislation in order to bring the majority to terms. Before the minority can effect anything of the kind it must be assisted by the democrats and populists, who, as everyone knows, are keeping hands off. It is a shame that the great daily will report to such stupid charges. It is a time honored custom of the Simon ring to keep control of the senate, and make all legislation dependent upon the house in supporting its schemes and electing its pets. Every man, who has been about the capitol during the session of the legislature, or in any way conversant with Simon's methods, knows this to be true. Joseph generally works up a few county division schemes in order to have a leverage upon those who oppose or advocate them. Simon would favor the division of Multnomah county if he could thereby secure the much needed, but never to be obtained, votes for Dolph.

THE great daily says the men who are opposing Dolph were of no prominence until their election took place. This may be true. The greatest safeguard to our liberty lies in the fact that prominent men are continually being sent to the rear, while those not so prominent are forging to the front. All great ideas as well as great men, while advancing from comparative obscurity have met a mournful procession of worn-out men and ideas on their way to the rear.

SENATE BILL NO. 99.

There is an interesting bill in the senate, bearing the number indicated above, in which relief to the amount of \$20,000 is provided for Iva Templeton, of Linn county, for injuries sustained on a public highway in 1890. The OREGONIAN has obtained the following history of the matter from a reliable source: It seems that in July, 1890, Iva Templeton, and some others were returning from a berrying trip in the mountains, and they came to a bridge over the Callipoola creek in Linn county. The others got out, and Iva drove on the bridge, down a steep bank, and when the wagon got on the bridge it fell down, throwing the whole business, girl, wagon, team and bridge, so fast below, into the water among the rocks. Her arm was broken and the use of it destroyed; her leg was broken, and the bone forced through the flesh; and all of her clothing remained in that condition for several hours. Afterward the leg had to be amputated, between the thigh and knee. Her teeth were knocked out, and her face disfigured for life.

She had to pay out several thousand dollars for attendance and medical skill, and was confined to her bed for a year, and now goes on crutches, an invalid, and almost helpless, all on account of that accident.

One would naturally ask, "Why didn't she sue Linn county for damages?" So she did, but in 1897 the legislature had amended a law allowing damages for such accidents, by which amendment she was prevented from obtaining damages from the county, although the constitution of the state plainly declares that everyone shall have a remedy by due course of law for such an injury. The supreme court decided against her and she was cut off from any remedy. Judge Lord, in his opinion in that case said she ought to have her remedy and that the county was liable, but Judges Straffen and Bean thought otherwise, as a point of law. When the case was decided and its effect seen, the law was again changed by the legislature and persons now have remedy against the county for such injuries, but such has been once she cannot come in again, and hence must ask the legislature for relief. It is right that the legislature should grant it because, having taken away her remedy, it leaves her without the protection guaranteed to every person of the state under the constitution. It was the only case which came up under that defective law and cannot stand as a precedent for any other case in the future because the victim of any similar accident in the future can obtain redress through the courts—the redress which that defective statute denied to her.

She was a lovely young woman before this accident and was left a helpless invalid and maimed and disfigured for life, and constantly at expense for medicines and treatment for internal injuries sustained in the same accident, and if the relief granted in the bill is allowed she will be able to pay off the debts this accident cost her, and have, by safe methods of investment, just about enough income to provide the necessities of life and pay for medical attendance.

The case is an aggravated one, and one which appeals to the manhood and sense of justice of every one who knows the true condition of the case; and the seal of approbation to this relief bill has been put into expression by a petition of over 1,420 taxpayers in the state, who know the case and all about it. The judge who rendered the decision against her damage case, and the attorneys who defended the case, all signed the petitions for her relief, and it is just one of those unfortunate cases, for which the laws failed to provide a remedy, and as the legislature was responsible for taking away her remedy, although ignorant of the consequences of its act, so the legislature should restore her injuries, and pass the bill.

THE devil rebuking sin! History repeats itself, and the illustrious example referred to above was reproduced Friday, when Joe Simon stood up in the Oregon senate to rebuke corruption and advocate moral reform in high places. Ye gods! What a spectacle this must have been, when the little corruptionist—the man who for thirty years has stood a perfect emblem of intrigue and corruption in politics and state legislation—stood on the senate floor and in easy flowing words denounced intrigue, and recommended reform. Selah.

MR. DALY'S house bill No. 64 passed the house Friday. This result was unlooked for by members of the school land ring, who have fattened for years by a system of speculation and jobbery which should have been broken up years ago. The real object of the bill is to take out of the hands of this ring of speculators some 250,000 acres of land falling to the state within the Cascade forest reserve. The bill is one of the most meritorious ones before the legislature, and should pass the senate without a dissenting vote.

DOLPH's friends are vehemently demanding that aspirants for the senatorship shall withdraw and keep hands off. How many people in the state remember how this same Dolph, who pretended to be a friend of J. H. Mitchell, deliberately prevented his election in order to secure the place for himself twelve years ago? Dolph has no strings on anyone; the strings are all on him. Poor old fellow!

It is a fact, but perhaps not a surprising one, that the man who is at the head of the movement in England for protection against American cattle is the man who was at the head of the free trade dinner given to Mr. Wilson in London.

THE Simon ring has heretofore made its reckoning without consulting with its host. The obscure thirty, which the Oregonian complains of, represent the neglected party who now insists on looking over the items.

THE Oregonian opposes the candidacy of Gov. Lord for senator, but has failed to find anything in his public or private record to charge against him, so it vitely attacks him on account of a slight physical defect. The hearing of Mr. Lord was injured during the late civil war, by the explosion of a cannon, while he was fighting for the preservation of the union. His hearing was not destroyed, and the defect has not interfered with the discharge of his duties as a public man. Mr. Scott came to Oregon to avoid service in the army, and has little sympathy with those who were so foolish as to risk life, limb, sight or hearing on the battle field. The editor of the Oregonian knows that Governor Lord's impairment of hearing does not prevent him from capably discharging public duties, but to the editor's mind the manner in which he received disability shows him to be a man of poor judgment. The Oregonian recognizes in Mr. Lord the logical compromise candidate for senator, and hates him for it. Not that it likes Mr. Lord the less, but it loves Mr. Dolph the more.

HOUSE BILL NO. 53 provides for an annual state license of \$50 for fire insurance companies and \$100 for life insurance companies. Benevolent and fraternal organizations, such as masons, workmen, etc., are exempted. There is a similar law in Washington and other states, and if this bill is enacted it will result in increasing the revenue of the state some \$300,000, considerably relieving the burden of taxation on property. The provisions of the proposed law are just and equitable, and it should have the support of all true economists in the legislature.

MR. H. W. CORBETT entertained a few members of the legislature with a banquet at the HOTEL PORTLAND Saturday evening. However, but twenty-six out of ninety members attended, which is a credit to the good cause of the majority. Mr. Corbett may be working wisely in the interest of the public, but to attempt to influence the legislature in this manner, even for good purposes, is wrong, and shows bad taste. The Oregonian lauds the banquet, but had Mr. Hume been the host, Mr. Scott would have exhausted his large list of epigrams in denouncing it.

COUNCIL NOTES.

At the regular monthly meeting of the city council Monday all members were present excepting Eglin and Lee.

The finance committee made a verbal report to the effect that Messrs. Hodes & Hall had refused to accept the lease recently made for the old engine house. Bills to the amount of \$336.63 were allowed and ordered paid.

An application of Ben Woldt to have his saloon license transferred from 2nd and Madison streets, to 2nd and Jefferson streets, and that same take effect on the first of June next, and continue for the unexpired term, which is about five months, was referred to the finance committee.

An ordinance was introduced by councilman Waggoner to repeal the ordinance recently passed, leasing the old engine house. A motion to suspend the rules and put the bill on its final passage, failed to receive the necessary two-thirds vote, and was lost. Waggoner and Greffoz voting in the negative.

The fire and water committee was instructed to correspond with sister cities in regard to service and prices of maintaining fire hydrants, and report what in their judgment the city needs.

DIED.

Death entered the home of William Mackay last Sunday morning at 10 o'clock and claimed a loving wife and mother. The funeral occurred Tuesday morning at St. Mary's church, of which Mrs. Mackay was a member, and the remains were interred in the Catholic cemetery. Mrs. Mackay, whose maiden name was Theresa M. McGrath, was born near Ottawa, Canada, Nov. 30, 1811, and was therefore a little more than 83 years old. April 29, 1862, she was married to William Mackay and two years later they started on their long and perilous voyage by way of Panama, moving for Corvallis, Oregon, where they arrived Nov. 30, 1864. The next year she and her husband moved to their homestead near Toledo, on Yaquina bay. Here they resided continuously until Mr. Mackay was elected sheriff of Benton, necessitating his residing in Corvallis. Mrs. Mackay leaves a husband and eight daughters to mourn her demise. The deceased has a brother living on Coos bay and a sister in Iowa.

Few can realize what it is to be an invalid for over seventeen years and what must have been endured by the deceased during her long hours of affliction. Her death was caused by a continued attack of nervous prostration, yet during all her pain and suffering she was resigned to what she could not control. A zealous Christian, she died in the faith she had known since childhood. Many friends mourn her loss and extend their sympathy to the bereaved family.

A RECEIVER APPOINTED.

The Corvallis public will note with regret that the Northwest Fire and Marine Insurance Co. has determined to wind up its business and retire from the insurance field. The insurance business on this coast has been unprofitable for several years and the Northwest has made a gallant fight against these adverse conditions, but was finally compelled to succumb to them. F. M. Johnson, who has been the company's agent in this city for several years, has arranged with the Zena Insurance Company of Hartford, Conn., assets \$11,000,000, to take up all Northwest policies written in his agency.

The Zena, as everyone knows who is at all familiar with the insurance business, is one of the oldest and best-managed companies in the world. On account of the absolute security furnished by the Zena, it is a matter of congratulation to Northwest policyholders that Mr. Johnson was able to make so favorable an arrangement without loss to his patrons. The Northwest, with its \$500,000 deposit with the state treasurer and other large assets, will, in all probability, be able to meet any losses occurring while its affairs are being settled up by Receiver Allison. The real cause of the collapse was the result of heavy losses sustained in the state of Washington during the year 1891. From the effect of this heavy drain on its assets and the continued depressed condition of underwriting, the company was unable to make money for its stockholders, and so concluded to retire from the field altogether. The Northwest has done a large business in Corvallis and was always very prompt in the settlement of its losses. Stock in the company to the amount of about \$10,000 was held by citizens of Corvallis.

Closing out sale at Stock's.

The Southern Pacific Railroad Company has issued a new local freight rate between Portland and Corvallis. Freight in any quantity regardless of classification unless regular tariff provides lower (powder excepted) 12 1/2 cents per 100 pounds. Lime, cement, plaster, nails, coal and coke in sacks; binding twine, fence wire, salt, pig iron and shingles, at estimated weight of 50 pounds per bundle, any quantity, 7 1/2 cents per 100 pounds.

Mrs. E. E. Paddock, of Independence, is visiting relatives in this city during the absence of her husband, who is now in Wisconsin looking for a business opening. Mr. Paddock has for some time past been seriously considering the advisability of returning to the east, where he was in business prior to locating in Oregon. He is expected back about the first of March, and if he succeeds in finding a suitable business opening during his absence he and his estimable wife will most likely remove to the east at an early date.

A. G. Long, of Portland, representing the Fire Extinguisher Manufacturing Co., of Chicago, was in Corvallis yesterday, interviewing members of the city council relative to the purchase of a chemical engine. Such an engine as would be suited to the needs of Corvallis would cost \$1,975. These extinguishers are coming into general use throughout the country. They are light and can be gotten to a fire with much more ease and rapidly than with an ordinary engine. The size of the engine which Mr. Long is desirous of selling to Corvallis, has two 35-gallon cylinders, the contents of the two being equal to 2,800 gallons of water. That is, each gallon of the chemical preparation contained in the cylinders is equal to 40 gallons of water. The chemical extinguisher is designed especially for use at small fires and does very effective service. The cylinders are charged to about 100 pounds pressure to the square inch and throw a stream through a three-eighth inch nozzle sixty or seventy feet.

Frank Hughes, a prominent resident of Lobster precinct, made the GAZETTE office a pleasant call this week. Mr. Hughes is considerably interested in getting a law passed to compel the recording of all conveyances, especially patents from the government. He says the Southern Pacific company has title to several thousand acres of land in the Alsea valley, which remains unoccupied from year to year, because the assessor is unable to locate and describe the lands, owing to the company's failure to have its patents recorded. Such a bill as Mr. Hughes suggests could hardly become a law, and if it did its operation would work numerous hardships. The trouble might be avoided by an act of congress which, upon the granting of a patent, would require all government land offices to advise the clerks of the several counties in their respective districts of the issuance of such patent, describing the lands so conveyed. By the operation of this plan it would be impossible for any lands, especially the large grants, to escape taxation.

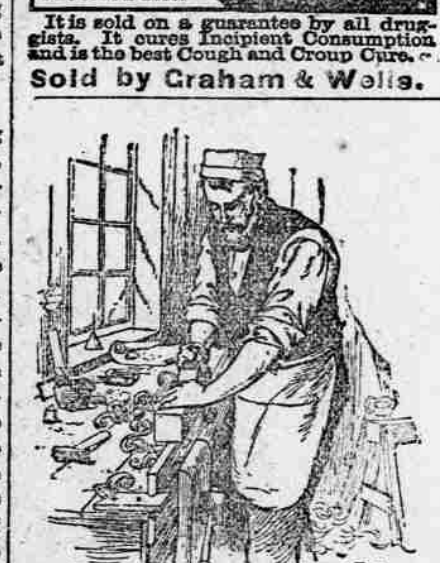
