BIG TIMES AT NEWPORT.

There will be big times at Newport next Sunday. Since the first of the month the trains have been crowded with Yaquina summer spenders. Next Saturday the immense throng already at the bay will be further augmented by the editors of the state. Ira Campbell of the Eugene Guard, writes Manager Stone that there will be 150 of the brethren with their female belongings, and a hundred and fifty newspaper men take up as much room and make more noise than 1,500 average folks. The first meeting of the press association will probably take place Saturday night. Sunday there will be an excursion from the valley towns to Newport. Round trip tickets have been placed at \$1.50, including the trip from Yaquina by the steamer Volante. The train will leave Corvallis at 7:30 a. m. and returning, the boat leaves Newport at 6:30 p. m. There will be a big crowd go over from Corvallis alone, and the railroad people are making arrangements to accommodate all. They have engaged several coaches from the Southern Pacific Company, so that none need be deterred from going on account of lack of seats.

A huge clam bake will take place in the afternoon under the immediate supervision of Mr. Malcomb, chef of the Hotel Portland. During the day the steamship "Farallon" will cross out over the bar with a deep sea fishing party. There will be the usual rowing, sailing and other attractions that make Newport so popular, and nothing will be left undone that will tend to enhance the pleasure of the excursionists. It will be the biggest day in the history of Newport.

The trip itself is a pleasant one. The roadbed has been placed in excellent shape and the bridges have been newly braced and strengthened, until now it is one of the best roads in the state. Manager Stone and Superintendent Clark are not only able railroad men, but they are clever and accommodating gentlemen, and they make a constant study of everything that will tend to the comfort and enjoyment of the patrons of the road. The press association will be under countless obligations to these gentlemen. The hotels will make efforts to feed the multitude that will gather on the seashore next Sunday.

The association will be in session three or four days. Besides the regular routine work there will be speeches and literary exercises and everything that newspaper men can think of to make an evening enjoyable. The Bachelor Quartette, of Corvallis, have responded to a pressing invitation and will warble their sweetest lays for the edification of the editorial car during the entire session. Miss Helen Holgate has kindly consented to accompany the boys in a dual capacity as accompanist and chaperone.

AN IMPORTANT TRANSFER.

Yesterday a deed was filed for record conveying to Assignee Bryson all the real property of B. R. Job and Zephin Job, which they were possessed at the time of making their assignment something over two years ago. In some respects this a very important transfer, and its announcement will be hailed with delight by the numerous creditors of the old firm of Hamilton, Job & Co., as the Job brothers are joined by their wives in executing the deed, which act will remove any cloud from the title to the realty in possession of the assignee and will enhance its selling price when offered for sale fully 25 per cent. Section 2,954 of the general laws of Oregon provides that "The widow of every deceased person shall be entitled to dower, or the use during her natural life, of one-half of all the lands whereof her husband was seized of an estate of an inheritance at any time during the marriage, unless she is lawfully barred thereof." As Job brothers were not joined by their wives in the execution of the original deed of assignment to Assignee Bryson they have retained their dower in all the realty at that time conveyed, and in the event of the death of either of the partners, his wife would have been entitled to a one-fourth interest, for life, in all the real property of the insolvent estate. The signing away of their interest at a nominal consideration—one dollar—when there existed no legal obligation to do so, is sufficient evidence that there has existed no desire on the part of Job brothers or their wives to defraud the creditors of Hamilton, Job & Co. Mrs. Zephin Job and Mrs. B. R. Job and their husbands are to be commended for the honorable and altogether unselfish action they have seen fit to take in the matter.
