Mr. Paul Downing, who is coaching the O. A. C. football team this season, returned from Portland Monday. He left here Friday evening and Saturday acted as referee in the football game between the Reliance team of Oakland, California, and the eleven of the Mutu-nomah Athletic Club.

T. J. Miller, a resident of Soap Creek precinct, was in town Tuesday. The previous day he had been kicked by a vicious horse, severely injuring his left knee cap. The fracture was reduced by Dr. C. H. Lee, and in a couple of weeks with proper care Mr. Miller will be able to be about his duties as formerly.

Wakefield, of Little Elk, Lincoln county, was in town Tuesday laying in his winter supply of groceries, etc. Mr. Wakefield came to Oregon within the past few years from Minnesota and is now one of its most prosperous citizens. He is a worker and a good manager and is extensively engaged in fruit growing, in which industry he has an abiding faith.

Another bachelor has succumbed to the wiles of Cupid. Though not at present a resident of Corvallis he was raised here and at one time was engaged in business in this city. The fortunate individual is Arthur E. Holgate, who was married last Sunday to Miss Magdalena Ruetter, of Portland. The ceremony was performed at the residence of the bride's sister, Mr. Holgate has many friends in Corvallis who will wish him a pleasant and prosperous journey through life.

Every advertised feature in "The Tornado" will be presented at the Opera House tonight.

Hundreds of boxes are now being turned out by Sheagreen & Newhouse for use in packing dried fruits. The prune boxes are neatly constructed of dressed cottonwood lumber, and the ends are labeled "Choice Oregon Dried Prunes." These boxes when filled will contain twenty-five pounds of dried fruit. The same firm is also turning out boxes for dried apples, which are about double the size of the prune boxes and hold fifty pounds. Orders for these boxes are coming in rapidly and before the season is over several thousand will likely be sold.

Several Corvallis hop-pickers are mourning the loss of their dollars paid to an independence photographer for pictures that never came. During the month of September a number of persons living in this vicinity were engaged in picking hops in the yard of Heron & Bonnie, near Buena Vista. A photographer came along and took cash orders for pictures of those working in the yard, agreeing to send the photographs the following Tuesday. About six weeks have since elapsed and the failure of the pictures to arrive is causing those who paid their hard-earned cash to believe they have been flimflammed.

A beautiful granite shaft has been raised on the Arnold lot in Crystal Lake cemetery, in memory of the late B. L. Arnold. The monument is nine feet high above the grass line and represents a cross. It is neatly engraved and is a handsome addition to the many beautiful monuments that are erected in honor of the departed that are buried in that quiet city of the dead. The shaft was made in San Francisco, by John Daniel & Co., of Barrie granite. It was shipped to Corvallis on the last steamer and was set up this week by John Scraftford, the well known marble cutter of this city.

Stock Inspector R. C. Kiger called at this office last week and requested the GAZETTE to call the attention of owners of scabby sheep to the fact that during the present month was the proper time for treatment of the disease. Mr. Kiger has already discovered two or three bands of scabby sheep and is of the opinion that there are others. Persons having knowledge of any such bands are requested to notify Mr. Kiger in order that he may require their owners to apply the proper remedies. Unless he is put in possession of the necessary information it will be impossible to prevent the spread of the disease with its attendant losses.

The small boys about town did not fail to observe Halloween this year. There was the usual carrying off of gates, signs, etc., and one of Wilkins' street cars was left under the trees on the college campus and covered with appropriate inscriptions. The old boards that did duty as a sidewalk across the old college block were thrown into the street, and if its removal would cause a new walk to be built, it is a pity that numerous others did not share the same fate. Last year the faculty was greatly annoyed by the pranks of the students, but this year, out of respect for Prof. Berchold, who is acting president during the absence of President Bloss, the boys refrained from molesting anything about the college premises.

Tuesday evening at the law office of E. E. Wilson J. M. Newman and Miss Clara Barnhart were united in marriage, Squire Wilson officiating. The groom is a resident of Columbus, Ohio, and at one time was employed at the carriage factory in this city. He is now representing a number of Ohio capitalists who are contemplating investing largely in Willamette valley fruit lands. It is understood that money has already been subscribed sufficient to purchase 1500 acres. Mr. Newman is in Oregon at this time to look over the situation and later will return and report the result of his investigations. He is perhaps more familiar with the advantages offered in Benton county than elsewhere, having resided here several months within the past two years. Mr. Newman and wife left yesterday for Roseburg.

REFEREE'S COURT.

Referee A. C. Woodcock held another adjourned sitting of his court Monday afternoon at the court house. Several attorneys were present, but as almost all of them were away for further time in which to complete their objections, the referee adjourned until 9 o'clock, Nov. 25, at which date objections to claims will be taken up and disposed of.

During Monday's session the tax claims of Marion and Benton counties were taken up. The Marion county claim was represented by Attorney Bigham, of Salem, and the claim of Benton county, by W. S. Hufford. At the time the last order of sale in the Oregon Pacific matter was made, the court found that there was taxes due Marion county for the years 1890, 1891 and 1892, amounting to \$7,040, and for the same years there was due Benton county the sum of \$25,020, and ordered that these sums be paid out of the first moneys coming into the hands of the court that were properly applicable to this purpose. Notwithstanding the terms of this order, other claimants have objected to payment to these tax claims and will doubtless make a vigorous fight against them. Attorneys Bigham and Hufford, however, have moved the referee to strike out all objections pertaining to the amounts ordered paid in the decree of Nov. 13, 1894, upon the ground that some have been adjudicated and the matter can not now be opened up.

In the interests of the taxpayers it is sincerely to be hoped that Messrs. Bigham and Hufford will be successful.

During the afternoon Attorney Wallis Nash, at the request of Col. T. E. Hogg, withdrew the latter's claim for additional compensation amounting to \$7,000, for services performed as receiver subsequent to the report of Referee Whalley. In withdrawing the claim Mr. Nash stated that he hoped the benefits would accrue to the labor claims.

The Quartet Concert.

The entertainment for the benefit of the O. A. C. football team was a genuine success. Notwithstanding the heavy rain storm, the college chapel was well filled with an appreciative audience. The stage had been arranged under the direction of Prof. Hedrich, and with its handsome furniture and beautiful plants delighted the eye. Those who attended the concert pronounce the program the most delightful that has been rendered in Corvallis for years.

The evening opened with a greeting song by the Bach Quartet. They responded by singing a new O. A. C. football song. This was received so enthusiastically that the quartet had to respond again. Prof. Berchold then talked football for a few minutes. His remarks were terse, sensible and very interesting. A flute duet by Prof. J. B. Horner and Mr. J. Fred Yates followed. The gentlemen showed proficiency with the instrument and had to respond to an encore.

Miss Mary Cundiff, of Albany, chose for her recitation Joaquin Miller's "Como." Later in the evening she recited an humorous sketch entitled "When Jack Comes Late." Miss Cundiff has good conception and her delivery is very clever. She greatly pleased the audience.

Mr. G. Lester Paul in his rendition of "How Ruby Played," captured the house. This was the first time Mr. Paul has been heard in so light a piece, but his delivery shows that he has a faculty of interpreting comedy as well as tragedy.

Miss Lillian Hamilton recited a poetical sketch written for the occasion entitled "What the Boys Didn't Do at Eugene," referring to the recent practice game at that city. The lines were witty and Mr. H. L. Holgate in writing them displayed much cleverness as well as originality. Miss Hamilton gives a piquancy and peculiar charm to her recitations and is deservedly popular with Corvallis audiences.

Hon. W. E. Yates made some very forcible and enthusiastic remarks. He aroused the enthusiasm of the students and interest of the citizens. He foretold the wonderful reception the boys would receive if they won the pennant.

Miss Mabel Johnson sang "In Tears I Pine for Thee." She possesses a rich, full voice of remarkable power and sings with taste and expression. Messrs. Eberhart and Johnson pleased the ears of the audience with a guitar duet and were recalled.

The various selections of the Bach Quartet were rendered with spirit and good expression. The quartet have attained a great popularity and their music is in demand. Mr. Ralph Terrell proved his efficiency as an accompanist. The proceeds of the concert were turned over to Manager Dentler and aided the fund considerably.

MORE O. P. LITIGATION.

R. H. Graham and other labor creditors under the Oregon Pacific receivership have appealed to the supreme court, and ask judgment against the plaintiff in the original suit, the Farmers Loan & Trust Co., for the amount of their several claims. The appellants are represented by Geo. G. Bigham, of Salem, and the Trust Co., by J. R. Bryson, of this city. The appellants contend that the receiver is an officer of the court, and that the expenses of the receivership as between the parties are disbursements and these payments are to be provided for in the same manner as other disbursements. That the receiver having been appointed upon the petition of respondent to preserve the property for the benefit of respondent it is liable for the payment of the expenses of the receivership, and that the court has authority to render judgment against respondent for the payment of the receiver's expenses as asked in petitioners' petition.

This case, it is said, is without precedent, for the reason that in the history of such litigation there has always been sufficient funds arising from the sale of the property involved to pay the legitimate court expenses. In this case, however, the court has incurred over a million and a quarter of indebtedness, and has but \$100,000 with which to settle the same. Perhaps under the circumstances the court is not censurable, for like everyone else connected with the suit, he has labored under a misapprehension of the value of the property involved. With an investment of \$15,000,000, it was hardly fair to presume that at the lowest figure the road would sell for less than 10 per cent of its cost, which amount would have been sufficient to more than pay all the court expenses.

The appellants, realizing that at best they will receive but a few cents on the dollar for their earnings from the purchase money, do not propose to die without a struggle. There seems to be no dispute as to the amount of the claims, so that the only difficulty to be encountered will be to fasten the responsibility of the payment of their claims upon the respondent, the Farmers Loan & Trust Co. This the appellants believe they will have no trouble in doing. Among the Corvallis attorneys there is a diversity of opinion regarding the matter; some claiming there is absolutely nothing in the case. Others take the ground that respondent wanted the property cared for, for its ultimate benefit. It asked the court to take charge of and manage the property for its use. It encouraged the court in incurring the present obligations, and now leaves the matter for the court to worry with. The following from the appellants' brief seems to be strongly in their favor: "Trustees under railroad mortgages have an inherent and equitable right to be reimbursed all expenses reasonably incurred in the execution of the trust and for such expense they have a lien upon the trust property. This right goes even further than this, for if the trust property prove insufficient to reimburse the trustees for their proper expenses and reasonable compensations, they may call upon the bond holders in whose behalf the trust was created, to pay them."

The Initial Game.

The first football game in the intercollegiate series will be played in Corvallis next Saturday, when the Pacific University team will strive against the Oregon Agricultural College eleven. The farmers have been playing hard practice games this week and are rapidly developing efficient team work. The loser of Saturday's game will be entirely out of the contest for the championship and the boys realize this. The Pacific's no doubt also are aware of the fact and a "red hot" game can be expected. There is no reason to believe that the Forest Grove boys have any advantage over our team. Individually the home team is the stronger, and it has better coaching. The practice game with Eugene is no criterion of the work the farmers will do next Saturday. Then they were raw and untrained, and practically did nothing but look at the Eugene boys sprint from center to goal. The layedays are playing ball now although there is room for improvement. The line is very strong. Their weakness is behind the line and they are improving fast there. The new full-back, Owens, does excellent work, is very quick, pounds the line hard, and can wiggle through a pin hole. Wil Abernethy is practicing this week and if he plays half-back will greatly strengthen the team. Walters, the new tackle, is strong and active, while Miles Phillips as usual can be relied upon to do the work of two men. Some of the men are woefully lacking in snap. They are too slow in starting. Terrell is playing better ball than he ever did, but needs some reducing.

Everybody should turn out and give the boys the encouragement of their presence. The prospects for a big crowd are very flattering. All the business houses have decided to close during the progress of the game, and a great many people are coming over from Albany. Lieut. Dentler is building a grand stand for the accommodation of those who desire to sit down and watch the game. For real genuine sport, excitement, interest and close genuine football Saturday's game will probably eclipse any ever played in Corvallis.

Guesses on the results of the game are largely in order. They vary greatly but most of the guessers patriotically favor the home team. The following are some of the predictions on record in this office: 10 to 6; 12 to 6; 16 to 10; 12 to 0, in favor of the home team, and 16 to 12; 20 to 12, and 40 to 6 in favor of the Pacific University.
