**CARRIAGE WORKS.**—A correspondent of the Register writes from the following:

I was met by an old time friend—W. W. Egan, and after the usual salutations, an invitation to his wagon factory was accepted, and I was surprised, and pleased, to find such an extensive business being carried on in so small a town. He showed us some work that would cope with any in San Francisco both for durability and artistic execution. His factory comprises four departments—viz, blacksmith shop, paint shop, wood shop, and finishing or tinning room. He has now in process of completion twenty-three vehicles, all manufactured of the best hickory wood. Mr. Egan informs me that he receives orders from all parts of the State and Washington Territory. Whenever his work is examined, orders are the inevitable result; and so his business is rapidly becoming extensive. He showed us a valuable invention—the result of his own genius—what he called a "short turn around." It does away with the kingbolt, which tends to weaken the axle, thus forming a lighter and more convenient vehicle. He has also invented a means for putting on and removing the carriage top without a monkey-wrench, being but a moment's work. This gentleman certainly deserves great credit for his industry and genius in thus building up in our midst this important industry.
