Just As We Predicted Last Week.

We find in the *Daily Oregonian*, of February 26th, an article headed "The Exculpation of Mr. Tilden," and comments at considerable length in regard to the strange fidelity of the friends of Mr. Tilden, that they threw themselves on the sacrificial altar to save their chief. That paper says, "It is rare indeed to find a man who can acquire such ascendancy over associates that they will throw away their reputations to afford him a chance for escape, but this is what the strange old bachelor at Grammercy Park has done, and so firmly does he rely on the fidelity of his followers that he disclaims all knowledge of the work in which they are forced to admit they were engaged in his behalf, and backs his disclaimers with almost all the holy vows of Heaven," and that paper again says, "Comparisons of Mr. Tilden's own testimony with that of some of his devoted 'coparceners' will afford suggestive results." The testimony of Tilden himself amounts to this: that he did not know that corrupt negotiations for electoral votes were going on. We hope the *Oregonian* will not misconstrue the testimony of Tilden as given by it a few days ago, which made him say that he had saw no dispatches, had not received any either in cipher or translation, knew no cipher, had no key, etc. The question before the committee, was there any foul propositions made to you in regard to obtaining electoral votes. Mr. Tilden did not pretend to say that he had not heard anything in regard to the Presidential contest, in the ordinary way of obtaining news; but that was not the question before the committee. The *Oregonian* of the 26th, makes him say that he disclaims all knowledge of the work in which they were forced to admit they were engaged in his behalf," in giving the testimony the other day, Mr. Tilden was made to say the only knowledge he had of any foul proposition being made was the information obtained from Mr. Cooper, and he ordered it stepped at once. Thus you see that by the above quotation that there is an effort made to mislead the public in regard to this matter. It is just as we said last week when we said, "Then all things should be set at rest so far as Mr. Tilden is concerned, unless his enemies are so persistent and bitter against him that they will attempt to convince the American people that he has committed perjury, and it would seem that this would be the next effort," and sure enough, quoting from the same paper it says, after giving a brief account of the testimony of Cooper, Weed, Pelton and Marble that, "Shall we credit Mr. Tilden, or his friends. There is deception here somewhere, and it would appear that Mr. Tilden's associates in protesting so stoutly that he didn't approve the proceedings but was incensed when he heard of them were too anxious to clear him," Mr. Tilden testified that no telegrams came to his house, but the *Oregonian* says, "telegrams continued to come to his house." Who shall we believe. This great man and statesman on his oath, or the editor of the *Oregonian*. We are ready to admit that Mr. Scott cannot see by what means of reasoning Mr. Tilden kept himself entirely clear of any improprieties in that matter; we believe it is easy to account for. We suppose men are more or less alike on the Atlantic and Pacific Coasts. A man can always find men that like to do dirty work, and it is not necessary for him to dirty his hands with it. Mr. Scott should know from experience, for it has been said that certain parties had a pretty hard scuffle to keep from being indicted in the United States Court, all for the small accomplishment of the election of Hiram Smith over Nesmith, but they and some of their "coparceners" done some tall wiggling till they succeeded in getting the official head off of Gov. Gibbs, and when they succeeded in bursting his cinch, they then went Scott free. This should be a sufficient explanation to satisfy any Republican editor in Portland. We suppose the people have not forgotten these little pictures of Grant that was sold for \$2.50 apiece and other things that might be referred to that would show how it was done.

A Wrongful Veto.

In the veto message, says the Telegram, we have perhaps the best way of saying things which should not be said at all. The President is one of those, who, when they grow fond of an opinion, call it honor, honesty and faith. If nothing else could give Eastern people a conception of this Chinese question we could wish they had among them as large a proportional Chinese population as we have—say eight or ten millions—and then they see the point. It puts one out of all patience to see this subject discussed on water-gruel humanitarian principles. The presence of Chinese here is a great evil to be vigorously dealt with. The president's oily words about civilization and religion are, under the circumstances, contemptible, and the bare technicality on which the bill is vetoed, namely, that congress, while it may set aside a whole treaty, cannot modify it, will not win more respect. One thing may be set down as certain. These Pacific states will vote for no man for president in 1880 who is not firmly committed to the right on this question. As for Hayes, he stands aloof from the masses of the people, wrapped up in himself and in his inherited fortunes, and he has no conception whatever of the struggles of the people, their wants or situations. The circles in which he moves are the scented and kid-gloved orders of society who know nothing and care nothing about men's natural wants, but give themselves up to ranting about the need of "missionary effort among the heathen," totally oblivious of distress at home. The people would like to have a president who has some knowledge of them and sympathy with their important interests. They do not consider their government a missionary enterprise for the regeneration of China, but an institution contrived to meet their own human wants,—but to see that they have the best possible protection both against domestic injustice and violence and the competition of foreign degraded labor. But the present occupant of the White House surrounds himself with an atmosphere of musk and insolence, and refuses to permit the "common people" to come betwixt the wind and his nobility. They are no better than Chinese serfs, and perhaps not so good, since persons like his excellency never stop to inquire even whether they have souls to be saved,—a solicitude they deeply feel in the case of the Chinese. People of the Pacific coast, who know what the Chinese are, are tired of this stuff and bosh. To them life has a meaning which is not expressed by cant and sentimentalism.

The name of the next Democratic nominee for President may as well be mentioned now as any time. It is Samuel J. Tilden, of New York.

HAM LIN Senator from Maine, wants the Chinese naturalized. There is an affinity in name as well as in spirit.

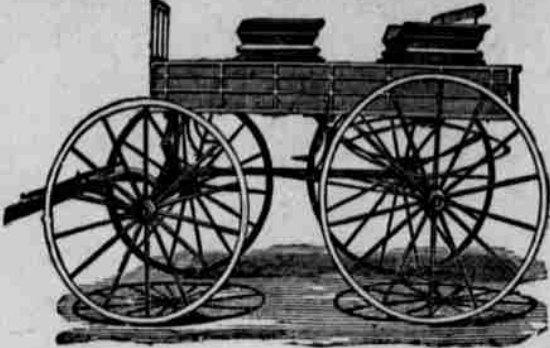
