

Democratic State Convention.

A Democratic State Convention is hereby called to meet at Albany, on Wednesday, April 7, at 1 o'clock P. M. for the purpose of nominating a candidate for Governor, three candidates for Supreme Judges, judges to each of the several judicial districts and Executive Attorneys, and the election of six delegates to attend the National Democratic Convention, and to transact such other business as may properly come before the Convention. The Convention will consist of 100 delegates, apportioned among the various counties as follows:
