sory education bill has a compulsory education out has ires all children between the ages of eight and fourteen years to attend a public school for twelve weeks, six of which shall be consecutive, in each school year. Text books are to be furnished free to the poor, and the School Trustees who do not prosecute parents and guardians for disobedience of the law are made liable to pay the fine imposed by the law. This responsibility of Trustees clause is an improvement on the compulsory educational laws now on the statute books of a few States, and will very likely make the Illinois law a live one.

The stone for filling the cribs to le hereafter built for Coos bay harbor work will be quarried at Barker's place at Rocky point. It is thought that by so doing the expense of sinking the cribs would be considerably less than would be the case in taking the rock from Coos river as was done last summer.




