AN HONORED CAREER.  
JOHN J. KNOX, EX-COMPTROLLER OF THE TREASURY.

Mr John J. Knox, of New York, for seventeen years Comptroller of the Treasury of the United States, has, after an honored and successful career in the public service, resigned his position to engage in private business. In view of service we present our readers with an Mr. Knox's long and conspicuous public excellent likeness of the gentleman who has so long presided over our national banking system.  
Comptroller Knox was appointed Deputy Comptroller October 10, 1867, and Comptroller on April 12, 1872, and thus has had a continuous service of seventeen years in the office. Previous to his appointment as Deputy Comptroller he had charge of the mint and coinage correspondence, and was sent by Secretary McCulloch to San Francisco in 1866 to examine the branch Mint in that city. His report was published with a complimentary notice by Secretary McCulloch in the finance report of that year. April 25th, 1870, he completed a revision of the Mint and Coinage laws of the United States, which was transmitted to Congress with an elaborate report. Upon his recommendation the coinage of the silver dollar was discontinued, and subsequently the bill which he proposed was passed by Congress with a few amendments, and is now known as the "Coinage Act of 1873."  
The Comptroller subsequently visited New Orleans and discovered in the office of the Assistant Treasurer the largest defalcation ever known in the history of the government. The failure of the First National Bank of New Orleans followed, and Mr. Knox remained for some weeks in that city acting as Assistant Treasurer. He was re-appointed Comptroller without his knowledge previous to the expiration of his first term, and confirmed by the Senate without reference to any committee. He was again appointed to a third term on April 12, 1882.

### The Irresistible Force Of Habit.

It was a Jefferson avenue car. A young gentleman rose and gave up his seat to a lady, and his chum who occupied the next seat, tendered him a position on his knee, which he accepted. ### The Duty of the Hour.

In three weeks fifty thousand voters will be called upon to choose between candidates for Congress, Supreme Judge and other minor offices. For what purpose do we want a representative in Congress? Manifestly to look generally after the interests of Oregon in that branch of the general government. Hence it is the part of good sense and good judgment on the part of voters to elect the man under the circumstances can do most good. As between Hon. John Myers and Birger Herman on the score of legislative experience, the advantage is all in favor of Mr. Myers, he having served two or three terms as State Senator from Clackamas county, while Mr. Herman has only served part of one term. In practical ability and good sound sense Mr. Myers is the superior of Mr. Herman. How well and faithful Mr. Myers will serve the people of Oregon in Congress may be seen when we state that at each election when he was elected Senator from Clackamas county he had a large Republican majority to overcome. But such was the abiding faith of the people of that county in his ability and integrity that without regard to party they stood by him at the polls. Probably the strongest reason why John Myers should be elected is the fact that Congress is now strongly Democratic and will remain so for many years to come. If we send Herman to Congress he will be in the minority, and hence will not be able to do anything for us. Every one sees that George is not doing anything for Oregon, and it is owing largely to the fact that he is not in harmony with the majority in Congress. Then let the people without regard to party elect Honest John Myers.—Albany Democrat.

### Libel Suit.

Our Democratic contemporary appears to have got itself into hot water by the way it referred to the fire that recently occurred at 125 Front street. The managers in this city for Feldman & Co. of San Francisco, the broom and wooden ware men, imagine they detected an insinuation in the Standard's account of the fire that they were incendiaries, and in consequence thereof, have begun suit for defamation of character, laying their damage at the snug little sum of \$25,000. There are one or two satisfactory points to the defendant in this suit which it may not be amiss to mention: It will be a big advertisement for his paper, and even if he loses his case in the court he can "beat the plaintiffs on the execution." Mr. Cole, one of Feldman's managers here, says that besides using the Standard in a civil suit for damages, a criminal charge will be preferred against J. B.
