BOUQUET OF GRAIN.—We clip the following from last Wednesday's Portland Daily Telegram: By express to-day Secretary Carlisle, of the State Board of Immigration, secured the first installment of Oregon products for the car which will soon be sent east. This consists of a "bouquet" of grain, composed of nineteen varieties of wheat, one variety of oats and one of rye. This bunch is a perfect beauty, some of the heads being from eight to ten inches long and filled with large, plump, golden grains. It will make some of the old farmers, both in the east and west, stare with astonishment and admiration. The grain was grown on the farm of George Belshaw, in Lane county. From Lane county two splendid specimens of clover were also received to-day. One is a sample of red clover (second crop this season) which was cut on the 27th of June.
