The Era of Republican Plunder.

The new Democratic campaign hand-book will prove a most disagreeable surprise to those Republican organs which have made merry at times over the words of the late Vice-President Hendricks: "We need to have the books in the government offices opened for examination." The books were opened, and the Republicans boasted that nothing was discovered to show the existence of fraud or grounds for suspicion. The wide discrepancies in the accounts of the treasury under Republican administration, and the 2,527 erasures in the ledgers of the offices of the register and secretary, have already been fully exposed and commented upon, and the Republicans flattered themselves with the notion that the worst was known. From the figures and incontestable proofs presented by the Democratic campaign hand-book, it appears that "the Republican party, in its long lease of power, has, through its various officers, by defalcation in collections and disbursements," stolen over \$20,000,000 of the people's money.

A partial peep into the books reveal this astonishing evidence of Republican plunder, and when the full exposure of all the delinquencies and defalcations of Republican office holders is made, the people can judge of what Republican government really means. The work of investigation is necessarily slow, as it takes considerable time to get up the accounts of the disbursing and receiving officers. The tables of defalcations presented by the Democratic campaign hand-book do not include shortages in the sixth auditor's department, which has charge of the expenditures of the postoffice department, in which Dorsey, Brady and the Star Route thieves figure. They do not include the shortages in the third and fourth auditor's offices, which deal with the expenditures of the war and navy departments, and do not, therefore, comprise the frauds of Howgate, Hodges and the Robeson and Chandler gang. No evasion, subterfuge or hypocrisy can avail the Republican party against this terrible array of figures. It stands before the people, convicted of wholesale plunder. Truly the opening of the books has proved more than was even anticipated.

General Brady's Book.

One of those government robbers of Star route notoriety is writing a book, and that man is General Brady. If he tells all he knows about some men and things, rich and interesting disclosures will be made. The dispatches say that the General proposes to place several alleged statesmen in public pillory, and will give the inside history of the Florida election, the returns of 1876 and the Star route trials and investigations; and that he will embellish the book with *fac simile* autograph letters and memoranda which will speak for themselves. Brady evidently wants to get even with somebody.

It is significant that the most largely circulated paper in Pennsylvania, the Philadelphia Record, is a very earnest opponent of the high protective tariff. The Record's circulation grows, too, having increased within a few months from 105,000 daily to 113,500. The politicians would seem to have something to learn from the popularity of anti-high tariff papers the country over. The fact that a good many prominent Knights of Labor are asking the workmen to tell, if they can, what good the high tariff has done them, should also give the politicians a "pointer." Do they imagine the Knights are under the influence of British gold?

Jos Purdon, whose change from the Gervais depot agency to Roseburg we recently noted, has gone back again, having concluded that he preferred the former to the latter place, and James Martin, who had taken his place at Gervais, has gone to Oakland to relieve Mr. Houston, who takes charge of the Junction City office and depot.

Suppose they did change Sedgwick's drinks and fuddle him. Ben Franklin got full while he was an envoy to France, and kissed the Queen's lip instead of her finger tip.

Lake of the Woods and Mount Pitt.

The southernmost of Oregon's snow peaks is Mount Pitt, the crowning feature of the Cascade range near its terminus at the Klamath lakes. It was christened in honor of England's great statesman of that name, and by its title serves, in common with many other localities and objects as a perpetual reminder of the early exploration and occupation of the Upper Pacific coast by the enterprising subjects of Great Britain. It is often, though less commonly, called Mount "McLoughlin" in honor of the sturdy Scotch doctor who managed the affairs of the Hudson Bay Company in this region for so many years, and who is such a prominent and honorable character in the early annals of Oregon. The latter name is more appropriate, and should supersede the former. The mountain as seen from the shore of the Lake of the Woods, one of those crystal gems so numerous in the Cascades, the mountain's snowy sides sharply reflected by the mirrored surface of the water. The lake lies at a distance from civilization, but he who seeks it will find beautiful scenery, refreshing mountain air and water, game in abundance, and full of sport with the beautiful trout with which it abounds.

The Albany Herald of the 18th says: Track laying on the Oregon Pacific, between Corvallis and the Willamette river at this city, is now practically completed, and the trains will be running to the Albany bridge in a very short time. A large number of Chinese laborers were taken from this city yesterday to lay side tracks and switches on the main line just completed. Work will be commenced this morning on laying a switch to the gravel bar above this city, to procure the gravel for ballasting the road. This work will occupy about a week. A switch is also to be built to a warehouse between Albany and Corvallis, in the near future. The piers of the bridge are nearly completed, and the bridge timbers are at the depot at Corvallis, and will be brought down the river at once to be placed in position. It is expected to have the bridge ready to admit the passage of trains by Oct. 15th. When the track is completed for the Oregon Pacific trains to cross the bridge over the Willamette into Albany, which will now be within a few weeks, the event should by all means be celebrated by driving a golden spike, with appropriate ceremonies. This would show enterprise, advertise both the road and this city, and would altogether be the proper thing to do.

The policy of attacks on the Administration of President Cleveland is interesting when considered in its regular, rhythmic and periodical aspect. Secretary Lamar was at first selected. Vituperation and vilification wore their fangs down to the gum and then numbed at him. The Pension Bureau, being in his Department, was held up in the most iniquitous lights, but as the country was led to investigate Gen. Black's methods in that Bureau, they were indorsed and peace fell upon the Interior Department. Next the Navy Department was accused of giving John Roach indigestion and softening of the brain, and a pitying Heaven was called to look at him, stretched on a bed of pain. But when Heaven did look, John Roach was found stretched in a hammock, and mighty able to do his part at a clam bake or a bull-head breakfast. Now the State Department is in focus, and if the papers are to be believed it is doing the American birth-right up in bunches and selling it at auction to Mexico, Canada and any outside bidder who will put up a cent or invest a wink on the auctioneer. After the shower of rot passes by, the people will see that this whole administration is protecting American honor abroad and promoting clean politics at home, and the critics will find that defamations of their own country is not endorsed by American citizens.
