A decision has been rendered by Acting Land Commissioner Stockslager wherein it is held that the occupation of land by an Indian, Telaiming it as a homestead) in Weshington Territory prior to the filling of the map by the railroad company, was such a claim as excepted it from the fallroad grant. This decision virtually decides a large number of sim ilar cases in Oregon.
