Hop Statistics.

We have before us a circular from Lilien thal & Co., of San Francisco, giving rec-ords of the hop production of the Pacific Coast for 1887 and 1888. In 1887 Califor-Coast for 1887 and 1888. In 1884 Califor-nia had an acreage of 5,171 acres, and pro-34,753 bales, an average of 1240 pounds to the acre. Oregon 2291 acres, 11493 bales, 960 pounds to the acre. Washington Terri-tory 3,367 acres, 30,186 bales, 1100 pounds to the acre. A total of 66,896 bales. In 1888 California had 4573 acres, produced 4005 bales, 1400 pounds

1385 California had 4073 acres, produced 4,605 bales, yield per acre 1400 pounds. Oregon 2,634 acres, 14,639 bales, yield per acre, 1330 pounds. Washington Territory 3,755 acres, 41,161 bales, average, 2,030 pounds. Total, 90,485 bales. In Oregon, Lane county stands first hav-ing in 1868, 625 acres which produced 4,542 bales, n arly one-third of the entire yield of the state averaging 1,350 pounds to the acre. Marion county stands second with 532 acres, and 2,967 bales, an average of 1,130 pounds to the acre. Polk county third with 284 acres, 2,953 bales, an average of 1920 pounds. Linn county fourth with 253 acres, 1620 bales an average of 1190 pounds.






