Council Proceedings.

COUNCIL CHAMBER, March 18, 89. Council met pursuant to adjournment, 8th inst. Present—Mayor Hovey, Councilmen Matlock, Paine, Campbell, Roney and McClung. The reading of the minutes of last meeting was dispensed with. The Mayor announced the following standing committees: Finance—Paine, Matlock and Dorris. Judiciary—Dorris, McClung and Campbell. Health—Campbell, Paine and Matlock. The following appointments were submitted to the Council for confirmation: For Marshal, H. J. Day; Street Commissioner, J. T. Martin; Nightwatchman, J. T. Wittler. The appointments were confirmed. Mr. McClung moved that another night watchman be appointed. Mr. Roney moved to amend by referring the appointment to the Finance committee. Carried.

On motion of Mr. McClung the Judiciary committee was instructed to draft an ordinance providing for the appointment of Marshall, Street Commissioner and Nightwatchman, and fixing their compensation. Councilman elect G. B. Dorris presented his certificate of election, took the oath of office and entered upon the discharge of his duties. A petition from R. S. Bean, J. M. Holcomb, et al. for two hydrants at the corner of 6th and Olive streets, and 6th and Lincoln streets, was read and referred to the committee on Fire and Water.

A petition from F. P. Clow, Wm. Smith, et al. for a six foot sidewalk on the east of Hyland street from 11th to 14th street, was read and referred to the committee on Streets. Recorder instructed to assess the city. The correspondence between the retiring committee on Fire and Water and the Cal. Fire Apparatus Mfg. Co. in relation to the purchase of hose and bell, was taken from the table and referred to the committee on Fire and Water.

On motion of Mr. McClung the Judiciary committee was instructed to draft an ordinance providing for the division of the city into wards. On motion adjourned.
