A NARROW ESCAPE.

Harry Ferrin Falls Forty Feet from a Residence in Albany.

[Albany Herald, July 7th.]
About 10 o'clock last evening Harry Ferrin, a bricklayer from Eugene, while working on a chimney on the roof of the residence of C. E. Wolverson on Lyon street, the scaffold gave way and he fell a distance of nearly forty feet. He struck first on the balustrade of the porch and then fell upon the steps below.
He was picked up and carried into the house and medical aid summoned. Dr. H. M. Ellis being called. It was found that one rib was broken and severe bruises inflicted, but considering the frightful fall his escape was remarkable, as his injuries will not prove fatal.
He was taken to his room at the City Restaurant building house in Twelfth street, where he was resting easy last night. He is a member of the I. O. O. F. fraternity and had just recovered from a severe attack of pneumonia.
Mr. Ferrin, we are pleased to state, is now able to be about, and his complete recovery is assured. It was certainly a narrow escape.

Military Wagon Road.
A petition to the county court has been in circulation this week, and numerous signed, asking and body to appropriate the sum of \$1000 for the improvement of the Oregon Military wagon road, which crosses the Cascade mountains. The road is dangerous and should be all means be put in a safe condition. The appropriation asked, we believe to be moderate, and we hope the county court will make said appropriation of money, to be expended under some reliable person who thoroughly understands the business of carrying troops. Of course the company that received the valuable land grant should keep the road in first-class repair, but it seems to be an impossibility to compel it to do so, hence the county should give the settlers in that section a passable road to travel. Besides, if the road is repaired it will draw an immense amount of travel to Lane county from Southern Oregon that, now goes to Northern California, and their trade would amount to a great sum annually to our people. And then, we are informed, that an immense amount of good government land is lying vacant along said road, which would be settled if the road was even in a safe condition to travel over.

A Shocking Tragedy.
On Saturday night at Palouse City, W. T., between 10 and 12 o'clock, Roland D. Johnson, a well-to-do and respectable citizen about 25 years of age, killed his wife and son, about 14 years old, and fatally shot his seven year old daughter. He then took his own life. He left a note stating that he did not want to live in this sinful world, and he thought he would kill them too. He said he had his family going to heaven, where Jesus was, and that he first gave them strychnine, but could not bear the sight of their agonies; so he killed them with a revolver. The bodies were all in the house and all upstairs. He never had any domestic troubles and his terrible crime is supposed to be due to religious fanaticism. On the front door he had pinned the following note: "Come in! Open! We are all dead upstairs!" He was one of the wealthiest farmers in the Palouse country.
Roland D. Johnson was for years a resident of Lane county where he had many friends. He was unquestionably crazy when he committed these deeds.

WOOL FROM EASTERN OREGON.—Mr. Roberts, of Silver Lake, Southeastern Oregon, arrived here this week via the McKenzie wagon road with 13,000 lbs of wool, and will dispose of the same to one of our merchants. In return he will load his wagon with 175 mules. The reason he came via the McKenzie road, which is considerably further than the military wagon, was because the latter is nearly impassable. He says a large number of persons would bring their wool here and buy supplies if the military road was repaired. The county court should immediately appropriate money for the repair of this important highway.

TWO THOUSAND BOXES.—This is the number of boxes of peach plants that Sladden & Son will have shipped to Mt. Paul by this Saturday evening, which will equal two car loads. They have had about twenty-five girls and boys employed during the week, besides a number of men, and several teams. The boxes were made by Dyerling's factory. This is the first shipment of fruit East from this point, and is only a beginning of what it will be next year when the young orchards will bear full crops. Each box has printed on it in large letters: "Oregon," "Peach Plants," "Sladden & Son, Eugene City, Oregon."

PROHIBITION LECTURE.—Dr. John A. Brooks, who ran for Vice President on the Prohibition ticket last year, lectured in the Court House last Wednesday afternoon and evening.
