SLUSLAW RAILWAY.—Representative Hermon has introduced a bill in Congress granting to the Sluslaw & Eastern Railway & Navigation company the right of way through the public lands of Oregon or in the territories of Utah and Idaho, on the line of said road between Sluslaw bay, in Oregon, and the city of Ogden, in Utah, and Boise City, in Idaho, all the right to take timber, stone and other material for road construction. Lands are also provided for switches and depot purposes. For a life-saving station and life-aver crew at the mouth of the Sluslaw river, in Lane county, Oregon.
