The Indians are Happy.

A House on West Seventh Street Was

Ransacked Last Night.

Last night between 7 and 8 o'clock, while the family were absent at church, the residence of Mrs. M. McCormick, on the corner of Seventh and Lincoln streets, was broken into. The persons entered by prying open a window on the porch fronting on Seventh street. The house was evidently missing all over, but the only article missing is a purse containing about \$6. Some of the tracks on the porch were of a narrow, pointed shoe, and evidently those of a girl or woman; while other tracks are there they are evidently larger but indistinct. As the family was nearing home on their return from church they noticed a man hurrying west on Seventh street, but though nothing of it until they reached home and found the window open. The presence of the woman's shoe prints is so far a complete mystery.

The Indians are all satisfied in bright sunlight over the fact that they have picked out the cream of the lands and are selling the mountains to the whites for cash. It is a fact, however, that when the unlanded lands are opened for settlement, four or five hundred families may find good homes in the Siletz. Twenty-two thousand dollars is the amount that will be paid out, all told, and the Indians will be rich, for a while, at least. Several thousand dollars in cash was shipped into Toledo, with which to cash the checks, for the process of which a small charge is exacted to pay the express charges.

O. R. & N. Eating-House.
