**Annual School Meeting.**  
The annual school meeting of district No. 4 took place at the courthouse last evening, about 20 voters being present. The reports of the board of directors and the clerk were read, and those submitted at the meeting on January 25, and published in the GUARD. The total receipts of the past year amounted to \$11,206.66; borrowed during the year, \$6700. The directors' report also says:  
"We are pleased to report to you that the past year has been a pleasant and successful one in both schools. Good order has been maintained, and fair advancement made in all the grades of the schools. The property of the district has been well cared for, and the schoolhouses are in reasonably good condition."  
No nominations were made for directors or for the board of school officers to be held next Monday afternoon.

**MR. BYRON HITS BACK.**-Vice President Jas. Byron, of Olala, of the soldiers' home board of directors gives the committee a live hit in the plain dealer. He says: In order to make a point against me, they decided, as the law requires, to serve legal notices on me stating time and place of investigation of my official acts. They preferred, guerrilla like, to shoot from ambush, or stab in the back, which they fully, faultily and completely did. During my two years on the board of trustees I have never traveled on a free pass and charged mileage to the state nor have I had the state of Oregon to buy my postage stamps or pocket knives, as the people who untruthfully investigated the soldiers' home have done. The animus originated in the fact that they were themselves candidates for the offices of commandant, secretary and trustees.

**SKIPPED FOR GOOD.**-Roseburg Review: W. E. Gibson, the Wilbur merchant who cut such a dash, has gone for good. It appears, leaving many creditors to mourn his departure. Mr. G. W. Grubbs has taken back the store, and is out about \$1200 worth of goods, and many farmers in the vicinity were victimized. Gibson paid high prices for produce, and owed a large amount for what he had bought. Will Emery, of Coles Valley, is reported to have lost about \$200 on a sale of horses. P. H. Burt, of Willbur, is out \$50. Gibson was a slick swindler.

**IMPORTANT PAPERS.**-Albany Democrat: Two big tin boxes passed through Albany from Corvallis to Salem Tuesday noon. They were labeled "Farmers' Loan & Trust Co., art. the O. P. R. R. One was marked "pledgments" and the other "evidence" and both were addressed to "J. J. Murphy clerk of the supreme court. They were the voluminous papers in the very important O. P. appeal case. It is the general sentiment that the case should be heard as soon as possible, so the public may know what they may depend upon in the matter.

**IN SERVICE.**-Salem Post: The Eagle, which has been the butt of many jokes and ridicule on the river, has gone into active service hauling potatoes from a point near Eugene, called Wick's Landing, to Corvallis, to be shipped by the O. P. Co. to San Francisco. A. J. Chubbill, formerly assistant on the Altona dock, who cast his lot with the fortunes and vicissitudes of this little craft, has stated that he was getting experience in large quantities that he will never forget.

**PLEASANT PARTY.**-Miss Edith Park entertained about 16 of her friends at her home on Eighth street Saturday evening. A waltz served as the principal game of the evening, after which a delicious lunch was served. Dancing was then indulged in for a while and it was a late hour when the guests left for their homes, after thanking their hostess warmly for the pleasant evening spent.

**A PARALYTIC STRIKE.**-This morning Earl Wilson suffered a paralytic stroke, affecting his right side and his speech. Dr. McKenney was summoned and attended the man, who is now getting along very nicely. He was at first unable to use his right limbs or talk, but has now gained some control of the affected members.

**Self-Explanatory.**  
The following letter has been received by President Wilkins, of the board of trade, regarding the limitation of the free transportation of goods for Nebraska sufferers, by the Southern Pacific and explains itself:  
PORTLAND, Ore., March 4th, 1895.  
MR. F. M. WILKINS, Eugene, Or.  
Dear Sir:-I have your favor of the 1st inst. in regard to a carload of provisions and clothing collected in your city for the Nebraska sufferers.  
I beg to advise you that this company did furnish free transportation for shipments of this character to Portland, but we were compelled to withhold the same some time since as the O. R. N. and Union Pacific refused to take the shipments to their destination, stating as their reason that heavy contributions had been made much nearer the point where the supplies were needed, and it was therefore useless to transport them such long distances. We are therefore not in a position to do anything for you on the shipment you mention, much to our regret.

**At her home in this city, this morning at 2 o'clock, Mrs. Andrew Hunt passed away. She had been ill for over a year with consumption. Last year she visited with relatives in the East in the hopes of the change of climate proving beneficial to her health. Mrs. Sarah Matilda Wooten-Hunt was born near Clowderdale October 30, 1834, and was therefore aged 40 years, 4 months and 3 days. She was married to Andrew Hunt on December 2, 1869, and has resided in Eugene since that time. She leaves a husband, a father at Clowderdale and a brother at Palouse, Wash., besides a host of friends to mourn her loss. The funeral will be held at the residence in this city tomorrow morning, the interment taking place at the Knox cemetery, near Crosswell.**

**A Pleasing Message.**  
In these times of financial stringency any accession to the public funds of the state will be pleasurably received. Saturday evening Governor Lord was the recipient of a telegraphic message from U. S. Senator Mitchell which is along that line and which it gave the governor great pleasure to transmit to the people. It read as follows:  
"WASHINGTON, D. C., Mar. 2, 1895.  
Hon. Wm. P. Lord, Salem, Or.: I have succeeded in securing the adoption of an amendment to the senate to the deficiency appropriation bill, appropriating the full amount of moneys due Oregon, California and Nevada for moneys expended in suppressing the rebellion. The total amount is \$4,000,000, of which \$35,152.88 are for Oregon. All depends now on the action of the house.

**Shortly after one o'clock this afternoon the grand jury returned "not a true bill" in each of the following cases:**

**WILL HOLD ON.**-Oregonian: It is not likely that Governor Lord will appoint a new board of railroad commissioners. Yesterday Attorney-General Idleman filed his opinion with the governor that such appointment was not a prerogative of the chief executive, as no vacancies exist in the board. It is supposed that the attorney general was requested to give an opinion, and finding that the members of the present board held over until their successors were duly elected and qualified, the matter will now be at rest. The only remedy now is to have an extra session of the legislature in order to elect a new lot of state officials, which will hardly be called.

**A QUEER CASE.**-Salem Post: "W. I. Henderson, guardian of Grace V. Henderson, a minor, has been cited to appear before the county judge on April 1 for final settlement of property. The young lady claims she has reached her majority, and is in a hurry to get a statement of guardianship. The father claims otherwise, and the mother of the young lady, who lives in San Francisco, will be left to decide whether or not the girl is of age." Henderson formerly lived in Eugene, and is well known here.

**COMPROMISED.**-The case of R. E. Campbell vs. A. D. Burton, from Springfield, over a division fence, has been settled. The costs in the case total half amounted to \$120.90, besides attorney fees. Each party now pays half the costs and their own attorney. They further stipulate that County Surveyor Pengra is to establish the line between them, and they will abide by the same. This is a sensible conclusion.

**SPRINGFIELD ELECTION.**-Our little neighbor town held her school election yesterday with the result that A. D. Burton was elected director and E. C. Martin re-elected clerk. The election proved to be as exciting as if they were balloting on congressman, or some other high functionary.

**SOLDIERS' HOME.**-It is understood that a new commander will be chosen for the Roseburg soldiers' home. D. W. Mathews, R. H. Ryan and Henry Rogers of Salem are candidates. Gen. W. H. Byars of Portland is also mentioned. Some prominent grand army men are satisfied to let Wallace Baldwin remain as commander.

**A NEW PROPOSITION.**-Some of our citizens have proposed the idea of forming a joint stock company and placing machinery in a portion of the canyon building for a flouring mill. Eugene by all means should have a first class flouring mill before the next harvest.

**THE ASSESSMENT OF 1895.**  
It Will Include a Complete Census Enumeration.  
The various county assessors in Oregon, in making the assessment for 1895, will also, as required by law, take an accurate census enumeration of the population and products of their respective counties. Burton will soon begin the work of assessing the county. In addition to the regular verified statement of assessable property, he is provided with blanks for obtaining the following facts and figures concerning every inhabitant:  
Names in full, sex, age, nativity, occupation, citizen or not.  
How many acres of land owned by each.  
How much of this is in crop or pasture.  
How many acres in orchards or other fruits.  
No. of horses, mules, cattle, hogs, sheep, or goats, poultry, turkeys, etc.  
Amount of farm products of last year, as hereinafter specified: Wheat, No. of bushels; oats, No. of bushels; potatoes, No. of bushels; hay, No. of tons; hops, No. of pounds; wool, No. of pounds; poultry, No. sold; apples, No. of bushels; pears, No. of bushels; grapes, No. of pounds; barley, No. of bushels; corn, No. of bushels; tomatoes, No. of bushels; nutter, No. of pounds; cheese, No. of pounds; bacon, No. of pounds; eggs sold, No. of dozen; peaches, No. of bushels; prunes or plums, No. of bushels; strawberries, No. of cases.  
Amount of lumber manufactured last year.  
Number of tons of flour manufactured last year.  
Number of ounces of gold dust produced last year.  
Number of barrels of salmon or cases of same.  
Any other products or manufactures.  
It is to be hoped the various assessors will do this work well, as the 1890 government census in 1890 was very defective and did not do the state justice.

**County Fair.**  
The subject of a county fair organization was talked of to a considerable extent a few weeks since, but nothing definite in the matter was done, and interest in the proposition has been allowed to lag. There is no need at this time to further speak on the benefits to derive from a properly conducted fair in this county, as it must be evident to all who are conversant with the subject that not only it would keep at home several thousand dollars annually, but bring in as many more from outside points, besides causing an earnest competition for the productions of fine grain and vegetables, and the raising of good stock.  
While the circuit court is in session and representative men are here from all parts of the county, a meeting should be called to talk over the matter. By this means it will be found whether or not the people of the county generally would favor the project, and we think they do. In the event of the people being favorable to the plan, a meeting could be called and the organization perfected, officers elected, dates arranged for a fair, etc. The interest in the matter should be kept up until this is done.  
**BOXES FILED.**-Corvallis Times: The O. P. appeal case is knocking at the door of the supreme court. The appellants in each of the three separate appeals from the confirmation decision have perfected the appeals by filing with the clerk acceptances and affidavits of service of notices of appeal, and the necessary bonds for costs. The amount of the latter is \$100, for \$1,000, and each signed by L. E. Blain and J. W. Lance of Albany as sureties. Will the O. P. cat come back to the Benton county circuit court?

**ADVANCEMENT CLUB.**-A good crowd was in attendance at last night's meeting. Dr. Paine read a paper "Methods of Reforming Criminals"; Mrs. Condon on "Ghosts"; and Rev. W. S. Gilbert on "Sacred Books." The papers were interesting and instructive and the usual lively and sharp discussion of the subjects took place afterwards, and some of the remarks afforded considerable amusement. The regular meeting will be held next Monday night.

**ARTICLES FILED.**-Articles of incorporation were filed with the secretary of state Tuesday for incorporation of the Corvallis Lumber Company. Place of business is at Corvallis, Or., and capital stock, \$16,000. The incorporators are Levi Oren, John Long and R. R. Deadmond. Deadmond and Long are well known in this county.

**A Pleasing Message.**  
In these times of financial stringency any accession to the public funds of the state will be pleasurably received. Saturday evening Governor Lord was the recipient of a telegraphic message from U. S. Senator Mitchell which is along that line and which it gave the governor great pleasure to transmit to the people. It read as follows:  
"WASHINGTON, D. C., Mar. 2, 1895.  
Hon. Wm. P. Lord, Salem, Or.: I have succeeded in securing the adoption of an amendment to the senate to the deficiency appropriation bill, appropriating the full amount of moneys due Oregon, California and Nevada for moneys expended in suppressing the rebellion. The total amount is \$4,000,000, of which \$35,152.88 are for Oregon. All depends now on the action of the house.  
JOHN H. MITCHELL."  
"AM True Bills."  
Shortly after one o'clock this afternoon the grand jury returned "not a true bill" in each of the following cases:  
State of Oregon vs Isaac Zumwalt; assault with intent to kill. From Junction.  
State of Oregon vs John Maxwell; attempting to commit a felony. From Irving.  
State of Oregon vs R. H. Mosby; grossly disturbing the public peace. From Cottage Grove.  
Each of the above parties were out on bonds.

**WILL HOLD ON.**-Oregonian: It is not likely that Governor Lord will appoint a new board of railroad commissioners. Yesterday Attorney-General Idleman filed his opinion with the governor that such appointment was not a prerogative of the chief executive, as no vacancies exist in the board. It is supposed that the attorney general was requested to give an opinion, and finding that the members of the present board held over until their successors were duly elected and qualified, the matter will now be at rest. The only remedy now is to have an extra session of the legislature in order to elect a new lot of state officials, which will hardly be called.

**A QUEER CASE.**-Salem Post: "W. I. Henderson, guardian of Grace V. Henderson, a minor, has been cited to appear before the county judge on April 1 for final settlement of property. The young lady claims she has reached her majority, and is in a hurry to get a statement of guardianship. The father claims otherwise, and the mother of the young lady, who lives in San Francisco, will be left to decide whether or not the girl is of age." Henderson formerly lived in Eugene, and is well known here.

**COMPROMISED.**-The case of R. E. Campbell vs. A. D. Burton, from Springfield, over a division fence, has been settled. The costs in the case total half amounted to \$120.90, besides attorney fees. Each party now pays half the costs and their own attorney. They further stipulate that County Surveyor Pengra is to establish the line between them, and they will abide by the same. This is a sensible conclusion.

**SPRINGFIELD ELECTION.**-Our little neighbor town held her school election yesterday with the result that A. D. Burton was elected director and E. C. Martin re-elected clerk. The election proved to be as exciting as if they were balloting on congressman, or some other high functionary.

**SOLDIERS' HOME.**-It is understood that a new commander will be chosen for the Roseburg soldiers' home. D. W. Mathews, R. H. Ryan and Henry Rogers of Salem are candidates. Gen. W. H. Byars of Portland is also mentioned. Some prominent grand army men are satisfied to let Wallace Baldwin remain as commander.

**A NEW PROPOSITION.**-Some of our citizens have proposed the idea of forming a joint stock company and placing machinery in a portion of the canyon building for a flouring mill. Eugene by all means should have a first class flouring mill before the next harvest.
